GLOBAL STABILIZATION OF LINEAR SYSTEMS WITH BOUNDS ON THE FEEDBACK AND ITS SUCCESSIVE DERIVATIVES*

Abstract. We address the global stabilization of linear time-invariant (LTI) systems when the magnitude of the control input and its successive time derivatives, up to an arbitrary order $p \in \mathbb{N}$, are bounded by prescribed values. We propose a static state feedback that solves this problem for any admissible LTI systems, namely for stabilizable systems whose internal dynamics has no eigenvalue with positive real part. This generalizes previous work done for single-input chains of integrators and rotating dynamics.

34 35 1. Introduction. The study of control systems subject to input constraints is motivated by the fact that signals delivered by physical actuators may be limited in amplitude, and may not evolve arbitrarily fast. An *a priori* bound on the amplitude of the control signal is usually referred to as *input saturation* whereas a bound on the variation of control signal is referred to as *rate saturation* (e.g [15]).

Stabilization of linear time-invariant systems (LTI for short) with input saturation has been widely studied in the literature. Such a system is given by

$$(S) \ \dot{x} = Ax + Bu,$$

where $x \in \mathbb{R}^n$, u belongs to a bounded subset of \mathbb{R}^m , A is an $n \times n$ matrix and B is an $n \times m$ one. Global stabilization of (S) can be achieved if and only if the LTI system is asymptotically null controllable with bounded controls, i.e., it can be stabilized in the absence of input constraint and the eigenvalues of A have non positive real parts. Saturating a linear feedback law may fail at globally stabilizing (S) as it was observed first in [4] and then in [18] for the special case of integrator chains (i.e., when A is the n-th Jordan block and $B = (0 \cdots 0 \ 1)^T$). As shown for instance in [12], optimal control can be used to define a globally stabilizing feedback for (S) but, when the dimension is greater than 3, deriving a closed form for this stabilizer becomes extremely difficult. The first globally stabilizing feedback with rather simple closed form (nested saturations) was provided in [20] for chains of integrators and then in [19] for the general case. In [9], a global feedback stabilizer for (S) was built by relying on control Lyapunov functions arising from a mere existence result. Other globally stabilizing feedback laws for (S) have been proposed with an additional property of robustness with respect to perturbations. In [14], using low-and-high gain techniques, a robust stabilizer was proposed to ensure semiglobal stability, meaning that the control gains can be tuned in such a way that the basin of attraction contains any prescribed compact subset of \mathbb{R}^n . This restriction has been removed in [13], where

the authors provided a global feedback stabilizer for (S) which is robust with respect to perturbations, based on an earlier idea due to Megretsky [11]. Nonetheless, the feedback laws of [13] and [11] require to solve a nonlinear optimization problem at every point $x \in \mathbb{R}^n$, which makes its practical implementation questionable. An easily implementable global feedback stabilizer for (S) which is robust with respect to perturbations was proposed in [2], but it only covers the multiple integrator case and it is discontinuous since it is based on sliding mode techniques. Robust stabilization of (S) was also addressed in [1] by relying on the control Lyapunov function techniques developed in [9]. Finally it is important to notice that, while global stabilizers own the advantage to be valid for all initial conditions, they are typically low performance and less suited for practical implementation because they do not allow the input to exceed the saturation limits, which often results in input signals that stay well below the maximum value.

In contrast to stabilization of LTI systems subject to input saturation, there are much less results available in the literature regarding global stabilization under rate saturation, i.e., when the first time derivative of the control signal is also a priori bounded. When only rate saturation is considered (with no constraint on the input magnitude), the objective can easily be reduced to the standard case of magnitude saturation by considering the augmented system where the control is an extra variable and its derivative becomes the new control. The control objective is more challenging when both magnitude and rate constraints are considered. In [3], the authors rely on a backstepping procedure to build a bounded globally stabilizing feedback with a bounded rate, but the methodology does not allow to a priori impose a prescribed rate. In [16], a dynamic feedback law inspired from [11] is constructed and can even be generalized to take into account constraints on higher time derivatives of the control signal. However, as mentioned previously, the numerical efficiency of such feedbacks is definitely questionable. A rather involved global feedback stabilizer for (S) achieving amplitude and rate saturations was also obtained in [17] for affine systems with a stable free dynamics. This corresponds in our setting to requiring that the matrix A is stable, i.e., $A^T + A \leq 0$ (up to similarity) and therefore fails at covering chains of integrators. Finally, let us mention the references [8], [10] for semiglobal stabilization results and [5] for local stabilization results using LMIs and anti-windup design. One should also mention [21] where a nonlinear small gain theorem is given for the behaviour analysis of control systems with saturation.

The results presented here encompass input and rate saturations as special cases. More precisely, given any integer p, we construct a globally stabilizing feedback for (S) such that the control signal and its p first time derivatives are bounded by arbitrary prescribed positive values, along all trajectories of the closed-loop system. This problem has already been solved by the authors in [7] for the multiple integrator and skew-symmetric cases. The solution given in that paper for the multiple integrator case consisted in considering appropriate nested saturation feedbacks. We also indicated in [7] that these feedbacks fail at ensuring global stability in the skew-symmetric case and we then provided an $ad\ hoc$ feedback law for this specific case. Here, we solve the general case with a unified strategy.

The paper should be seen as a first theoretical step towards the global stabilization of an LTI system when the input signal is delivered by a dynamical actuator that limits the control action in terms of magnitude and p first time derivatives. Further developments are needed to explicitly take into account the dynamics of such an actuator. Possible extensions of this work may also address the question of global stabilization by smooth feedback laws (i.e., C^{∞} with respect to time) when all successive

derivatives need to be bounded by prescribed values.

The paper is organized as follows. In Section 2, we precisely state the problem we want to tackle, the needed definitions as well as the main results we obtain, namely Theorem 1 for the single input case and Theorem 2 for the multiple input case. Section 3 contains the proof of the main results. In Section 3.1.1 we show that the proof of Theorem 1 is a consequence of two propositions. In the first one (Proposition 1), we show that the feedback proposed in Theorem 1 is indeed a globally stabilizing feedback for (S). We actually prove a stronger result dealing with robustness properties of this feedback, as it is required in [20] and [19]. The second proposition (Proposition 2) specifically deals with bounding the p first derivatives of the control signal by relying on delicate estimates. Section 3.2.1 contains the proof of Theorem 2 which is a consequence of Proposition 1 and Proposition 3, the latter providing estimates on the successive time derivatives of the control signal. In Section 4, we provide a numerical validation of our main result based on a four-dimensional system made of a cascade of two rotating dynamics. We close the paper by an Appendix, where we gather several technical results used throughout the paper.

Notations. We use \mathbb{R} and \mathbb{N} to denote the sets of real numbers and the set of non negative integers respectively. Given a set $I \subset \mathbb{R}$ and a constant $a \in \mathbb{R}$, we let $I_{\geq a} := \{x \in I : x \geq a\}$. Given $m, k \in \mathbb{N}$, we define $[\![m, k]\!] := \{l \in \mathbb{N} : l \in [m, k]\}$. For a given set M, the boundary of M is denoted by ∂M . The factorial of k is denoted by k! and the binomial coefficient is denoted $\binom{k}{m} := \frac{k!}{m!(k-m)!}$.

Given $k \in \mathbb{N}$ and $n, p \in \mathbb{N}_{\geq 1}$, we say that a function $f : \mathbb{R}^n \to \mathbb{R}^p$ is of class $C^k(\mathbb{R}^n, \mathbb{R}^p)$ if its differentials up to order k exist and are continuous, and we use $f^{(k)}$ to denote the k-th order differential of f. By convention, $f^{(0)} := f$.

Given $n, m \in \mathbb{N}_{\geq 1}$, $\mathbb{R}^{n,m}$ denotes the set of $n \times m$ matrices with real coefficients. The transpose of a matrix A is denoted by A^T . The identity matrix of dimension n is denoted by \mathbb{I}_n . We say that an eigenvalue of A is *critical* if it has zero real part and we set $\mu(A) := s(A) + z(A)$ where s(A) is the number of conjugate pairs of nonzero purely imaginary eigenvalues of A (counting multiplicity), and z(A) is the multiplicity

of the zero eigenvalue of
$$A$$
. We define $A_0 := \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}$, and $b_0 := \begin{pmatrix} 0 \\ 1 \end{pmatrix}$.

We use ||x|| to denote the Euclidean norm of an arbitrary vector $x \in \mathbb{R}^n$. Given $\delta > 0$ and $f : \mathbb{R}_{\geq 0} \to \mathbb{R}^n$, we say that f is eventually bounded by δ , and we write $||f(\cdot)|| \leq_{ev} \delta$, if there exists T > 0 such that $||f(t)|| \leq \delta$ for all $t \geq T$.

2. Problem statement and main results. Given $n \in \mathbb{N}_{\geq 1}$ and $m \in \mathbb{N}_{\geq 1}$, consider the LTI system defined by

$$\dot{x} = Ax + Bu,$$

where $x \in \mathbb{R}^n$, $u \in \mathbb{R}^m$, $A \in \mathbb{R}^{n,n}$, and $B \in \mathbb{R}^{n,m}$. Assume that the pair (A,B) is stabilizable and that all the eigenvalues of A have non positive real parts. Recall that these assumptions on (A,B) are necessary and sufficient for the existence of a bounded continuous state feedback u = k(x) which globally asymptotically stabilizes the origin of (1), see [19].

Given an integer p and a (p+1)-tuple of positive real numbers $(R_j)_{0 \le j \le p}$, we want to derive a static state feedback law whose magnitude and p-first time derivatives along all trajectories of the closed-loop system are bounded by R_j , $j \in [0, p]$.

DEFINITION 1 (feedback law p-bounded by $(R_j)_{0 \le j \le p}$). Given $n \in \mathbb{N}_{\ge 1}$, $m \in \mathbb{N}_{\ge 1}$ and $p \in \mathbb{N}$, let $(R_j)_{0 \le j \le p}$ be a (p+1)-tuple of positive real numbers. We say that $\nu : \mathbb{R}^n \to \mathbb{R}^m$ is a feedback law p-bounded by $(R_j)_{0 \le j \le p}$ for system (1) if it is of class

 $C^p(\mathbb{R}^n, \mathbb{R}^m)$ and, for every trajectory of the closed-loop system $\dot{x} = Ax + B\nu(x)$, the
134 control signal $U: \mathbb{R}_{\geq 0} \to \mathbb{R}^m$, $t \mapsto U(t) := \nu(x(t))$ satisfies $\sup_{t \geq 0} \|U^{(j)}(t)\| \leq R_j$ 135 for all $j \in [0, p]$ and all $t \geq 0$. The function $\nu: \mathbb{R}^n \to \mathbb{R}^m$ is said to be a feedback
136 law p-bounded for system (1), if there exists a (p+1)-tuple of positive real numbers
137 $(R_j)_{0 \leq j \leq p}$ such that $\nu(\cdot)$ is a feedback law p-bounded by $(R_j)_{0 \leq j \leq p}$ for system (1).

We stress that the above definition includes only *static* state feedback laws, meaning control laws that depend solely on the current state value. Based on this definition, we can write our stabilization problem of Bounded Higher Derivatives as follows.

PROBLEM (BHD). Given $p \in \mathbb{N}$ and a (p+1)-tuple of positive real numbers $(R_j)_{0 \leq j \leq p}$, design a state feedback law $\nu : \mathbb{R}^n \to \mathbb{R}^m$ such that the origin of the closed-loop system $\dot{x} = Ax + B\nu(x)$ is globally asymptotically stable (GAS for short) and the feedback ν is a feedback law p-bounded by $(R_j)_{0 \leq j \leq p}$ for system (1).

Our construction to solve Problem (BHD) will often use the property of Small Input Small State with linear gain ($SISS_L$ for short) developed in [19]. We recall below its definition

DEFINITION 2 (SISS_L, [19]). Given positive Δ , N, the control system $\dot{x} = f(x, u)$, with $x \in \mathbb{R}^n$ and $u \in \mathbb{R}^m$, is said to be $SISS_L(\Delta, N)$ if, for every $\delta \in (0, \Delta]$ and every bounded measurable signal $e : \mathbb{R}_{\geq 0} \to \mathbb{R}^m$ eventually bounded by δ , then any solution of $\dot{x} = f(x, e)$ is eventually bounded by $N\delta$. A control system $\dot{x} = f(x, u)$ is said to be $SISS_L$ if it is $SISS_L(\Delta, N)$ for some $\Delta, N > 0$. An input-free system $\dot{x} = f(x)$ is called $SISS_L$, if the control system $\dot{x} = f(x) + u$ is $SISS_L$.

REMARK 1. Note that if $\dot{x} = f(x)$ is $SISS_L$, then all its solutions converge to the origin. To see this, pick a sequence $(\delta_k)_{k \in \mathbb{N}}$ of positive numbers tending to zero so that $\delta_0 \leq \Delta$ and apply the $SISS_L$ property to every δ_k with the zero input. Note, however, that the $SISS_L$ property does not necessarily ensure GAS in the absence of input, as it does not imply stability of the origin.

When a state feedback law ensures both global asymptotic stability and $SISS_L$, we refer to is an $SISS_L$ -stabilizing feedback.

DEFINITION 3 (SISS_L-stabilizing feedback). Given a control system $\dot{x} = f(x, u)$ with $x \in \mathbb{R}^n$ and $u \in \mathbb{R}^m$, we say that a state feedback law $\nu : \mathbb{R}^n \to \mathbb{R}^m$ is stabilizing if the origin of the closed-loop system $\dot{x} = f(x, \nu(x))$ is globally asymptotically stable. If, in addition, this closed-loop system is SISS_L, then we say that ν is SISS_L-stabilizing.

As mentioned before the state feedback law given in [7], which solves Problem (BHD) for the special case of multiple integrators, simply made use of nested saturations with carefully chosen saturation functions. We recall next why this state feedback construction cannot work in general. For that purpose it is enough to consider the 2D simple oscillator case which is the control system given by $\dot{x} = \omega A_0 x + b_0 u$, with $x = (x_1, x_2)^T$, $u \in \mathbb{R}$ and $\omega > 0$. This system is one of the two basic systems to be stabilized by means of a bounded feedback, as explained in [19]. According to [7], one must then consider a stabilizing feedback law $u = -\sigma(k^T x)$, where $k = (k_1, k_2)^T$ is a fixed vector in \mathbb{R}^2 and $\sigma : \mathbb{R} \to \mathbb{R}$ is a saturation function, i.e., a bounded, continuously differentiable function satisfying $s\sigma(s) > 0$ for $s \neq 0$ and $\sigma^{(1)}(0) > 0$. Note that k is chosen so that the linearized system at (0,0) is Hurwitz. In particular this implies that $k_2 \neq 0$. Pick now the following sequence of initial conditions $(l, -k_1 l/k_2)_{l\geq 1}$. A straightforward computation yields that the first time derivative of the control along each trajectory satisfies $\dot{u}(0) = -\sigma^{(1)}(0)\omega l(k_1^2/k_2 + k_2)$, which grows unbounded as l tends to infinity. Therefore the feedback law proposed in [7] can not be a 1-bounded

180 feedback for this system.

In order to solve Problem (BHD) for the 2D oscillator, we showed in [7] that a feedback law of the type $u_{k,\alpha} := \frac{k^T x}{(1+||x||^2)^{\alpha}}$ with $k \in \mathbb{R}^2$ and $\alpha \geq 1/2$ does the job and it also solves Problem (BHD) in case the matrix A in (1) is stable. However, we are not able to show whether $u_{k,\alpha}$ stabilizes or not the system in the case where $A := \begin{pmatrix} A_0 & b_0^T b_0 \\ 0 & A_0 \end{pmatrix}$. It turns out that the previous issue is as difficult as asking if a saturated linear feedback stabilizes or not the above-mentioned 4D case, which is an open problem. It is therefore not immediate how to address the general case. This is why our main result is a non trivial extension of the solution of Problem (BHD) provided for the two-dimensional oscillator.

2.1. Single input case. For the case of single input systems, the solution of Problem (PHB) is given by the following statement.

THEOREM 1 (Single input). Given $n \in \mathbb{N}_{>0}$, consider a single input system $\dot{x} = Ax + bu$ where $x \in \mathbb{R}^n$, $A \in \mathbb{R}^{n,n}$ and $b \in \mathbb{R}^{n,1}$. Assume that A has no eigenvalue with positive real part and that the pair (A,b) is stabilizable. Then, given any $p \in \mathbb{N}$ and any (p+1)-tuple $(R_j)_{0 \le j \le p}$ of positive real numbers, there exist vectors $k_i \in \mathbb{R}^n$ and matrices $T_i \in \mathbb{R}^{n,n}$, $i \in [1, \mu(A)]$, such that the feedback law $\nu : \mathbb{R}^n \to \mathbb{R}$ defined as

198 (2)
$$\nu(x) = -\sum_{i=1}^{\mu(A)} \frac{k_i^T x}{(1 + \|T_i x\|^2)^{1/2}},$$

199 is a feedback law p-bounded by $(R_j)_{0 \le j \le p}$ and $SISS_L$ -stabilizing for system $\dot{x} = Ax + bu$.

In view of Definition 3, the feedback law (2) globally asymptotically stabilizes the origin of (1), and thus solves Problem (BHD). We stress that, even though the exact computation of the control gains k_i is quite involved (see proof in Section 3), the structure of the proposed feedback law (2) is rather simple. It should also be noted that, unlike the results developed in [7], this state feedback law applies to any admissible single-input systems (including rotating dynamics and integrator chains) in a unified manner.

2.2. Multiple input case. To give the main result for LTI system with multiple inputs we need this following definition.

Definition 1 (Reduced controllability form). Given $n \in \mathbb{N}$ and $q \in \mathbb{N}$, a LTI system is said to be in reduced controllability form if it reads

$$\dot{x}_0 = A_{00}x_0 + A_{01}x_1 + A_{02}x_2 + \ldots + A_{0q}x_q + b_{01}u_1 + b_{02}u_2 + \ldots + b_{0q}u_q,$$

$$\dot{x}_1 = A_{11}x_1 + A_{12}x_2 + \ldots + A_{1q}x_q + b_{11}u_1 + b_{22}u_2 + \ldots + b_{1q}u_q,$$

$$\dot{x}_2 = A_{22}x_2 + \ldots + A_{2q}x_q + b_{22}u_2 + \ldots + b_{2q}u_q,$$

$$\vdots$$

$$\dot{x}_q = A_{qq}x_q + b_{qq}u_q,$$

where, for some (q+1)-tuple $(n_i)_{0 \le i \le q+1}$ in $\mathbb{N} \times (\mathbb{N}_{>0})^q$ with $\sum_{i=0}^q n_i = n$, $A_{00} \in \mathbb{R}^{n_0,n_0}$ is Hurwitz, for every $i \in [1,q]$ all the eigenvalues of $A_{ii} \in \mathbb{R}^{n_i,n_i}$ are critical, $b_{ii} \in \mathbb{R}^{n_i,1}$ and the pairs (A_{ii},b_{ii}) are controllable.

From Lemma 5.1 in [19], we can consider that system (1) is already given in the reduced controllability form without loss of generality. We can now establish the solution of Problem (BHD) for the multiple input case.

THEOREM 2 (Multiple input). Let $p \in \mathbb{N}$ and consider any (p+1)-tuple $(R_j)_{0 \leq j \leq p}$ of positive real numbers. Given $n \in \mathbb{N}$ and $q \in \mathbb{N}$, consider system (3). Then, there exist $\kappa_1, \ldots, \kappa_q$ such that:

- i) for every $i \in [1, q]$, $\kappa_i : \mathbb{R}^{n_i} \to \mathbb{R}$ is a feedback law p-bounded and $SISS_L$ stabilizing for $\dot{x}_i = A_{ii}x_i + b_{ii}u_i$;
- ii) the state feedback law $\mu = [\mu_1, \dots, \mu_q]^T$ given by

$$(4) \quad \mu_i(x_i, \dots, x_q) := \frac{\kappa_i(x_i)}{(1 + \|x_{i+1}\|^2 + \dots + \|x_q\|^2)^{p+1}}, \quad \forall i \in [1, q-1],$$

$$\mu_q(x_q) := \kappa_q(x_q),$$

is a feedback law p-bounded by $(R_j)_{0 \le j \le p}$ and $SISS_L$ -stabilizing for system (3).

This statement provides a unified control law solving Problem (BHD) for all admissible LTI systems. It allows in particular multi-input systems, which was not covered in [7].

3. Proof of the main results.

- **3.1. Proof of Theorem 1.** In this section, we prove Theorem 1. For that purpose, we first reduce the argument to establishing of Propositions 1 and 2 given below. The first one states that the feedback given in Theorem 1 is SISS_L stabilizing for (S) in the case of single input. The second proposition provides an estimate of the successive time derivatives of the control signal.
- 3.1.1. Reduction of the proof of Theorem 1 to the proofs of Proposi-238 tions 1 and 2. Let $n \in \mathbb{N}_{\geq 1}$, $p \in \mathbb{N}$ and $(R_j)_{0 \leq j \leq p}$ be a (p+1)-tuple of positive 239 real numbers. Define $\underline{R} := \min_{j \in [0,p]} R_j$. Consider a single input linear system 240 $\dot{x} = Ax + bu$ where $x \in \mathbb{R}^n$, A and \dot{b} are $n \times n$ and $n \times 1$ matrices respectively. We 241 assume that the pair (A, b) is stabilizable and that all the eigenvalues of A have non 242 positive real parts. As observed in [19], it is sufficient to consider the case where the 243 pair (A,b) is controllable and all eigenvalues of A are critical. Indeed, since (A,b)is stabilizable there exists a linear change of coordinates transforming A and b into 245 $\begin{pmatrix} A_1 & 0 \\ 0 & A_2 \end{pmatrix}$ and $\begin{pmatrix} b_1 \\ b_2 \end{pmatrix}$, where A_1 is Hurwitz, the eigenvalues of A_2 are critical and the 246 pair (A_2, b_2) is controllable. Then, it is immediate to see that we only have to treat 247 the case where A has only critical eigenvalues. From now on, we therefore assume that 248 A has only eigenvalues with zero real parts, and that the pair (A, b) is controllable. 249 250

Our construction uses the following linear change of coordinates given by [19, Lemma 5.2]. This decomposition puts the original system in a triangular form made of one-dimensional integrators and two-dimensional oscillators.

LEMMA 1 (Lemma 5.2 in [19]). Let $\dot{x} = Ax + bu$, $x \in \mathbb{R}^n$, $u \in \mathbb{R}$, be a controllable single input linear system. Assume that all the eigenvalues of A are critical. Let $\pm i\omega_1, \ldots, \pm i\omega_{s(A)}$ be the nonzero eigenvalues of A. Let $(a_2, \ldots, a_{\mu(A)})$ be a family of

265 where $y_i \in \mathbb{R}^2$ for i = 1, ..., s(A), $y_i \in \mathbb{R}$ for $i = s(A) + 1, ..., \mu(A) - 1$, and $y_{\mu(A)} \in \mathbb{R}$ 266 if $\mu(A) > s(A)$.

With no loss of generality, we prove Theorem 1 for system (7). We rely on a candidate feedback $\nu : \mathbb{R}^n \to \mathbb{R}$ under the form

where $a_1, \ldots, a_{\mu(A)}$ are positive constants that will be picked in such a way that the feedback law (8) is a feedback law p-bounded by $(R_j)_{0 \le j \le p}$, and $SISS_L$ -stabilizing for system (7). To that aim, we rely on the next two propositions, respectively proven in Sections 3.1.2 and 3.1.3.

PROPOSITION 1. Let $\dot{x} = Ax + bu$, $x \in \mathbb{R}^n$, $u \in \mathbb{R}$, be a controllable single input linear system. Assume that all the eigenvalues of A are critical. Let $\pm i\omega_1, \ldots, \pm i\omega_{s(A)}$ be the nonzero eigenvalues of A. Then, there exist $\mu(A) - 1$ functions $\overline{a}_i : \mathbb{R}_{>0} \to \mathbb{R}_{>0}$, $i \in [1, \mu(A) - 1]$ such that for any constants $a_1, \ldots, a_{\mu(A)}$ satisfying

$$a_{\mu(A)} \in (0,1], \quad a_i \in (0\,,\,\overline{a}_i(a_{i+1})], \quad \forall i \in [\![1,\mu(A)-1]\!],$$

the feedback law (8) is $SISS_L$ -stabilizing for system (7).

PROPOSITION 2. Let $\dot{x} = Ax + bu$, $x \in \mathbb{R}^n$, $u \in \mathbb{R}$, be a controllable single input linear system. Assume that all the eigenvalues of A are critical. Let $\pm i\omega_1, \ldots, \pm i\omega_{s(A)}$ be the nonzero eigenvalues of A. Let a_i , $i \in [1, \mu(A)]$, be positive constants in (0, 1].

Then, there exist a positive constant $c_{\mu(A)}$, and continuous functions $c_i : \mathbb{R}^{\mu(A)-i}_{>0} \to \mathbb{R}$

287 $\mathbb{R}_{>0}$, $i \in [1, \mu(A) - 1]$, such that for any trajectory of the closed-loop system (7) with 288 the feedback law (8), the control signal $U : \mathbb{R}_{\geq 0} \to \mathbb{R}$ defined by $U(t) := \nu(y(t))$ for all 289 $t \geq 0$ satisfies, for all $k \in [0, p]$,

$$\left| U^{(k)}(t) \right| \le a_{\mu} c_{\mu(A)} + \sum_{i=1}^{\mu(A)-1} a_i c_i(a_{\mu(A)}, \dots, a_{i+1}), \quad \forall t \ge 0.$$

Based on these two propositions, pick $a_{\mu(A)} \in (0,1]$ in such a way that

Moreover, as a consequence of Proposition 2, for any trajectory of the closed-loop system (7) with the feedback law 297 (8), the control signal $U: \mathbb{R}_{>0} \to \mathbb{R}$ defined by $U(t) := \nu(y(t))$ for all $t \geq 0$ satisfies 298 $\sup_{t>0} |U^{(k)}(t)| \leq \underline{R}$ for all $k \in [0,p]$. Thus, the feedback law (8) is a feedback law 299 p-bounded by $(R_j)_{0 \le j \le p}$ for system (7). Since there is a linear change of coordinate 300 301 (y=Tx) that puts (7) into the original form $\dot{x}=Ax+bu$, the feedback law defined 302 given in (2) can be picked as

and it is a feedback law p-bounded by $(R_j)_{0 \le j \le p}$, and $SISSL_L$ -stabilizing for (1). To sum up, the proof of Theorem 1 boils down to establishing Propositions 1 and 2.

- 306 **3.1.2. Proof of Proposition 1.** Proposition 1 is proved by induction on $\mu(A)$.
 307 More precisely, we show that the following property holds true for every positive integer μ .
- 309 (P_{μ}) : Let $s, z \in \mathbb{N}$ be such that $s + z = \mu$ and $\omega_1, \ldots, \omega_s$ be positive constants. 310 Then there exist $\mu - 1$ functions $\overline{a}_i : \mathbb{R}_{>0} \to \mathbb{R}_{>0}$, $i \in [1, \mu - 1]$ such that for any constants a_1, \ldots, a_{μ} satisfying

$$a_{\mu} \in (0,1], \quad a_i \in (0, \overline{a}_i(a_{i+1})], \quad \forall i \in [1, \mu - 1],$$

the feedback law (8) is $SISS_L$ -stabilizing for system (7), with $\mu(A) = \mu$, s(A) = s, and z(A) = z. Moreover the linearization of this closed-loop system around the origin is asymptotically stable (AS).

In order to start the argument, we give intermediate results whose proofs are given in Appendix and which will be used for the initialization step of the induction and the inductive step. The first statement establishes $SISS_L$ for the one-dimensional integrator.

case i) $z = \mu + 1$, i.e, all the eigenvalues of A are zero (multiple integrator);

case ii) $s \ge 1$, i.e some eigenvalues of A have non zero imaginary part (multiple integrator with rotating modes).

In both cases we reduce our problem to the choice of only one constant a_1 using the inductive hypothesis.

In both cases, it remains to show that there exists a function \overline{a}_1 such that if $a_1 \in (0, \overline{a}_1]$ then the closed-loop systems (14) and (19) are $SISS_L$ and globally asymptotically stable with respect to the origin, and their respective linearization at zero is asymptotically stable as well. According to Remark 1, one only needs to prove that the closed-loop systems are $SISS_L$ and their linearization at zero is asymptotically stable.

We start by showing the latter fact. For any $a_1 > 0$, the linearization at zero of the y_1 -subsystem in (14) (respectively (19)) is asymptotically stable since it is given by $\dot{y}_1 = -a_1 y_1$ (respectively $\dot{y}_1 = (\omega_1 A_0 - a_1 b_0 b_0^T) y_1$). 3.2. Proof of Theorem 2.

3.2.1. Reduction of the proof of Theorem 2 to the proof of Propositions 1 and 3. We prove Theorem 2 by induction on the number of inputs q. We show that the inductive step reduces to Proposition 1 and Proposition 3 which is proven in Section 3.2.2.

For q=1, the conclusion follows from Theorem 1. For a given $q\in\mathbb{N}_{\geq 1}$ assume that Theorem 2 holds. We show that Theorem 2 then holds for LTI systems given in the reduced controllability form with q+1 inputs. Let $p \in \mathbb{N}$ and $(R_i)_{0 \le i \le p}$ be a (p+1)-tuple of positive real numbers. Define $\underline{R} := \min_{j \in [0,p]} R_j$. Given $n \in \mathbb{N}_{\geq 2}$ consider a LTI system given in the reduced controllability form with $\tilde{q} := q+1$ inputs by

598 where $x_i \in \mathbb{R}^{n_i}$ and $u_i \in \mathbb{R}$ for each $i \in [0, q+1]$, A_{00} is Hurwitz, for every $i \in [1, q+1]$ all the eigenvalues of A_{ii} are critical, and the pairs (A_{ii}, b_{ii}) are controllable. 599

Since A_{00} is Hurwitz, if we find a feedback law p-bounded by $(R_i)_{0 \le i \le p}$, and 600 $SISS_L$ -stabilizing for $(x_1, \ldots, x_{\tilde{q}})$ -subsystem then, clearly, this feedback does the job for the complete system. Let $\pm i\omega_1, \ldots, \pm i\omega_{s(A)}$ be the nonzero eigenvalues of A, $(a_2, \ldots, a_{\mu(A)})$ be a sequence of positive numbers and $T \in \mathbb{R}^{n,n}$ be such that the linear change of coordinate y = Tx transforms $\dot{x} = Ax + bu$ into system (7) compactly written as $\dot{y} = Jy + bu$. Rewrite T as

$$T = [T_1, \dots, T_{s(A)}, T_{s(A)+1}, \dots, T_{\mu(A)}]^T,$$

- 609 where $T_i \in \mathbb{R}^{2,n}$ if $i \in [1, s(A)]$ otherwise $T_i \in \mathbb{R}^{1,n}$. Then T has the following 610 property
- 611 (I): $T_{\mu(A)}$ is independent of $(a_2, \ldots, a_{\mu(A)})$, and each T_i depend only on $(a_{i+1}, \ldots, a_{\mu(A)})$.
- Moreover, given $r, k \in \mathbb{N}$, let $M \in \mathbb{R}^{n,r}$ be independent of the constants a_i , then the matrices TM and J^kT satisfy property (\mathcal{I}) .
- The proof of Lemma 4 follows from a careful examination of the proofs of Lemmas 3.1 and 5.1 in [19].
- 617 . Let $(a_2, \ldots, a_{\mu(A_{11})})$ be a sequence of positive numbers (to be chosen later). Let 618 T be the linear change of coordinate that transforms $\dot{x} = A_{11}x + b_{11}u_1$ into the form 619 of system (7) compactly written as $\dot{y} = Jy + bu$. We now make the following changes 620 of coordinates y = Tx, and system (47) is then given by

621 (48a)
$$\dot{y} = Jy + bu_1 + T\tilde{A}z + T\tilde{B}\overline{u},$$

$$\dot{z} = \overline{A}z + \overline{B}\overline{u}.$$

- Let κ be a feedback law p-bounded by $(R_j/2)_{0 \leq j \leq p}$, and $SISS_L(N_2, \Delta_2)$ -stabilizing
- for subsystem (48b), for some $N_2, \Delta_2 > 0$ (thanks to the inductive hypothesis, we
- know that this feedback law exists). Let $a_1 > 0$, to be chosen later. We seek the
- 627 following state feedback law:

628 (49a)
$$u_1(y,z) := \frac{\mu(y)}{(1+\|z\|^2)^p},$$

$$\overline{u}(z) := \kappa(z),$$

- 631 where $\mu(y)$ is defined in (8). We now show that there exist positive constants
- $(a_1, a_2, \ldots, a_{\mu(A_{11})})$ such that the feedback law (49) is a feedback law p-bounded and
- 633 $SISS_L$ -stabilizing for system (48). This choice is based on Proposition 1 and the
- 634 following statement which is proven in Section 3.2.2.
- PROPOSITION 3 (p-bounded feedback). Let a_i , for $i \in [1, \mu(A_{11})]$, be positive constants in (0, 1]. Consider system (48) with the feedback law (49). Assume that κ
- is a feedback law p-bounded by $(R_j/2)_{0 \le j \le p}$, and $SISS_L(N_2, \Delta_2)$ -stabilizing for sub-
- 638 system (48b). Then, there exist a positive constant $c_{\mu(A_{11})}$, and continuous functions

639 $c_i: \mathbb{R}_{>0}^{\mu(A_{11})-i} \to \mathbb{R}_{>0}, i \in [1, \mu(A_{11}) - 1], \text{ such that for any trajectory of the closed-}$ 640 $loop \ system \ (48) \ with \ the \ feedback \ law \ (49), \ the \ control \ signal \ U_1: \mathbb{R}_{\geq 0} \to \mathbb{R} \ defined$ 641 $by \ U_1(t) := u_1(y(t), z(t)) \ for \ all \ t \geq 0 \ satisfies, \ for \ all \ k \in [0, p],$

$$\left| U_1^{(k)}(t) \right| \le a_{\mu} c_{\mu(A_{11})} + \sum_{i=1}^{\mu(A_{11})-1} a_i c_i(a_{\mu(A_{11})}, \dots, a_{i+1}), \quad \forall t \ge 0.$$

Pick $a_{\mu(A_{11})} \in (0,1]$ in such a way that

$$a_{\mu(A_{11})} \le \frac{\underline{R}}{2(p+1)c_{\mu(A_{11})}}.$$

Choose recursively $a_i \in (0,1], i = \mu(A_{11}) - 1, \dots, 1$, such that

644
$$a_i \leq \overline{a}_i(a_{i+1}), \quad a_i \leq \frac{\underline{R}}{2(p+1)c_i(a_{\mu(A)}, \dots, a_{i+1})},$$

where the functions c_i appearing above are defined in Proposition 3 and the functions \overline{a}_i are defined in Proposition 1. By Proposition 1, the feedback law $\mu(y)$ is $SISS_L$ stabilizing for system $\dot{x} = Jx + bu$. We now prove that the closed-loop system (48)
with the feedback (49) is $SISS_L$ (now, all the coefficients have been chosen). To that
aim, first notice that there exist $\alpha_1, \alpha_2 > 0$ such that, for all $||z|| \leq 1$,

$$\left\| T\tilde{A}z + T\tilde{B}\kappa(z) \right\| \le \alpha_1 \|z\|,$$
651
$$\left\| b\mu(y) \left(1 - \frac{1}{(1 + \|z\|^2)^p} \right) \right\| \le \alpha_2 \|z\|.$$

Let

$$\Delta:=\min\left\{1,\;\Delta_2,\;\frac{1}{N_2},\;\frac{\Delta_1}{(\alpha_2+\alpha_1)N_2+1}\right\}.$$

- Given $\delta \leq \Delta$, let e_1, e_2 be two bounded measurable functions of the appropriate dimension, eventually bounded by δ . Consider any trajectory $(y(\cdot), z(\cdot))$ of the following system
- 655 (50) $\dot{y} = Jy + b\mu(y) b\mu(y) \left(1 \frac{1}{(1 + ||z||^2)^p}\right) + T\tilde{A}z + T\tilde{B}\kappa(z) + e_1,$
- $\dot{z} = \overline{A}z + \overline{B}\kappa(z) + e_2,$
- From the $SISS_L(\Delta_2, N_2)$ property of z-subsystem it follows that $||z(\cdot)|| \le_{ev} N_2 \delta \le 1$.

 Thus, using the above estimate, it is immediate to see that

660
$$\left\| b\mu(y(\cdot)) \left(1 - \frac{1}{(1 + \|z(\cdot)\|^2)^p} \right) + T\tilde{A}z(\cdot) + T\tilde{B}\kappa(z(\cdot)) + e_1(\cdot) \right\| \le_{ev} \delta\left((\alpha_1 + \alpha_2)N_2 + 1 \right)$$
661
$$\le \Delta_1.$$

Therefore, invoking the $SISS_L(\Delta_1, N_1)$ property of $\dot{x} = Jx + b\mu(y)$, it follows that $||y(\cdot)|| \leq_{ev} \delta((\alpha_1 + \alpha_2)N_2 + 1)N_1$. So, the closed-loop system (48) with the feedback (49) is $SISS_L$. Moreover, as a consequence of Proposition 3 and of the inductive hypothesis, for any trajectory of the closed-loop system (7) with the feedback law

(49), the control signal $U: \mathbb{R}_{\geq 0} \to \mathbb{R}^m$, defined by $U(\cdot) := [U_1(\cdot), U_2(\cdot)]^T$ with $U_1(t) := u_1(y(t), z(t))$ and $U_2(t) := \kappa(z(t))$ for all $t \geq 0$, satisfies

$$\sup_{t \ge 0} \left\| U^{(k)}(t) \right\| \le R_k$$

- for all $k \in [0, p]$. Thus, the feedback law (49) is a feedback law p-bounded by $(R_j)_{0 \le j \le p}$ for system (48).
- 3.2.2. Proof of Proposition 3. For the sake of notation compactness let $\mu = \mu(A_{11})$. To prove Proposition 3, we establish by induction on k that the following property holds, for all $k \in [0, p]$:
- 667 (\overline{H}_k) : There exist a positive constant c_{μ} , and continuous functions $c_i : \mathbb{R}_{>0}^{\mu-i} \to \mathbb{R}_{>0}$, 668 $i \in [1, \mu - 1]$, such that for any trajectory of the closed-loop system (48) 669 with the feedback law (49), the control signal $U_1 : \mathbb{R}_{\geq 0} \to \mathbb{R}$ defined by 670 $U_1(t) := u_1(y(t), z(t))$ for all $t \geq 0$ satisfies, for all $j \in [0, k]$,

$$\left| U_1^{(j)}(t) \right| \le a_{\mu} c_{\mu} + \sum_{i=1}^{\mu-1} a_i c_i(a_{\mu}, \dots, a_{i+1}), \quad \forall t \ge 0.$$

- For k=0, the statement (\overline{H}_0) holds trivially. Now, assume that (\overline{H}_k) holds true for some $k \in [0, p-1]$. We next prove that (\overline{H}_{k+1}) also holds true. Let $(y(\cdot), z(\cdot))$ be any trajectory of the closed-loop system (48) with the feedback law (49), and the control signal $U_1(t) := u_1(y(t), z(t))$ and $U_2(t) := \kappa(z(t)), \forall t \geq 0$. As in the proof of Proposition 2, it is sufficient to prove that there exist a positive constant $\tilde{\Upsilon}_{\mu}$ and continuous functions $\tilde{\Upsilon}_i : \mathbb{R}^{\mu-i}_{>0} \to \mathbb{R}_{>0}, i \in [1, \mu-1]$, such that
- 678 (52) $\left| U_1^{(k+1)}(t) \right| \le a_{\mu} \tilde{\Upsilon}_{\mu} + \sum_{i=1}^{\mu-1} a_i \tilde{\Upsilon}_i(a_{\mu}, \dots, a_{i+1}), \quad \forall t \ge 0.$
- Let $\tilde{q}(s) := s^{-(p+1)}$, for all s > 0. Define $h(t) := 1 + ||z(t)||^2$, for all $t \ge 0$. With the same notation given in the proof of Proposition 2, one can write $U_1(\cdot)$ as

681 (53)
$$U_1(t) = -\sum_{i=1}^{\mu} U_{1i}(t), \quad \forall t \ge 0,$$

where, for every $i \in [1, \mu]$,

683 (54)
$$U_{1i}(t) := Q_{i,\mu} b_{0,i}^T y_i(t) [g \circ f_i](t) [\tilde{q} \circ h](t), \quad \forall t \ge 0.$$

As in the proof of Proposition 2, we next show that for each $i \in [1, \mu]$, there exist continuous functions $c_{i,l} : \mathbb{R}_{>0}^{\mu-l} \to \mathbb{R}_{>0}$, $l \in [1, i]$, such that, for all $t \geq 0$,

(55)
$$|U_{1i}^{(k+1)}(t)| \le \sum_{l=1}^{i} a_l c_{i,l}(a_\mu, \dots, a_{l+1}),$$

- 687 $c_{i,\mu}$ is actually a constant independent of a_{μ} , we write it as $c_{i,\mu}(a_{\mu}, a_{\mu+1})$ for the sake
- 688 of notation homogeneity. For $i \in [1, \mu]$, we apply Leibniz's rule to (54) and obtain
- that the (k+1)-th time derivative of $U_{1i}(\cdot)$ is given, for all $t \geq 0$, by

690
$$U_{1i}^{(k+1)}(t) = a_i Q_{i+1,\mu} \left(\sum_{l_1=0}^{k+1} \sum_{l_2=0}^{l_1} {k+1 \choose l_1} {l_1 \choose l_2} [\tilde{q} \circ h]^{(k+1-l_1)}(t) [g \circ f_i]^{(l_2)}(t) b_{0,i}^T y_i^{(l_1-l_2)}(t) \right).$$

691 Then, to get (55), it is sufficient to show that:

a) there exists C > 0 such that, for any $l \in [0, k+1]$ and for all $t \ge 0$,

$$\left| [\tilde{q} \circ h]^{(\tilde{l})}(t) \right| \le C[\tilde{q} \circ h](t).$$

b) for each $i \in [1, \mu]$, there exist Ψ_i , Θ_i , $\Phi_i : \mathbb{R}_{>0}^{\mu-i} \to \mathbb{R}_{>0}$, and $v_{i,j} : \mathbb{R}_{>0}^{\mu-j} \to \mathbb{R}_{>0}$ 692 $\mathbb{R}_{>0}$ for $j \in \llbracket 1,i \rrbracket$ such that, for any $\tilde{l} \in \llbracket 0,k+1 \rrbracket$ and for all $t \geq 0,$

694
$$\|y_i^{(\tilde{l})}(t)\| \leq \overline{\Psi}_i(a_{\mu}, \dots, a_{i+1}) \sum_{l=i}^{\mu} \|y_l(t)\| + \Theta_i(a_{\mu}, \dots, a_{i+1}) \|z(t)\|$$

$$+ \overline{\Phi}_i(a_{\mu}, \dots, a_{i+1}) + \sum_{l=1}^i a_l \tilde{v}_{l,i}(a_{\mu}, \dots, a_{l+1}).$$

c) for each $i \in [\![1,\mu]\!]$, there exist $\Gamma_i, \theta_i : \mathbb{R}_{>0}^{\mu-i} \to \mathbb{R}_{>0}$, and $\Gamma_{i,j} : \mathbb{R}_{>0}^{\mu-j} \to \mathbb{R}_{>0}$ for $j \in [\![1,i]\!]$ such that, for any $\tilde{l} \in [\![0,k+1]\!]$ and for all $t \ge 0$, 696 697

698
$$\left| \left[g \circ f_i \right]^{(\tilde{l})}(t) \right| \leq \left[g \circ f_i \right](t) \left(\Gamma_i(a_\mu, \dots, a_{i+1}) + \sum_{l=1}^i a_l \tilde{v}_{l,i}(a_\mu, \dots, a_{l+1}) + \theta_i(a_\mu, \dots, a_{i+1}) \|z(t)\|^{2\tilde{l}} \right).$$

We now establish a). By an inductive argument using differentiation of the zsubsystem (48b) coupled with the fact that the feedback law κ is p-bounded, one easily shows that there exist $C_0, C_1 > 0$ such that for any $l \in [1, k+1]$ and for any $t \geq 0$,

$$||z^{(\tilde{l})}(t)|| \le C_0 + C_1 ||z(t)||.$$

Using the Leibniz rule, it can be establish that there exist $\tilde{C}_0, \tilde{C}_1 > 0$ such that, for any $l \in [1, k+1]$,

$$|h^{(\tilde{l})}(t)| \leq \tilde{C}_0 + \tilde{C}_1 ||z(t)||^2,$$

for all $t \geq 0$. Thanks to Faá Di Bruno Formula (Lemma 5) applied to $[q \circ h]$, item a) 700 701 follows.

We now deal with item b). From Lemma 4 and an induction argument using 702 differentiation of system (48a), one can obtain the following statement: for any $l_1 \in$ 703 $[\![1,k+1]\!],\ i\in[\![1,\mu]\!],\ \text{there exist continuous functions}\ \overline{\Psi}_{l_1,i,l}:\mathbb{R}_{>0}^{\mu-i}\to\mathbb{R}_{>0},\ l\in[\![1,k+1]\!]$

707
$$\|y_{i}^{(l_{1})}(t)\| \leq \sum_{l=i}^{\mu} \overline{\Psi}_{l_{1},i,l}(a_{\mu},\ldots,a_{i+1}) \|y_{l}(t)\| + \overline{\Theta}_{l_{1},i,l}(a_{\mu},\ldots,a_{i+1}) \|z(t)\|$$

$$+ \sum_{l=0}^{l_{1}-1} \overline{\Phi}_{l_{1},i,l}(a_{\mu},\ldots,a_{i+1}) |U_{1}^{(l)}(t)| + \overline{\Xi}_{l_{1},i,l}(a_{\mu},\ldots,a_{i+1}) \|U_{2}^{(l_{1})}(t)\| .$$

So, using the inductive hypothesis and the fact that κ is a p-bounded feedback law, 709 one can obtain item b). 710

Proceeding as in Proposition 2, one can get item c). This ends the proof of 711 Proposition 3. 712

4. Numerical validation.

727

In order to test the validity of our main result, we consider the single-input system discussed after Definition 3, namely $\dot{x} = Ax + bu$ with

$$A = \left(\begin{array}{cccc} 0 & -1 & 0 & 0 \\ 1 & 0 & 0 & 1 \\ 0 & 0 & 0 & -1 \\ 0 & 0 & 1 & 0 \end{array}\right), \quad b = \left(\begin{array}{c} 0 \\ 0 \\ 0 \\ 1 \end{array}\right).$$

It can easily be checked that A has no eigenvalue with positive real part (it actually has two pairs of purely imaginary eigenvalues: $s(A) = \mu(A) = 2$) and that the pair (A, b) is controllable, thus making the assumptions of Theorem 1 fulfilled. The system is readily in the form (7) and the proposed control law (8) reads

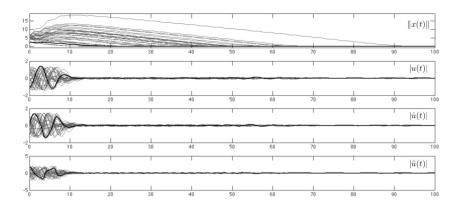


FIG. 1. Time evolution of the state norm, the control signal, and its first two derivatives for 30 random initial states within [-5;5].

$$\kappa(y) = -\frac{Q_{1,2}x_2}{\left(1 + \|x\|^2\right)^{1/2}} - \frac{Q_{2,2}x_4}{\left(1 + x_3^2 + x_4^2\right)^{1/2}},$$

where $Q_{1,2} = a_1 a_2$ and $Q_{2,2} = a_2$ for some $a_1, a_2 > 0$. In Figure 1, we run 30 simulations, each of them starting from initial conditions randomly picked in the interval [-5; 5], with $a_1 = 0.5$ and $a_2 = 1$. A particular solution is reported in bold black.

These simulations indicate that, despite poor closed-loop performance, stabilization is achieved for all considered initial states, while u(t), $\dot{u}(t)$, and $\ddot{u}(t)$ all remain within [-2;2].

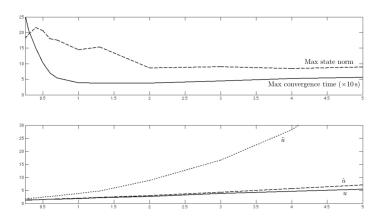


FIG. 2. Top: Maximum value of the transient state norm and maximum convergence time over 30 random simulations, as a function of the feedback gain a_1 . Bottom: Maximum norm of the control signal and of its first two derivatives over 30 random simulations, as a function of the feedback gain a_1 .

Varying the parameter a_1 between 0.25 and 5, and running again 30 simulations for each of these values, Figure 2 reports the largest transient state norm and convergence time (top), and the values reached by |u(t)|, $|\dot{u}(t)|$ and $|\ddot{u}(t)|$ respectively (bottom).

It can be seen that the control signal and its first two derivatives can be constrained to smaller values, while still achieving stabilization. Not surprisingly, the price to pay is a larger overshoot and a slower convergence towards the origin as a_1 decreases.

740 **5.1. Proof of Lemma 2** . Let $\epsilon > 1$ and $\beta > 0$. We first prove forward completeness of

742 (56)
$$\dot{x} = -\beta \frac{x}{(1+x^2)^{1/2}} + d_1$$

743 in response to any locally bounded function $d_1(\cdot)$. For this, let $V(x) := x^2/2$. Its derivative along trajectories of (56) satisfies

745 (57)
$$\dot{V}(x) = -\beta \frac{x^2}{(1+x^2)^{1/2}} + x^T d_1(t).$$

Then, a straightforward computation leads to $\dot{V}(x) \leq V(x) + d_1(t)^2$ and forward completeness follows using classical comparison results. Moreover when $d_1 = 0$, (57) ensures that the origin of (56) is G.A.S.

We then prove the $SISS_L(\beta/2, \frac{2\epsilon}{\beta})$ property of the system (56) with respect to $d_1(\cdot)$. Given $\delta \leq \beta/2$, let d_1 be a bounded measurable function on $\mathbb{R}_{\geq 0}$ eventually bounded by δ . Since the system is forward complete, we can consider without loss of generality that $d_1(t) \leq \delta$ for all $t \geq 0$. From (57) and the fact that $(1+x^2)^{1/2} \leq 1+|x|$, one can obtain that

$$\dot{V}(x) = -\beta \frac{x^2}{(1+x^2)^{1/2}} + \frac{1}{(1+x^2)^{1/2}} (|d_1(t)| |x| + |d_1(t)| |x^2|).$$

755 Observing that

$$\frac{|d_1(t)| x^2}{(1+x^2)^{1/2}} \le \frac{\beta x^2}{2(1+x^2)^{1/2}},$$

757 it follows that

758 (59)
$$\dot{V}(x) \le -\beta \frac{|x|}{(1+x^2)^{1/2}} (|x| - \frac{2}{\beta}\delta).$$

759 Consequently, $\dot{V} < 0$ whenever $|x| > \frac{2\delta}{\beta}$. It follows that every trajectory of (10)

760 eventually enters and remains in the set $S = \{x \in \mathbb{R} : x^2 \le \epsilon^2 (\frac{2\delta}{\beta})^2\}$ (indeed, $\dot{V} < 0$

for all $x \notin S$ and $x \in \partial S$). Thus Lemma 2 can be easily established.

762 **5.2. Proof of Lemma 3.** Let $\omega > 0$. Given any $0 < \beta < 1$, let $A_{\beta} := \omega A_0 - \beta b_0 b_0^T$, which is Hurwitz since A_0 is skew-symmetric and (A_0, b_0) is controllable.

764 Therefore there exists a symmetric positive definite matrix P_{β} satisfying the following

765 Lyapunov equation

$$766 \quad (60) \qquad P_{\beta}A_{\beta} + A_{\beta}^{T}P_{\beta} = -\mathbb{I}_{2}.$$

767 A simple computation gives

$$P_{\beta} = \begin{pmatrix} \frac{\beta}{2\omega^2} + \frac{1}{\beta} & \frac{1}{2\omega} \\ \frac{1}{2\omega} & \frac{1}{\beta} \end{pmatrix}.$$

The smallest and largest eigenvalues of P_{β} denoted by $\underline{\sigma}_{\beta}$ and $\overline{\sigma}_{\beta}$ respectively are given by

$$\underline{\sigma}_{\beta} := \beta \left\| P_{\beta} b_0 \right\|^2 - \frac{\beta}{2\omega} \left\| P_{\beta} b_0 \right\|,$$

$$\overline{\sigma}_{\beta} := \beta \left\| P_{\beta} b_0 \right\|^2 + \frac{\beta}{2\omega} \left\| P_{\beta} b_0 \right\|,$$

773 with

774
$$||P_{\beta}b_{0}|| = \sqrt{\frac{1}{4\omega^{2}} + \frac{1}{\beta^{2}}}.$$

775 Define $V: \mathbb{R}^2 \to \mathbb{R}_{>0}$ as

776 (61)
$$V(x) := x^T P_{\beta} x + \frac{(\overline{\sigma}_{\beta} + \underline{\sigma}_{\beta})}{3} \left((1 + \|x\|^2)^{3/2} - 1 \right), \quad \forall x \in \mathbb{R}^2.$$

777 Given C > 1, let α_1 and α_2 be class \mathcal{K}_{∞} functions given by

778
$$\alpha_1(r) := \frac{(\overline{\sigma}_{\beta} + \underline{\sigma}_{\beta})}{C} \max\{r^2, r^3\},$$

779
$$\alpha_2(r) := C(\overline{\sigma}_{\beta} + \underline{\sigma}_{\beta}) \max\{r^2, r^3\}.$$

There exists C > 1 such that

781
$$\alpha_1(\|x\|) \le V(x) \le \alpha_2(\|x\|), \quad \forall x \in \mathbb{R}^2.$$

Moreover, there exists a constant M > 0, independent of β , such that

783 (62)
$$\alpha_1^{-1} \circ \alpha_2(r) \le Mr, \quad \forall r \ge 0.$$

Proceeding as in the proof of Lemma 2, forward completeness of

785 (63)
$$\dot{x} = \omega A_0 x - \beta b_0 \frac{b_0^T x}{(1 + ||x||^2)^{1/2}} + d_1$$

can easily be derived in response to any locally measurable bounded function d_1 . We next show that the system (63) is $SISS_L(\beta\Gamma, N/\beta)$ with respect to d_1 , for some N > 0

788 and with

789 (64)
$$\Gamma := \frac{1}{8(\frac{1}{4\omega^2} + 1)}.$$

Since (63) is forward complete, we can assume without loss of generality that d_1 790 satisfies $||d_1(t)|| \leq \delta$, $\forall t \geq 0$, for some $\delta \leq \beta \Gamma$. Consider the Lyapunov function $V: \mathbb{R}^2 \to \mathbb{R}$ defined in (61). By noticing that (63) can be rewritten as 792

$$\dot{x} = A_{\beta}x + \beta b_0 b_0^T x \left(1 - \frac{1}{(1 + \|x\|^2)^{1/2}} \right) + d_1,$$

one gets that the time derivative of V along trajectories of (63) satisfies 794

$$\dot{V} = x^{T} P_{\beta} \left(A_{\beta} x + \beta b_{0} b_{0}^{T} x \left(1 - \frac{1}{(1 + \|x\|^{2})^{1/2}} \right) + d_{1} \right)$$
796
$$+ \left(x^{T} A_{\beta}^{T} + \beta b_{0}^{T} b_{0}^{T} x \left(1 - \frac{1}{(1 + \|x\|^{2})^{1/2}} \right) + d_{1}^{T} \right) P_{\beta} x$$
797
$$+ (\overline{\sigma}_{\beta} + \underline{\sigma}_{\beta}) (1 + \|x\|^{2})^{1/2} \left(-\beta \frac{(b_{0}^{T} x)^{2}}{(1 + \|x\|^{2})^{1/2}} + x^{T} d_{1} \right).$$

Since P_{β} is a symmetric matrix satisfying the Lyapunov equation (60), it follows that 799

800
$$\dot{V} = -\|x\|^2 + 2\beta x^T P_{\beta} b_0 b_0^T x \left(1 - \frac{1}{(1 + \|x\|^2)^{1/2}}\right) + 2x^T P_{\beta} d_1 - \beta (\overline{\sigma}_{\beta} + \underline{\sigma}_{\beta}) (b_0^T x)^2 + (\overline{\sigma}_{\beta} + \underline{\sigma}_{\beta}) (1 + \|x\|^2)^{1/2} x^T d_1.$$

By completing the squares it holds that, for all $t \geq 0$, 803

$$\left| 2\beta x^T P_{\beta} b_0 b_0^T x \left(1 - \frac{1}{(1 + \|x\|^2)^{1/2}} \right) \right| \le \frac{\|x\|^2}{2} + 2\beta^2 \|P_{\beta} b_0\|^2 (b_0^T x)^2.$$

Therefore, one can get that 805

806
$$\dot{V} \le -\frac{1}{2} \|x\|^2 + 2x^T P d_1 + 2\beta \|P b_0\|^2 (1 + \|x\|^2)^{1/2} x^T d_1.$$

Using the fact that $(1+||x||^2)^{1/2} \leq 1+||x||$ for all $x \in \mathbb{R}^2$, and exploiting (64), it 807 follows that

809
$$\dot{V} \le -\frac{1}{4} \|x\|^2 + 2 \|x\| \delta \left(2\beta \|P_{\beta}b_0\|^2 + \frac{\beta}{2\omega} \|P_{\beta}b_0\| \right).$$

Consequently, it holds that $\dot{V} < 0$ whenever $||x|| > 8\delta(2\beta ||P_{\beta}b_0||^2 + \frac{\beta}{2\omega} ||P_{\beta}b_0||)$. Let $\mu > 1$ and set $r := 8\mu(2\beta ||P_{\beta}b_0||^2 + \frac{\beta}{2\omega} ||P_{\beta}b_0||)$. Define $S := \{x \in \mathbb{R}^2 : V(x) \le 1\}$ 810

 $\alpha_2(r\delta)$. If $x \notin S$ then $||x|| > r\delta$. Consequently, any trajectory eventually enters and

stay in S. Moreover, we have that $\alpha_1(||x(\cdot)||) \leq_{ev} V(x(t)) \leq \alpha_2(r\delta)$. From (62),

it follows that $||x(\cdot)|| \leq_{ev} rM\delta$. Moreover, one can see that there exists a constant

D>0 such that for any $\beta\leq 1$ we have $r\leq \frac{D}{\beta}$. So we obtain

$$||x(\cdot)|| \le_{ev} \frac{N\delta}{\beta},$$

for some N > 0, which concludes the proof.

LEMMA 5 (Faà Di Bruno's formula, [6], p. 96). For $k \in \mathbb{N}$, let $\phi \in C^k(\mathbb{R}_{\geq 0}, \mathbb{R})$ and $\rho \in C^k(\mathbb{R}, \mathbb{R})$. Then the k-th order derivative of the composite function $\rho \circ \phi$ is given by

]^(k) $(t) = \sum_{a=1}^{k} \rho^{(a)}(\phi(t)) B_{k,a} \Big(\phi^{(1)}(t), \dots, \phi^{(k-a+1)}(t)\Big),$

823 where $B_{k,a}$ is the Bell polynomial given by

$$B_{k,a}\Big(\phi^{(1)}(t), \dots, \phi^{(k-a+1)}(t)\Big) := \sum_{\delta \in \mathcal{P}_{k,a}} c_{\delta} \prod_{l=1}^{k-a+1} \Big(\phi^{(l)}(t)\Big)^{\delta_l},$$

where $\mathcal{P}_{k,a}$ denotes the set of (k-a+1)-tuples $\delta := (\delta_1, \delta_2, \dots, \delta_{k-a+1})$ of positive integers satisfying

$$\delta_{1} + \delta_{2} + \ldots + \delta_{k-a+1} = a,$$

$$\delta_{1} + 2\delta_{2} + \ldots + (k-a+1)\delta_{k-a+1} = k,$$

$$c_{\delta} := \frac{k!}{(\delta_{1}! \cdots \delta_{k-a+1}! (1!)^{\delta_{1}} \cdots ((k-a+1)!)^{\delta_{k-a+1}})}.$$
