## Supplementary material for Proposition 3.1

## 1 Notations and preliminaries

The functions $\log$ and $\ln$ denote respectively the base 2 and the natural logarithms. By convention, $0 \log 0=0=0 \ln 0$. For $x \in \mathbb{R},\lfloor x\rfloor$ (resp. $\lceil x\rceil)$ denotes the greatest (resp. smallest) integer not greater (resp. not smaller) than $x$. For integers $a \leq b, \llbracket a, b \rrbracket$ denotes the set of integers between $a$ and $b$, bounds included. Let $\mathbb{D}=\left\{2^{\mu}: \mu \in \mathbb{N}\right\}$.

Let $(X, Y) \simeq P_{X, Y}$ be an arbitrary pair of random variables over $\mathcal{B} \times \mathcal{Y}$ with $\mathcal{B}=\{0,1\}$ and $\mathcal{Y}$ an arbitrary countable set. We regard $(X, Y)$ as a memoryless source $S$, with $X$ as the part to be compressed and $Y$ in the role of "side-information" about $X$. We consider a sequence $S=\left\{\left(X_{i}, Y_{i}\right): i \in \mathbb{N}^{*}\right\}$ of independent drawings from $(X, Y)$ - which can be interpreted as a representation of the source $S$ - and we introduce the two transformations ${ }^{-}$and ${ }^{+}$applied to the source $S$ and defined by

\begin{align*}
& S^{-}=\left\{\left(X_{2 i-1} \oplus X_{2 i},\left(Y_{2 i-1}, Y_{2 i}\right)\right): i \in \mathbb{N}^{*}\right\}  \tag{1}\\
& S^{+}=\left\{\left(X_{2 i},\left(Y_{2 i-1}, Y_{2 i}, X_{2 i-1} \oplus X_{2 i}\right)\right): i \in \mathbb{N}^{*}\right\} \tag{2}
\end{align*}
$$

With these notations, $S^{-}$(resp. $S^{+}$) is the memoryless source that takes its values in $\mathcal{B} \times\left(\mathcal{Y}^{2}\right)$ (resp. in $\mathcal{B} \times\left(\mathcal{Y}^{2} \times \mathcal{B}\right)$ ), with $X_{1} \oplus X_{2}$ (resp. $X_{2}$ ) as the part to be compressed and $\left(Y_{1}, Y_{2}\right)$ (resp. $\left(Y_{1}, Y_{2}, X_{1} \oplus X_{2}\right)$ ) in the role of "side-information".

The process that constructs $S^{-}$and $S^{+}$from $S$ can be written $S_{0}^{(0)}=S$,

$$
\begin{equation*}
S_{1}^{(0)}=\left(S_{0}^{(0)}\right)^{-}=S^{-} \quad \text { and } \quad S_{1}^{(1)}=\left(S_{0}^{(0)}\right)^{+}=S^{+} \tag{3}
\end{equation*}
$$

Applied recursively, this process leads to the sequence of memoryless sources $\left(S_{\mu}^{(i)}\right)_{\mu \in \mathbb{N}, i \in\left\lceil 0,2^{\mu}-1 \rrbracket\right.}$, where $S_{\mu}^{(i)}$ takes its values in a set $\mathcal{B} \times\left(\mathcal{Y}^{2^{\mu}} \times \mathcal{B}^{K(i)}\right)$ with $K(i) \in \llbracket 0,2^{\mu}-1 \rrbracket$ and is defined by

$$
S_{\mu+1}^{(i)}= \begin{cases}\left(S_{\mu}^{(\lfloor i / 2\rfloor)}\right)^{-} & \text {if } i \text { is even }  \tag{4}\\ \left(S_{\mu}^{(\lfloor i / 2\rfloor)}\right)^{+} & \text {if } i \text { is odd }\end{cases}
$$

Let us introduce the sources' conditional entropies expressed in bits:

$$
\begin{align*}
H(S) & =\mathbb{H}\left(X_{1} \mid Y_{1}\right)=\mathbb{H}\left(X_{2} \mid Y_{2}\right),  \tag{5}\\
H\left(S^{-}\right) & =\mathbb{H}\left(X_{1} \oplus X_{2} \mid Y_{1}, Y_{2}\right)  \tag{6}\\
H\left(S^{+}\right) & =\mathbb{H}\left(X_{2} \mid Y_{1}, Y_{2}, X_{1} \oplus X_{2}\right) . \tag{7}
\end{align*}
$$

For any $m \in \mathbb{D}\left(m=2^{\mu}\right.$ with $\left.\mu \in \mathbb{N}\right)$ and for any $\left.\left.\theta \in\right] 0, \frac{1}{2}\right]$, let

$$
\begin{align*}
\mathcal{H}_{X \mid Y} & =\mathcal{H}_{X \mid Y}(\theta)=\mathcal{H}_{X \mid Y}^{(m)}(\theta)=\left\{i \in \llbracket 0, m-1 \rrbracket: H\left(S_{\mu}^{(i)}\right)>\theta\right\}  \tag{8}\\
\mathcal{V}_{X \mid Y} & =\mathcal{V}_{X \mid Y}(\theta)=\mathcal{V}_{X \mid Y}^{(m)}(\theta)=\left\{i \in \llbracket 0, m-1 \rrbracket: H\left(S_{\mu}^{(i)}\right)>1-\theta\right\} . \tag{9}
\end{align*}
$$

For any memoryless source $S=(X, Y) \simeq P_{X, Y}$, we introduce its Bhattacharyya parameter:

$$
\begin{align*}
Z(S) & =2 \sum_{y \in \mathcal{Y}} \sqrt{P_{X, Y}(0, y) P_{X, Y}(1, y)}  \tag{10}\\
& =\sqrt{4 P_{X}(0) P_{X}(1)} \sum_{y \in \mathcal{Y}} \sqrt{P_{Y \mid X}(y \mid 0) P_{Y \mid X}(y \mid 1)}
\end{align*}
$$

which is the inner product between the unit vectors whose components are the square root of the distributions $P_{Y \mid X=0}$ and $P_{Y \mid X=1}$, under equiprobability $P_{X}(0)=P_{X}(1)=\frac{1}{2}$. This
quantity informs about the similarity between the side-information $Y$ when $X$ is 0 and 1, under equiprobability $P_{X}(0)=P_{X}(1)=\frac{1}{2}$.

Let

$$
\begin{equation*}
h(x)=-x \log x-(1-x) \log (1-x) \tag{11}
\end{equation*}
$$

be the entropy function expressed in bits, which admits an inverse $h^{-1}:[0,1] \mapsto\left[0, \frac{1}{2}\right]$ when we restrict $x$ to be in $\left[0, \frac{1}{2}\right]$.
Proposition 1.1 (Properties of Bhattacharyya parameter) Let $(X, Y) \simeq P_{X, Y}$ be an arbitrary pair of random variables over $\mathcal{B} \times \mathcal{Y}$ with $\mathcal{B}=\{0,1\}$ and $\mathcal{Y}$ an arbitrary countable set. For any memoryless source $S=(X, Y) \simeq P_{X, Y}$, with $X$ as the part to be compressed and $Y$ in the role of "side-information" about $X$, we have

$$
\begin{gather*}
Z(S)^{2} \leq H(S) \leq \log (1+Z(S))  \tag{12}\\
Z\left(S^{+}\right)=Z(S)^{2} \quad \text { and } \quad \sqrt{2 Z(S)^{2}-Z(S)^{4}} \leq Z\left(S^{-}\right) \leq 2 Z(S) \tag{13}
\end{gather*}
$$

The proof of the left inequality in (13) can be found in the paper ${ }^{1}$ by Chou et al. and the proofs of Proposition 1.1 and Theorem 1.2 can be find in the paper by Şaşoğlu ${ }^{2}$.

Theorem 1.2 (Şaşoğlu) Let $\left(X_{1}, Y_{1}\right)$ and $\left(X_{2}, Y_{2}\right)$ be independent pairs of discrete random variables taking their values in $\mathcal{B} \times \mathcal{Y}_{1}$ and respectively in $\mathcal{B} \times \mathcal{Y}_{2}$ with $\mathcal{B}=\{0,1\}$, and let $\mathbb{H}\left(X_{1} \mid Y_{1}\right)=\alpha$ and $\mathbb{H}\left(X_{2} \mid Y_{2}\right)=\beta$. Then, the conditional entropy $\mathbb{H}\left(X_{1} \oplus X_{2} \mid Y_{1}, Y_{2}\right)$ is minimized when $\mathbb{H}\left(X_{1} \mid Y_{1}=y_{1}\right)=\alpha$ and $\mathbb{H}\left(X_{2} \mid Y_{2}=y_{2}\right)=\beta$ for all $\left(y_{1}, y_{2}\right) \in \mathcal{Y}_{1} \times \mathcal{Y}_{2}$ such that $P_{Y_{1}}\left(y_{1}\right) P_{Y_{2}}\left(y_{2}\right)>0$. Moreover, if $\beta=\alpha=h(x)$ with $x \in\left[0, \frac{1}{2}\right]$ and if $0<\alpha<1$, then

$$
\begin{equation*}
\min \left(\mathbb{H}\left(X_{1} \oplus X_{2} \mid Y_{1}, Y_{2}\right)-\mathbb{H}\left(X_{1} \mid Y_{1}\right)\right)=h(2 x(1-x))-h(x)>0 \tag{14}
\end{equation*}
$$

where the minimum in (14) is taken on the set $\left\{P_{X_{1} Y_{1}}, P_{X_{2} Y_{2}}: \mathbb{H}\left(X_{1} \mid Y_{1}\right)=\mathbb{H}\left(X_{2} \mid Y_{2}\right)=\alpha\right\}$.
Finally, let us introduce

$$
\begin{equation*}
Z^{\prime}(S)=1-Z(S)^{2} . \tag{15}
\end{equation*}
$$

The next proposition results straightforwardly from Proposition 1.1 and definition (15).
Proposition 1.3 For any memoryless source $S$ with binary part to be compressed and discret "side-information", we have

$$
\begin{equation*}
Z^{\prime}\left(S^{+}\right)=2 Z^{\prime}(S)-Z^{\prime}(S)^{2} \text { and } Z^{\prime}\left(S^{-}\right) \leq Z^{\prime}(S)^{2} \tag{16}
\end{equation*}
$$

## 2 Rough polarization

The following corollaries and theorems are adaptations to source polarization of results given by Guruswami and Xia ${ }^{3}$ for channel polarization.

Corollary 2.1 (Guruswami \& Xia) There exists a constant $\theta_{0}$ with $0.799<\theta_{0}<0.8$ such that for any memoryless source $S$ with binary-part to compress and discrete side-information,

$$
\begin{equation*}
H\left(S^{-}\right)-H(S)=H(S)-H\left(S^{+}\right) \geq \theta_{0} H(S)(1-H(S)) \tag{17}
\end{equation*}
$$

[^0]Proof. We write $S=\left\{\left(X_{i}, Y_{i}\right): i \in \mathbb{N}^{*}\right\}$, a sequence of independent drawings from $(X, Y) \simeq$ $P_{X, Y}$, as in Section 1. According to the definitions of $H\left(S^{-}\right)$and $H(S)$, we have

$$
\begin{equation*}
H\left(S^{-}\right)-H(S)=H\left(X_{1} \oplus X_{2} \mid Y_{1}, Y_{2}\right)-H\left(X_{1} \mid Y_{1}\right) \tag{18}
\end{equation*}
$$

Using the entropy function $h$ defined in equation (11) and setting $H\left(X_{1} \mid Y_{1}\right)=H\left(X_{2} \mid Y_{2}\right)=$ $h(x)$, with $x \in\left[0, \frac{1}{2}\right]$, it results from Theorem 1.2 that

$$
\begin{equation*}
H\left(S^{-}\right)-H(S) \geq h(2 x(1-x))-h(x) \tag{19}
\end{equation*}
$$

Therefore

$$
\begin{equation*}
\frac{H\left(S^{-}\right)-H(S)}{H(S)(1-H(S))} \geq \frac{h(2 x(1-x))-h(x)}{h(x)(1-h(x))} \geq \min _{x \in\left[0, \frac{1}{2}\right]} \frac{h(2 x(1-x))-h(x)}{h(x)(1-h(x))}=\theta_{0} \tag{20}
\end{equation*}
$$

and numerical simulations give $0.799<\theta_{0}<0.8$. In order to end the proof, let us remark that the transformation $\left(X_{1}, X_{2}\right) \mapsto\left(X_{1} \oplus X_{2}, X_{2}\right)$ is invertible, hence $H\left(S^{+}\right)+H\left(S^{-}\right)=2 H(S)$, i.e., $H(S)-H\left(S^{+}\right)=H\left(S^{-}\right)-H(S)$.

Remark 2.1 It results from Theorem 1.2 and its proof that for any $x \in\left[0, \frac{1}{2}\right]$, the inequality (19) can be an equality, hence the constant $\theta_{0}$ is the greatest value $\theta \in \mathbb{R}$ such that $H\left(S^{-}\right)-H(S) \geq \theta H(S)(1-H(S))$ for any memoryless source $S$ with binary-part to compress and discrete side-information.

Lemma 2.2 The function

$$
\begin{align*}
g:[0,1] & \rightarrow\left[0, \frac{1}{2}\right] \\
\eta & \mapsto \sqrt{\eta(1-\eta)} \tag{21}
\end{align*}
$$

is strictly concave and for any $\eta \in] 0,1[$, the function

$$
\begin{align*}
G_{\eta}:[0, \min (\eta, 1-\eta)] & \rightarrow[0,1] \\
\delta & \mapsto \frac{g(\eta+\delta)+g(\eta-\delta)}{2 g(\eta)} \tag{22}
\end{align*}
$$

is strictly decreasing.
Proof. The functions $g$ and $G_{\eta}$ are well defined for any $\left.\eta \in\right] 0,1[$. Moreover, the two first derivatives of $g$ are

$$
\begin{equation*}
g^{\prime}(\eta)=\frac{1-2 \eta}{2 g(\eta)} \quad \text { and } \quad g^{\prime \prime}(\eta)=\frac{-1}{g(\eta)}\left[1+\frac{(1-2 \eta)^{2}}{4 \eta(1-\eta)}\right]<0 \tag{23}
\end{equation*}
$$

hence $g$ is strictly concave and finally for any $\eta \in] 0,1[$ and $\delta \in[0, \min (\eta, 1-\eta)]$

$$
\begin{equation*}
G_{\eta}^{\prime}(\delta)=\frac{g^{\prime}(\eta+\delta)-g^{\prime}(\eta-\delta)}{2 g(\eta)} \leq 0 \tag{24}
\end{equation*}
$$

with equality if and only if $\delta=0$, which completes the proof.
Theorem 2.3 (Guruswami \& Xia) Let $g$ be the function defined in (21). There exists a constant $\Lambda<1$, with $0.9165<\Lambda<0.9166$, such that for any memoryless source $S$ with binary-part to compress and discrete side-information

$$
\begin{equation*}
\frac{1}{2}\left[g\left(H\left(S^{-}\right)\right)+g\left(H\left(S^{+}\right)\right)\right] \leq \Lambda g(H(S)) \tag{25}
\end{equation*}
$$

Proof. For a memoryless source $S$ with binary-part to compress and discrete side-information, let $\eta=H(S), \varepsilon_{0}(\eta)=\theta_{0} \eta(1-\eta)$, where $\theta_{0}$ has been introduced in Corollary 2.1 and $\varepsilon=$ $H\left(S^{-}\right)-H(S)=H(S)-H\left(S^{+}\right)$. It results from Corollary 2.1 that $\varepsilon \geq \varepsilon_{0}(\eta)$, which implies, according to Lemma 2.2, that

$$
\begin{align*}
\frac{g\left(H\left(S^{-}\right)\right)+g\left(H\left(S^{+}\right)\right)}{2 g(H(S))} & =\frac{g(\eta+\varepsilon)+g(\eta-\varepsilon)}{2 g(\eta)} \\
& \leq \frac{g\left(\eta+\varepsilon_{0}(\eta)\right)+g\left(\eta-\varepsilon_{0}(\eta)\right)}{2 g(\eta)} \\
& =\frac{1}{2}\left(\sqrt{A_{\theta_{0}}(\eta)}+\sqrt{A_{\theta_{0}}(1-\eta)}\right) \tag{26}
\end{align*}
$$

with $A_{\theta_{0}}(\eta)=\left[1+\theta_{0}(1-\eta)\right]\left(1-\theta_{0} \eta\right)=\theta_{0}^{2}\left(\eta-\theta_{0}^{-1}\right)\left[\eta-\left(1+\theta_{0}^{-1}\right)\right]$. The two roots of polynomial $A_{\theta_{0}}(\eta)$ are both outside the interval $[0,1]$, therefore the function $\eta \mapsto \sqrt{A_{\theta_{0}}(\eta)}$ is strictly convexe for $\eta \in[0,1]$. As a result, its derivative is injective and the term (26) is maximum for $\eta \in[0,1]$ if and only if

$$
\begin{equation*}
\frac{A_{\theta_{0}}^{\prime}(\eta)}{\sqrt{A_{\theta_{0}}(\eta)}}=\frac{A_{\theta_{0}}^{\prime}(1-\eta)}{\sqrt{A_{\theta_{0}}(1-\eta)}} \tag{27}
\end{equation*}
$$

i.e., if and only if $\eta=\frac{1}{2}$. Hence, it comes

$$
\begin{align*}
\frac{g\left(H\left(S^{-}\right)\right)+g\left(H\left(S^{+}\right)\right)}{2 g(H(S))} & \leq \frac{1}{2} \sqrt{\left[1+\theta_{0}(1-\eta)\right]\left(1-\theta_{0} \eta\right)}+\left.\frac{1}{2} \sqrt{\left[1-\theta_{0}(1-\eta)\right]\left(1+\theta_{0} \eta\right)}\right|_{\eta=\frac{1}{2}} \\
& =\sqrt{1-\frac{\theta_{0}^{2}}{4}}=\Lambda \tag{28}
\end{align*}
$$

Numerical simulations give $0.9165<\Lambda<0.9166$.
A recursive application of Theorem 2.3 gives

$$
\begin{equation*}
\forall \mu \in \mathbb{N}, \quad \frac{1}{2^{\mu}} \sum_{i=0}^{2^{\mu}-1} g\left[H\left(S_{\mu}^{(i)}\right)\right] \leq \Lambda^{\mu} g[H(S)] \leq \Lambda^{\mu} \max _{\eta \in[0,1]} g(\eta)=\frac{1}{2} \Lambda^{\mu} . \tag{29}
\end{equation*}
$$

This last equation can be interpreted as

$$
\begin{equation*}
\mathrm{E}\left\{g\left[H\left(S_{\mu}^{(J)}\right)\right]\right\} \leq \frac{1}{2} \Lambda^{\mu} \tag{30}
\end{equation*}
$$

where $J$ is a uniform random variable over $\llbracket 0,2^{\mu}-1 \rrbracket$. Hence, the next corollary results from Markov's inequality.

Corollary 2.4 (Guruswami \& Xia) For any memoryless source $S$, with binary-part to compress and discrete side-information, and the associated sequence introduced in equation (4), for any $\mu \in \mathbb{N}$, if $J$ is a uniform random variable over $\llbracket 0,2^{\mu}-1 \rrbracket$, then

$$
\begin{equation*}
\forall \theta>0, \quad \mathbb{P}\left(g^{2}\left[H\left(S_{\mu}^{(J)}\right)\right] \geq \theta\right) \leq \frac{\Lambda^{\mu}}{2 \sqrt{\theta}} \tag{31}
\end{equation*}
$$

We conclude this section by proving an adaptation to source polarization of the Guruswami and Xia rough (channel) polarization theorem. For any $\left.\theta \in] 0, \frac{1}{2}\right]$, let

$$
\begin{equation*}
x_{1}=x_{1}(\theta)=\frac{1-\sqrt{1-2 \theta}}{2} \quad \text { and } \quad x_{2}=x_{2}(\theta)=\frac{1+\sqrt{1-2 \theta}}{2}=1-x_{1} \tag{32}
\end{equation*}
$$

be the solutions of $x(1-x)=\frac{\theta}{2}$. We have $0 \leq x_{1} \leq \frac{1}{2} \leq x_{2} \leq 1$ and

$$
\begin{equation*}
\left\{x \in[0,1]: x(1-x) \geq \frac{\theta}{2}\right\}=\left[x_{1}(\theta), x_{2}(\theta)\right] \tag{33}
\end{equation*}
$$

Moreover, $0 \leq 1-2 \theta \leq \sqrt{1-2 \theta} \leq 1$ implies $x_{1}(\theta) \leq \theta$. Hence, for any $m \in \mathbb{D}\left(m=2^{\mu}\right)$, for any $\theta \in] 0, \frac{1}{2}[$ and for any memoryless source $S$ with binary-part to compress and discret side-information, we have

$$
\begin{align*}
\left\{i \in \llbracket 0, m-1 \rrbracket: g^{2}\left[H\left(S_{\mu}^{(i)}\right)\right]<\frac{\theta}{2}\right\} & =\left\{i \in \llbracket 0, m-1 \rrbracket: H\left(S_{\mu}^{(i)}\right) \in\left[0, x_{1}[\cup] x_{2}, 1\right]\right\} \\
& \subset \mathcal{V}_{X \mid Y}\left(x_{1}\right) \cup \mathcal{H}_{X \mid Y}^{c}\left(x_{1}\right) \tag{34}
\end{align*}
$$

and the following partition of $\llbracket 0, m-1 \rrbracket$ :

$$
\begin{equation*}
\llbracket 0, m-1 \rrbracket=\mathcal{V}_{X \mid Y}\left(x_{1}\right) \cup \mathcal{H}_{X \mid Y}^{c}\left(x_{1}\right) \cup\left[\mathcal{V}_{X \mid Y}^{c}\left(x_{1}\right) \cap \mathcal{H}_{X \mid Y}\left(x_{1}\right)\right], \tag{35}
\end{equation*}
$$

implies, by setting $A=\mathcal{V}_{X \mid Y}\left(x_{1}\right), B=\mathcal{H}_{X \mid Y}^{c}\left(x_{1}\right)$ and $C=\mathcal{V}_{X \mid Y}^{c}\left(x_{1}\right) \cap \mathcal{H}_{X \mid Y}\left(x_{1}\right)$,

$$
\begin{align*}
1-H(S) & =1-\frac{1}{m} \sum_{i=0}^{m-1} H\left(S_{\mu}^{(i)}\right) \\
& =\frac{1}{m}\left[\sum_{i \in A}\left(1-H\left(S_{\mu}^{(i)}\right)\right)+\sum_{i \in B}\left(1-H\left(S_{\mu}^{(i)}\right)\right)+\sum_{i \in C}\left(1-H\left(S_{\mu}^{(i)}\right)\right)\right]  \tag{36}\\
& \leq \frac{|A|}{m}\left(1-\min \left\{H\left(S_{\mu}^{(i)}\right): i \in \mathcal{V}_{X \mid Y}\left(x_{1}\right)\right\}\right)+\frac{|B|+|C|}{m}  \tag{37}\\
& \leq x_{1}(\theta)+\frac{|B|+|C|}{m} \leq \theta+\frac{|B|}{m}+\mathbb{P}(J \in C), \tag{38}
\end{align*}
$$

where $J$ is a random variable uniformly distributed over $\llbracket 0, m-1 \rrbracket$. Now, the contraposition of (34) gives

$$
\begin{equation*}
C \subset\left\{i \in \llbracket 0, m-1 \rrbracket: g^{2}\left[H\left(S_{\mu}^{(i)}\right)\right] \geq \frac{\theta}{2}\right\} \tag{39}
\end{equation*}
$$

hence it results from Corollary 2.4 that

$$
\begin{equation*}
\mathbb{P}(J \in C) \leq \frac{\Lambda^{\mu}}{2 \sqrt{\theta / 2}} \tag{40}
\end{equation*}
$$

and this implies, with inequality (38) where $\frac{|B|}{m}=\mathbb{P}\left(J \in \mathcal{H}_{X \mid Y}^{c}\left(x_{1}\right)\right)$, that

$$
\begin{equation*}
\mathbb{P}\left(J \in \mathcal{H}_{X \mid Y}^{c}\left(x_{1}\right)\right) \geq 1-H(S)-\theta-\frac{\Lambda^{\mu}}{2 \sqrt{\theta / 2}} \tag{41}
\end{equation*}
$$

Proposition 2.5 There exists $\Lambda \in] 0,1[$ such that for any $\left.\theta \in] 0, \frac{1}{2}\right]$, for any memoryless source $S$ with binary-part to compress and discrete side-information, for any $m \in \mathbb{D}\left(m=2^{\mu}\right)$, the subsets defined in equations (8-9) satisfy

$$
\begin{align*}
\frac{\left|\mathcal{H}_{X \mid Y}(\theta) \cap \mathcal{V}_{X \mid Y}^{c}(\theta)\right|}{m} & \leq \frac{\sqrt{2} \Lambda^{\mu}}{2 \sqrt{\theta}}  \tag{42}\\
H(S)-\theta \leq \frac{\left|\mathcal{H}_{X \mid Y}(\theta)\right|}{m} & \leq H(S)+\theta+\frac{\sqrt{2} \Lambda^{\mu}}{2 \sqrt{\theta}}  \tag{43}\\
H(S)-\theta-\frac{\sqrt{2} \Lambda^{\mu}}{2 \sqrt{\theta}} \leq \frac{\left|\mathcal{V}_{X \mid Y}(\theta)\right|}{m} & \leq H(S)+\theta . \tag{44}
\end{align*}
$$

Proof. Since $x_{1}=x_{1}(\theta) \leq \theta$, we have $\mathcal{H}_{X \mid Y}^{c}\left(x_{1}\right) \subset \mathcal{H}_{X \mid Y}^{c}(\theta)$ and $\mathcal{V}_{X \mid Y}\left(x_{1}\right) \subset \mathcal{V}_{X \mid Y}(\theta)$. Therefore: firstly $\mathcal{H}_{X \mid Y}(\theta) \cap \mathcal{V}_{X \mid Y}^{c}(\theta) \subset \mathcal{H}_{X \mid Y}\left(x_{1}\right) \cap \mathcal{V}_{X \mid Y}^{c}\left(x_{1}\right)$ and inequality (42) results from (40);
secondly $\left|\mathcal{H}_{X \mid Y}^{c}\left(x_{1}\right)\right| \leq\left|\mathcal{H}_{X \mid Y}^{c}(\theta)\right|$ and the right inequality in (43) comes directly from (41). Furthermore, the conditions $\max _{i \in \mathcal{H}_{X \mid Y}^{c}(\theta)} H\left(S_{\mu}^{(i)}\right) \leq \theta$ and $\max _{i \in \mathcal{H}_{X \mid Y}(\theta)} H\left(S_{\mu}^{(i)}\right) \leq 1$ give

\begin{equation*}
H(S)=\frac{1}{m} \sum_{i=0}^{m-1} H\left(S_{\mu}^{(i)}\right) \leq \theta \mathbb{P}\left[J \in \mathcal{H}_{X \mid Y}^{c}(\theta)\right]+\mathbb{P}\left[J \in \mathcal{H}_{X \mid Y}(\theta)\right] \leq \theta+\frac{\left|\mathcal{H}_{X \mid Y}(\theta)\right|}{m} \tag{45}
\end{equation*}
$$

which proves the left inequality in (43). Similarly, condition $\min _{i \in \mathcal{V}_{X \mid Y}(\theta)} H\left(S_{\mu}^{(i)}\right) \geq 1-\theta$ implies

\begin{equation*}
H(S) \geq(1-\theta) \mathbb{P}\left[J \in \mathcal{V}_{X \mid Y}(\theta)\right] \geq \frac{\left|\mathcal{V}_{X \mid Y}(\theta)\right|}{m}-\theta \tag{46}
\end{equation*}
$$

which proves the right inequality in (44). Finally, note that $\mathcal{V}_{X \mid Y}(\theta) \subset \mathcal{H}_{X \mid Y}(\theta)$ implies $\mathcal{V}_{X \mid Y}(\theta)=\mathcal{H}_{X \mid Y}(\theta) \backslash\left[\mathcal{H}_{X \mid Y}(\theta) \cap \mathcal{V}_{X \mid Y}^{c}(\theta)\right]$, so the left inequality in (44) results from (42-43). $\diamond$

Let us now consider $\rho \in] 0,1\left[\right.$ and $\mu \in \mathbb{N}^{*}$ such that $4 \rho^{2 \mu}<\frac{1}{2}$, i.e., $\mu>\frac{3}{2 \log (1 / \rho)}$. For any memoryless source $S$ with binary-part to compress and discrete side-information, since according to Proposition 1.1 for all $i \in \llbracket 0,2^{\mu}-1 \rrbracket, Z\left(S_{\mu}^{(i)}\right) \leq \sqrt{H\left(S_{\mu}^{(i)}\right)}$, we have

\left\{i \in \llbracket 0,2^{\mu}-1 \rrbracket: H\left(S_{\mu}^{(i)}\right) \leq 4 \rho^{2 \mu}\right\} & \subset\left\{i \in \llbracket 0,2^{\mu}-1 \rrbracket: Z\left(S_{\mu}^{(i)}\right) \leq 2 \rho^{\mu}\right\}  \tag{47}\\
\left\{i \in \llbracket 0,2^{\mu}-1 \rrbracket: H\left(S_{\mu}^{(i)}\right) \leq x_{1}\left(4 \rho^{2 \mu}\right)\right\} & \subset\left\{i \in \llbracket 0,2^{\mu}-1 \rrbracket: H\left(S_{\mu}^{(i)}\right) \leq 4 \rho^{2 \mu}\right\} \tag{48}
\end{align*}
$$

therefore with $\theta=4 \rho^{2 \mu}$ in (41), we obtain the following Proposition.
Proposition 2.6 With the notations introduced in this subsection, for any $\rho \in] 0,1[$, for any integer $\mu>\frac{3}{2 \log (1 / \rho)}$ we have

\mathbb{P}\left(Z\left(S_{\mu}^{(J)}\right) \leq 2 \rho^{\mu}\right) \geq 1-H(S)-4 \rho^{2 \mu}-\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\mu} \tag{49}
\end{equation*}
$$

where $J$ is a random variable uniformly distributed over $\llbracket 0,2^{\mu}-1 \rrbracket$.
Let us remark that

\begin{equation*}
\forall \theta \in\left[0, \frac{\sqrt{5}-1}{2}\left[, \quad \sqrt{1-\theta} \leq 1-\theta^{2}\right.\right. \tag{50}
\end{equation*}
$$

and for any $\rho \in] 0,1[$, for any $\mu \in \mathbb{N}$ such that

$$
\begin{equation*}
\mu>\frac{2-\log (\sqrt{5}-1)}{\log (1 / \rho)} \simeq \frac{1.69}{\log (1 / \rho)} \quad \text { i.e., } \quad 2 \rho^{\mu}<\frac{\sqrt{5}-1}{2} \tag{51}
\end{equation*}
$$

we have

$$
\begin{equation*}
\log \left(\frac{1}{1-2 \rho^{2 \mu}}\right)<\frac{1}{2} \quad \text { i.e., } \quad \mu>\left[\frac{3}{4}-\frac{\log (\sqrt{2}-1)}{2}\right] \frac{1}{\log (1 / \rho)} \simeq \frac{1.38}{\log (1 / \rho)} \tag{52}
\end{equation*}
$$

and it results from the right inequality in (12) that

\left(H(S)>\log \left(2-4 \rho^{2 \mu}\right)\right) \Rightarrow\left(1+Z(S)>2-4 \rho^{2 \mu}\right) \tag{53}
\end{equation*}
$$

Now, $\log \left(2-4 \rho^{2 \mu}\right)=1-\log \left[\left(1-2 \rho^{2 \mu}\right)^{-1}\right]$, moreover $1+Z(S)>2-4 \rho^{2 \mu}$ if and only if $Z(S)>1-4 \rho^{2 \mu}$ and $1-4 \rho^{2 \mu} \geq \sqrt{1-2 \rho^{\mu}}$ according to (50-51), hence

\left(H(S)>1-\log \left[\frac{1}{1-2 \rho^{2 \mu}}\right]\right) \Rightarrow\left(Z(S)>\sqrt{1-2 \rho^{\mu}}\right) \quad \text { i.e., } \quad Z^{\prime}(S)=1-Z(S)^{2}<2 \rho^{\mu} \tag{54}
\end{equation*}
$$

Finally,

$$
\begin{equation*}
1-\log \left[\frac{1}{1-2 \rho^{2 \mu}}\right]=1+\frac{\ln \left(1-2 \rho^{2 \mu}\right)}{\ln 2} \leq 1-\frac{2 \rho^{2 \mu}}{\ln 2} \tag{55}
\end{equation*}
$$

Therefore the next proposition results from the left inequality in (44).

Proposition 2.7 With the notations introduced in this subsection, for any $\rho \in] 0,1[$, for any integer $\mu>\frac{2-\log (\sqrt{5}-1)}{\log (1 / \rho)}$ we have

\begin{equation*}
\mathbb{P}\left(Z^{\prime}\left(S_{\mu}^{(J)}\right)<2 \rho^{\mu}\right) \geq H(S)-\frac{2}{\ln 2} \rho^{2 \mu}-\frac{\sqrt{\ln 2}}{2}\left(\frac{\Lambda}{\rho}\right)^{\mu} \tag{56}
\end{equation*}
$$

where $J$ is a random variable uniformly distributed over $\llbracket 0,2^{\mu}-1 \rrbracket$.

We add this paragraph to prove the Rough polarization theorem.
Let $\rho \in] \Lambda, 1[$ and $\varepsilon \in] 0, \frac{1}{2}[$; let

and let $\mu \in \mathbb{N}$ such that $\mu>b_{\rho} \ln (1 / \varepsilon)$. Then, we have $\frac{\ln (1 / \varepsilon)-(\ln 2) / 2}{\ln (\rho / \Lambda)}<\frac{\ln (1 / \varepsilon)}{\ln (\rho / \Lambda)} \leq b_{\rho} \ln (1 / \varepsilon)<\mu$ and $\frac{\ln (1 / \varepsilon)+3 \ln 2}{2 \ln (1 / \rho)} \leq \frac{4 \ln (1 / \varepsilon)}{2 \ln (1 / \rho)} \leq b_{\rho} \ln (1 / \varepsilon)<\mu$, which imply

\begin{equation*}
\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\mu}<\frac{\varepsilon}{2} \quad \text { and } \quad 4 \rho^{2 \mu}<\frac{\varepsilon}{2}, \quad \text { hence } \quad 4 \rho^{2 \mu}+\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\mu}<\varepsilon \tag{58}
\end{equation*}
$$

We proved the following theorem by Guruswami and Xia.
Theorem 2.8 (Rough polarization) There exists $\Lambda \in] 0,1[$ such that for any $\rho \in] \Lambda, 1[$, there exists $b_{\rho}>0$ such that for any memoryless source $S$ with binary-part to compress and discrete side-information, for any $\varepsilon \in] 0, \frac{1}{2}\left[\right.$ and for any $\mu \in \mathbb{N}$, such that $\mu>b_{\rho} \ln (1 / \varepsilon)$, there exists a roughly polarized set

$$
\begin{equation*}
\mathcal{S}_{r} \subset\left\{S_{\mu}^{(i)}: 0 \leq i<2^{\mu}\right\} \tag{59}
\end{equation*}
$$

such that for any $M \in \mathcal{S}_{r}, Z(M) \leq 2 \rho^{\mu}$ and $\mathbb{P}\left(S_{\mu}^{(J)} \in \mathcal{S}_{r}\right) \geq 1-H(S)-\varepsilon$, where $J$ is a random variable uniformly distributed over $\llbracket 0,2^{\mu}-1 \rrbracket$.

## 3 Fine polarization

This section is an adaptation of the reasoning given by Guruswami and Xia (see footnote 3) to prove their fine polarization theorem.

### 3.1 Preliminaries

Lemma 3.1 For any $\beta \in] 0, \frac{1}{2}\left[\right.$, the function $\zeta: \mathbb{R}_{+}^{*} \rightarrow \mathbb{R}_{+}$defined by

\zeta(y)=\frac{\lfloor y\rfloor}{2 y}+\frac{2 \beta^{2} y}{\lceil y\rceil}= \begin{cases}\frac{1+4 \beta^{2}}{2} & \text { if } y \in \mathbb{N}^{*}  \tag{60}\\ \frac{q}{2(q+\alpha)}+\frac{2 \beta^{2}(q+\alpha)}{q+1} & \text { if } y=q+\alpha \text { with } q \in \mathbb{N} \text { and } 0<\alpha<1,\end{cases}
$$

satisfies the condition:

$$
\begin{equation*}
\forall y, \quad\left(\lfloor y\rfloor \geq \frac{4 \beta^{2}}{1-4 \beta^{2}} \Rightarrow \min \{\zeta(\lfloor y\rfloor+\alpha): \alpha \in[0,1]\}=\frac{\lfloor y\rfloor}{2(\lfloor y\rfloor+1)}+2 \beta^{2}\right) \tag{61}
\end{equation*}
$$

Proof. For $q \in \mathbb{N}^{*}$, let us introduce the continuously differentiable function of $\alpha$

f_{q}: \mathbb{R}_{+} & \rightarrow \mathbb{R}_{+}^{*} \\
\alpha & \mapsto \frac{q}{2(q+\alpha)}+\frac{2 \beta^{2}(q+\alpha)}{q+1}, \tag{62}

which satisfies $f_{q}(\alpha)=\zeta(q+\alpha)(\forall \alpha \in] 0,1[)$ and

\begin{gather*}
f_{q}(0)=\frac{1}{2}+2 \beta^{2} \frac{q}{q+1}<\frac{1}{2}+2 \beta^{2} \quad \text { and } \quad f_{q}(1)=\frac{q}{2(q+1)}+2 \beta^{2}<\frac{1}{2}+2 \beta^{2},  \tag{63}\\
f_{q}^{\prime}(\alpha)=\frac{2 \beta^{2}}{q+1}-\frac{q}{2(q+\alpha)^{2}} \quad \text { and } \quad f_{q}^{\prime}(\alpha)=0 \Leftrightarrow \alpha=\frac{\sqrt{q(q+1)}}{2 \beta}-q . \tag{64}
\end{gather*}
$$

Let us remark that $\beta \in] 0, \frac{1}{2}\left[\right.$ implies $f_{q}^{\prime}(0)=\frac{-1}{2 q}+\frac{2 \beta^{2}}{q+1}<0$ and the zero of the derivative function is always greater than zero. Moreover, the zero of the derivative function is smaller than 1 if and only if

\frac{q(q+1)}{4 \beta^{2}}<(q+1)^{2} \quad \Leftrightarrow \quad q<\frac{4 \beta^{2}}{1-4 \beta^{2}} \tag{65}
\end{equation*}
$$

Hence, if $\lfloor y\rfloor=q \geq \frac{4 \beta^{2}}{1-4 \beta^{2}}$, then $\min \left\{f_{q}(\alpha): \alpha \in[0,1]\right\}=f_{q}(1)=\frac{\lfloor y\rfloor}{2(\lfloor y\rfloor+1)}+2 \beta^{2}$.
The proofs of the following three lemmas are straightforward.
Lemma 3.2 The function

\zeta: \mathbb{R}_{+} & \rightarrow \mathbb{R}_{-}  \tag{66}\\
y & \mapsto-\alpha_{0} 2^{y}+y
\end{align*} \quad \text { with } \quad \alpha_{0}=\frac{2}{e \ln 2} \simeq 1.06
$$

is maximum at the point $y_{0}=\frac{-\ln \left(\alpha_{0} \ln 2\right)}{\ln 2}=\frac{1}{\ln 2}-1 \simeq 0,44$ and $\zeta\left(y_{0}\right)=-1$.
Lemma 3.3 For any $\beta \in] 0, \frac{1}{2}[$, the function

$$
\begin{align*}
\varphi: \mathbb{R}_{+}^{*} & \rightarrow \mathbb{R}_{+}^{*} \\
y & \mapsto \frac{1-\beta+y^{-1}}{1-2^{-\beta y}} \tag{67}
\end{align*}
$$

is strictly decreasing, $\varphi(1 / \beta)=2$ and $\varphi(y)$ approaches to $1-\beta<1$ when $y$ approaches to infinity. Hence, there exists $c_{\beta}>0$ such that

$$
\begin{equation*}
\forall y,\left(y \geq c_{\beta} \Rightarrow \varphi(y)<1\right) . \tag{68}
\end{equation*}
$$

Lemma 3.4 $\forall \beta \in] 0, \frac{1}{2}\left[, \forall \gamma \in \mathbb{R}_{+}^{*}, \forall \xi>1\right.$ and $\left.\forall \rho \in\right] 0,1[$ the function

\begin{align*}
\psi: \mathbb{R}_{+} & \rightarrow \mathbb{R}_{+}^{*} \\
y & \mapsto \sqrt{e}\left(1+\frac{\gamma \xi}{\log (1 / \rho)}\right) \exp \left[\frac{-(1-2 \beta)^{2} y}{2}\right] \tag{69}
\end{align*}
$$

is strictly decreasing on $\mathbb{R}_{+}, \psi(0)>1$ and $\psi(y)$ approaches to 0 when y approaches to infinity.

### 3.2 Introduction of parameters, constants and notations

Let $\delta \in] 0, \frac{1}{2}[$ and $\beta \in] \delta, \frac{1}{2}\left[\right.$ such that $\gamma=\frac{\delta}{\beta-\delta}$ is a rational number. We put $\gamma=\frac{\gamma_{n}}{\gamma_{d}}$ with $\gamma_{n}$ and $\gamma_{d}$ co-prime integers ( $\gamma$ can take any value in $\mathbb{Q}_{+}^{*}$ ).
Let $\rho \in] \Lambda, 1[, \xi>1$ (the $x$ parameter used by Guruswami and Xia is connected to $\xi$ with the relation $\left.x=\frac{\log (1 / \rho)}{\xi \log (2 / \rho)}\right)$ and

$$
\begin{equation*}
c=\left\lceil\frac{\gamma \xi}{\log (1 / \rho)}\right\rceil . \tag{70}
\end{equation*}
$$

Using the constant $c_{\beta}$ introduced in lemma 3.3, let

$$
\begin{gather*}
c_{\beta}^{\prime}=\left(\frac{\xi}{\log (1 / \rho)}+\frac{1}{\gamma}\right) \max \left\{c_{\beta}, \frac{1}{(1-2 \beta)}\right\},  \tag{71}\\
c_{\delta}=\max \left(\frac{\left(1+\alpha_{0}\right) \xi}{(\xi-1) \log (1 / \rho)}, c_{\beta}^{\prime}\right) . \tag{72}
\end{gather*}
$$

Let $\mu$ be a natural integer multiple of $\gamma_{d}$ such that

\begin{equation*}
\mu>c_{\delta} \tag{73}
\end{equation*}
$$

Finally, let us introduce

\begin{equation*}
\nu=\gamma \mu \quad \text { and } \quad \nu_{0}=(\gamma+1) \mu=\nu+\mu, \tag{74}
\end{equation*}
$$

which are natural integers because $\mu$ is a multiple of $\gamma_{d}$.
For any $j \in \llbracket 1, c \rrbracket$, let us note $I_{j}=\left[\frac{(j-1) \nu}{c}, \frac{j \nu}{c}\left[\cap \mathbb{N}, n_{j}=\left|I_{j}\right|\right.\right.$ and

G_{j}(\nu)=\left\{i=\sum_{k=0}^{\nu-1} b_{k} 2^{k}: \sum_{k \in I_{j}} b_{k} \geq \frac{\beta \nu}{c}\right\}, \quad G_{j}^{\prime}(\nu)=\left\{i=\sum_{k=0}^{\nu-1} b_{k} 2^{k}: \sum_{k \in I_{j}}\left(1-b_{k}\right) \geq \frac{\beta \nu}{c}\right\} \tag{75}
\end{equation*}
$$

where $b_{0}, \ldots, b_{\nu-1}$ are the binary digits of $i$. It comes

\left\lfloor\frac{\nu}{c}\right\rfloor \leq n_{j} \leq\left\lceil\frac{\nu}{c}\right\rceil \quad \text { and } \quad \sum_{j=1}^{c} n_{j}=\nu \tag{76}

Finally, let us put

G(\nu)=\bigcap_{j=1}^{c} G_{j}(\nu) \quad \text { and } \quad G^{\prime}(\nu)=\bigcap_{j=1}^{c} G_{j}^{\prime}(\nu) . \tag{77}

### 3.3 Proof of the fine polarization theorem

Lemma 3.5 (Guruswami \& Xia) With the notations introduced in the previous subsections, if $J_{2}$ is a random variable with uniform distribution over $\llbracket 0,2^{\nu}-1 \rrbracket$, then

Proof. If we write $J_{2}=\sum_{k=0}^{\nu-1} B_{k} 2^{k}$, then the $\nu$ bits $B_{k}$ are independent Bernoulli random variables with parameter $\frac{1}{2}$. If $J_{2}$ takes its values in $G_{j}(\nu)$, we have

\sum_{k \in I_{j}} B_{k}-\frac{n_{j}}{2} \geq-\left(\frac{n_{j}}{2}-\frac{\beta \nu}{c}\right) \tag{80}
\end{equation*}

Moreover

\frac{n_{j}}{2}-\frac{\beta \nu}{c} \geq \frac{1}{2}\left\lfloor\frac{\nu}{c}\right\rfloor-\frac{\beta \nu}{c}>\frac{1}{2}\left(\frac{\nu}{c}-1\right)-\frac{\beta \nu}{c} \tag{81}
\end{equation*}
$$

and since, according to equations (70-74), we have

\frac{\nu}{c} \geq \frac{\gamma \mu}{1+\frac{\gamma \xi}{\log (1 / \rho)}}=\frac{\mu}{\frac{1}{\gamma}+\frac{\xi}{\log (1 / \rho)}}>\frac{1}{(1-2 \beta)} \tag{82}
\end{equation*}
$$

it comes

$$
\begin{equation*}
\frac{1}{2}\left(\frac{\nu}{c}-1\right)-\frac{\beta \nu}{c}=\frac{(1-2 \beta) \nu}{2 c}-\frac{1}{2}>0 \tag{83}
\end{equation*}
$$

It then results from Hoeffding's inequality that

\mathbb{P}\left(J_{2} \in G_{j}(\nu)\right) & =1-\mathbb{P}\left(\sum_{k \in I_{j}} B_{k}-\frac{n_{j}}{2}<-\left(\frac{n_{j}}{2}-\frac{\beta \nu}{c}\right)\right) \\
& \geq 1-\exp \left(-\left(\frac{1}{2}-\frac{\beta \nu}{c n_{j}}\right)^{2} 2 n_{j}\right) \tag{84}
\end{align*}
$$

Now, $\left(\frac{1}{2}-\frac{\beta \nu}{c n_{j}}\right)^{2} 2 n_{j}=\frac{n_{j}}{2}-\frac{2 \beta \nu}{c}+\frac{2 \beta^{2} \nu^{2}}{c^{2} n_{j}}=\frac{\nu}{c}\left(\frac{n_{j}}{2 \frac{\nu}{c}}-2 \beta+\frac{2 \beta^{2} \frac{\nu}{c}}{n_{j}}\right) \geq \frac{\nu}{c}\left(\zeta\left(\frac{\nu}{c}\right)-2 \beta\right)$, where the last inequality comes from (76) and the $\zeta$ function is defined in equation (60). Further it results from condition (82) that ${ }^{4}\left\lfloor\frac{\nu}{c}\right\rfloor \geq \frac{4 \beta^{2}}{1-4 \beta^{2}}$. Therefore $\zeta\left(\frac{\nu}{c}\right) \geq \frac{\left\lfloor\frac{\nu}{c}\right\rfloor}{2\left(\left\lfloor\frac{\nu}{c}\right\rfloor+1\right)}+2 \beta^{2}=\frac{1}{2}+2 \beta^{2}-\frac{1}{2\left(\left\lfloor\frac{\nu}{c}\right\rfloor+1\right)}$, according to Lemma 3.1, and

\begin{equation*}
\left(\frac{1}{2}-\frac{\beta \nu}{c n_{j}}\right)^{2} 2 n_{j} \geq \frac{\nu(1-2 \beta)^{2}}{2 c}-\frac{1}{2} \frac{\frac{\nu}{c}}{\left\lfloor\frac{\nu}{c}\right\rfloor+1} \geq \frac{\nu}{c} \frac{(1-2 \beta)^{2}}{2}-\frac{1}{2} . \tag{85}
\end{equation*}
$$

Hence

\mathbb{P}\left(J_{2} \in G_{j}(\nu)\right) \geq 1-\sqrt{e} \exp \left[\frac{-(1-2 \beta)^{2} \nu}{2 c}\right] \tag{86}

and we obtain

\mathbb{P}\left(J_{2} \notin G(\nu)\right) \leq \sum_{j=1}^{c} P\left(J_{2} \notin G_{j}(\nu)\right) \leq c \sqrt{e} \exp \left[\frac{-(1-2 \beta)^{2} \nu}{2 c}\right] \leq \psi\left(\frac{\nu}{c}\right) \tag{87}
\end{equation*}
$$

(the last inequality resulting from equations (70) and (69)), that proves (78). Finally, the same proof, where $B_{k}$ is replaced with ( $1-B_{k}$ ) in relations (80) and (84) and $G_{j}(\nu)$ is replaced with $G_{j}^{\prime}(\nu)$ leads to (79).

Now for any memoryless source $S$ with binary-part to compress and discrete side-information, it results from Proposition 2.6 (since $\left.{ }^{5} \mu>\frac{3}{2 \log (1 / \rho)}\right)$ that there exists $\mathcal{S}_{r} \subset\left\{S_{\mu}^{(i)}: 0 \leq i<\right.$ $\left.2^{\mu}\right\}$ such that

\end{equation*}

where $J_{1}$ is a random variable uniformly distributed over $\llbracket 0,2^{\mu}-1 \rrbracket$. In a same way, it results from Proposition $2.7\left(\right.$ since $\left.^{6} \mu>\frac{3}{2 \log (1 / \rho)}\right)$ that there exists $\mathcal{S}_{r}^{\prime} \subset\left\{S_{\mu}^{(i)}: 0 \leq i<2^{\mu}\right\}$ such that

\forall M \in \mathcal{S}_{r}^{\prime}, Z^{\prime}(M) \leq 2 \rho^{\mu} \quad \text { and } \quad \mathbb{P}\left(S_{\mu}^{\left(J_{1}\right)} \in \mathcal{S}_{r}^{\prime}\right) \geq H(S)-\frac{2}{\ln 2} \rho^{2 \mu}-\frac{\sqrt{\ln 2}}{2}\left(\frac{\Lambda}{\rho}\right)^{\mu} \tag{89}
\end{equation*}
$$

For any $M \in \mathcal{S}_{r}$, we define the sequence

\tilde{Z}_{k}^{(i)}=\left\{\begin{array}{cl}
\left(\tilde{Z}_{k-1}^{(\lfloor i / 2\rfloor)}\right)^{2} & \text { if } i \text { is odd, }  \tag{90}\\
2 \tilde{Z}_{k-1}^{(i / 2\rfloor)} & \text { if } i \text { is even, }
\end{array} \quad \text { for any } k \in \mathbb{N}^{*}, \text { with } \tilde{Z}_{0}^{(0)}=Z(M)\right.
$$

${ }^{4}$ Indeed, the condition (82) implies

\left\lfloor\frac{\nu}{c}\right\rfloor \geq \frac{\nu}{c}-1>\frac{1}{1-2 \beta}-1=\frac{2 \beta}{1-2 \beta}>\left(\frac{2 \beta}{1-2 \beta}\right)\left(\frac{2 \beta}{1+2 \beta}\right)=\frac{4 \beta^{2}}{1-4 \beta^{2}} .
$$

${ }^{5}$ Indeed, condition (72) implies $\mu>\frac{\left(1+\alpha_{0}\right) \xi}{(\xi-1) \log (1 / \rho)}>\frac{1+\alpha_{0}}{\log (1 / \rho)} \simeq \frac{2.06}{\log (1 / \rho)}>\frac{3}{2 \log (1 / \rho)}$.

Let us note $R(\mu)=\left\{i \in \llbracket 0,2^{\mu}-1 \rrbracket: S_{\mu}^{(i)} \in \mathcal{S}_{r}\right\}$.
In the same way, for any $M^{\prime} \in \mathcal{S}_{r}^{\prime}$, we define the sequence

Let us note $R^{\prime}(\mu)=\left\{i \in \llbracket 0,2^{\mu}-1 \rrbracket: S_{\mu}^{(i)} \in \mathcal{S}_{r}^{\prime}\right\}$.
Lemma 3.6 (Guruswami \& Xia) With the notations introduced in the previous subsection, we have $\log \left(\max \left\{\tilde{Z}_{\nu}^{(i)}: i \in G(\nu)\right\}\right) \leq-2^{\beta \nu}$.
Proof. Let us note for $j \in \llbracket 1, c \rrbracket, \nu_{j}=\sum_{k=1}^{j} n_{k}\left(\right.$ thus $\left.\nu_{c}=\nu\right)$ and

Let us remark first that if $z_{j}$ has been attained by $p$ squarings $\left(0 \leq p \leq n_{j}\right)$ and $n_{j}-p$ doublings from $z_{j-1}$, the maximum value will be obtained by applying first the $n_{j}-p$ doublings followed by the $p$ squarings ${ }^{7}$. Moreover, if $z_{j}<1$, the maximum value will be reached by minimizing the number of squarings ${ }^{8}$.
According to relations (72), (74), (70) and (88), we have $\mu>\frac{\left(1+\alpha_{0}\right) \xi}{(\xi-1) \log (1 / \rho)}, M \in \mathcal{S}_{r}, \frac{\nu}{c} \leq \frac{\mu \log (1 / \rho)}{\xi}$ and

\log Z(M)+\frac{\nu}{c} \leq 1-\mu \log (1 / \rho)(1-1 / \xi) \leq 1-\left(1+\alpha_{0}\right)=-\alpha_{0} \leq-1 \tag{93}
\end{equation*}

Equation (93) shows that $\log Z(M)+n_{1} \leq \log Z(M)+\frac{\nu}{c}+1<0$, hence if one doubles $n_{1}$ times $z_{0}$ one obtains a value that is smaller than 1 . Thus $z_{1}<1$ and since for any $i \in G(\nu)$, the number of squarings is worth at least $\left\lceil\frac{\beta \nu}{c}\right\rceil$, we have

\end{equation*}

according to condition (68) and

\frac{\nu}{c} \geq \frac{\gamma \mu}{1+\frac{\gamma \xi}{\log (1 / \rho)}}=\frac{\mu}{\frac{1}{\gamma}+\frac{\xi}{\log (1 / \rho)}}>c_{\beta} \tag{96}
\end{equation*}
$$

- the last inequality resulting from condition (73) and definitions (71-72) of $c_{\delta}$.

Moreover, according to Lemma 3.3, the $\varphi$ function is greater than $1-\beta$ and it results from (93) and (95) that

where the $\zeta$ function is defined in Lemma 3.2. So $\frac{\nu}{c}+1+\log z_{1}<0$, therefore $z_{2}<1$ and the same reasoning as above leads to

\end{equation*}

which, with (95), leads to

\log z_{2}+(1-\beta) \frac{\nu}{c} \leq \log z_{2}+\frac{\nu}{c} \varphi\left(\frac{\nu}{c}\right) \leq 2^{\frac{2 \beta \nu}{c}}\left(\log z_{0}+\frac{\nu}{c} \varphi\left(\frac{\nu}{c}\right)\right) \tag{100}
\end{equation*}

and according to conditions (93) and (96) and the property (68), it follows that

& <-\alpha_{0} 2^{\frac{2 \beta \nu}{c}}+\frac{\beta \nu}{c}=\zeta\left(\frac{2 \beta \nu}{c}\right)-\frac{\beta \nu}{c} \leq \zeta\left(\frac{2 \beta \nu}{c}\right) \leq-1 \tag{101}
\end{align*}
$$

where the last inequality results from Lemma 3.2. More generally, let us suppose that

Let us recall that $\nu_{0}=\nu+\mu$ and let us summarize the results proved in this section. We expanded $i \in \llbracket 0,2^{\nu_{0}}-1 \rrbracket$ into $i=i_{1}+2^{\mu} i_{2}$, where the binary digits of $i_{2} \in \llbracket 0,2^{\nu}-1 \rrbracket$ and $i_{1} \in \llbracket 0,2^{\mu}-1 \rrbracket$ correspond respectively to the first $\nu$ and last $\mu$ bits of $i$. We proved that if $i_{1} \in R(\mu)$ (i.e., if $S_{\mu}^{\left(i_{1}\right)} \in \mathcal{S}_{r}$ or equivalently if $\left.Z\left(S_{\mu}^{\left(i_{1}\right)}\right)<2 \rho^{\mu}\right)$ and if $i_{2} \in G(\nu)$, then

We also proved that if $i_{1} \in R^{\prime}(\mu)$ (i.e., if $S_{\mu}^{\prime\left(i_{1}\right)} \in \mathcal{S}_{r}^{\prime}$ or equivalently if $\left.Z^{\prime}\left(S_{\mu}^{\left(i_{1}\right)}\right)<2 \rho^{\mu}\right)$ and if $i_{2} \in G^{\prime}(\nu)$, then

Now, according to equations (88) and (78) and assuming $J=J_{1}+2^{\mu} J_{2}$ is a random variable uniformly distributed over $\llbracket 0,2^{\nu_{0}}-1 \rrbracket$, we have

& \geq\left(1-H(S)-4 \rho^{2 \mu}-\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\mu}\right)\left(1-\psi\left(\frac{\nu}{c}\right)\right) \\
& \geq 1-H(S)-4 \rho^{2 \mu}-\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\mu}-\psi\left(\frac{\nu}{c}\right) . \tag{111}
\end{align*}
$$

We deduce that

\mathbb{P}\left(Z\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-2^{\delta \nu_{0}}} \ln 2\right) & \geq \mathbb{P}\left(J_{1} \in R(\mu) \text { and } J_{2} \in G(\nu)\right) \\
& \geq 1-H(S)-4 \rho^{2 \mu}-\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\mu}-\psi\left(\frac{\nu}{c}\right) \tag{112}
\end{align*}
$$

In a same way, we have

$$
\begin{align*}
\mathbb{P}\left(Z^{\prime}\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-2^{\delta \nu_{0}}}\right) & \geq \mathbb{P}\left(J_{1} \in R^{\prime}(\mu) \text { and } J_{2} \in G^{\prime}(\nu)\right) \\
& \geq H(S)-\frac{2}{\ln 2} \rho^{2 \mu}-\frac{\sqrt{\ln 2}}{2}\left(\frac{\Lambda}{\rho}\right)^{\mu}-\psi\left(\frac{\nu}{c}\right) . \tag{113}
\end{align*}
$$

Thus, we proved that for any $\mu$ multiple of $\gamma_{d}: \mu=k \gamma_{d}$ with $k \in \mathbb{N}^{*}$ great enough ( $k>\frac{c_{\delta}}{\gamma_{d}}$ ) or in other words for any sufficiently large $\nu_{0}=\mu(1+\gamma)=k\left(\gamma_{d}+\gamma_{n}\right)$, the relations (109-110) and (112-113) are valid.

Let us consider now $\nu_{0}^{\prime}$ between two successive multiples of $\gamma_{d}+\gamma_{n}$ :

\end{equation*}

then

\gamma \leq \gamma^{\prime}=\gamma+\frac{u}{k \gamma_{d}} \leq \gamma+\frac{u}{\gamma_{d}}<1+2 \gamma \tag{116}
\end{equation*}
$$

Let us remark that if we introduce $\delta^{\prime}$ such that

Thus, by replacing $\gamma$ with $1+2 \gamma$ in the definition of $\psi$ (see (69)), leaving $\gamma$ unchanged in equation (71) and replacing $\gamma$ with $\gamma^{\prime}$ everywhere else, the above reasoning can be remade in order to prove the following proposition.

Proposition 3.9 For any $\delta \in] 0, \frac{1}{2}[$, for any $\beta \in] \delta, \frac{1}{2}[$, for any $\rho \in] 0,1[$, for any $\xi>1$, there exists $C_{\delta, \beta}>0$ and $A_{\delta, \beta}>0$ such that for any memoryless source $S$ with binary-part to compress and discrete side-information and for any integer $\nu_{0}>C_{\delta, \beta}$, we have

\mathbb{P}\left(Z\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-2^{\delta \nu_{0}}} \ln 2\right) \geq 1-H(S)-4 \rho^{2 \mu}-\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\mu}-A_{\delta, \beta} \exp \left(\frac{-(1-2 \beta)^{2} \nu}{2 c}\right),  \tag{,118}\\
\mathbb{P}\left(Z^{\prime}\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-2^{\delta \nu_{0}}}\right) \geq H(S)-\frac{2}{\ln 2} \rho^{2 \mu}-\frac{\sqrt{2}}{2}\left(\frac{\Lambda}{\rho}\right)^{\mu}-A_{\delta, \beta} \exp \left(\frac{-(1-2 \beta)^{2} \nu}{2 c}\right), \tag{119}
\end{gather*}
$$

where $J$ is a random variable uniformly distributed over $\llbracket 0,2^{\nu_{0}}-1 \rrbracket$, $\gamma=\frac{\delta}{\beta-\delta}, \nu_{0}=(\gamma+1) \mu$, $\nu=\gamma \mu$ and $c=\left\lceil\frac{\gamma \xi}{\log (1 / \rho)}\right\rceil$.

Let us denote

\varepsilon=\frac{\mu}{\nu_{0}}=\frac{1}{\gamma+1}=\frac{\beta-\delta}{\beta}, \quad \text { hence } \quad \beta=\frac{\delta}{1-\varepsilon} \quad \text { and } \quad \gamma=\frac{1}{\varepsilon}-1 . \tag{120}
\end{equation*}

Now we can choose $\xi>1$ so that the fraction $\frac{\gamma \xi}{\log (1 / \rho)}$ is an integer (equal to $c$ ), then we have

Proposition 3.10 For any $\delta \in] 0, \frac{1}{2}[$, for any $\rho \in] 0,1[$, for any $\varepsilon \in] 0,1-2 \delta[$, for any $\xi>1$ such that $\frac{(1-\varepsilon) \xi}{\varepsilon \log (1 / \rho)} \in \mathbb{N}^{\star}$, there exists $C_{\delta, \varepsilon}>0$ and $A_{\delta, \varepsilon}>0$ such that for any memoryless source $S$ with binary-part to compress and discrete side-information and for any integer $\nu_{0}>C_{\delta, \varepsilon}$, we have

\begin{align*}
\mathbb{P}\left(Z\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-2^{\delta \nu_{0}}} \ln 2\right) \geq & 1-H(S)-4 \rho^{2 \varepsilon \nu_{0}}-\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\varepsilon \nu_{0}} \\
& -A_{\delta, \varepsilon} \exp \left(\frac{-\left(1-\frac{2 \delta}{1-\varepsilon}\right)^{2} \log (1 / \rho) \varepsilon \nu_{0}}{2 \xi}\right) \\
= & 1-H(S)-4 \rho^{2 \varepsilon \nu_{0}}-\frac{1}{2 \sqrt{2}}\left(\frac{\Lambda}{\rho}\right)^{\varepsilon \nu_{0}}-A_{\delta, \varepsilon}\left[(\rho)^{\left(1-\frac{2 \delta}{1-\varepsilon}\right)^{2} \frac{1}{2 \xi \ln 2}}\right]^{\varepsilon \nu \nu_{0}}(1  \tag{122}\\
\mathbb{P}\left(Z^{\prime}\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-2^{\delta \nu_{0}}}\right) \geq & H(S)-\frac{2}{\ln 2} \rho^{2 \varepsilon \nu_{0}}-\frac{\sqrt{\ln 2}}{2}\left(\frac{\Lambda}{\rho}\right)^{\varepsilon \nu_{0}}-A_{\delta, \varepsilon}\left[(\rho)^{\left(1-\frac{2 \delta}{1-\varepsilon}\right)^{2} \frac{1}{2 \xi \ln 2}}\right]_{,}^{\varepsilon \nu \nu_{0}}(1 \tag{123}
\end{align*}
$$

where $J$ is a random variable uniformly distributed over $\llbracket 0,2^{\nu_{0}}-1 \rrbracket$. Moreover we can choose

$$
\begin{equation*}
A_{\delta, \varepsilon}=\sqrt{e}\left(1+\frac{(2-\varepsilon) \xi}{\varepsilon \log (1 / \rho)}\right) . \tag{124}
\end{equation*}
$$

Let us put $n=2^{\nu_{0}}$. Equation (122) can be written

\mathbb{P}\left(Z\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-n^{\delta}} \ln 2\right) \geq 1-H(S)-\frac{4}{n^{\kappa_{\epsilon}^{(1)}}}-\frac{1}{2 \sqrt{2} \cdot n^{\kappa_{\epsilon}^{(2)}}}-\frac{A_{\delta, \varepsilon}}{n^{\kappa_{\epsilon}^{(3)}}} \tag{125}
\end{equation*}
$$

with

\begin{align*}
\kappa_{\epsilon}^{(1)} & =2 \varepsilon \log (1 / \rho),  \tag{126}\\
\kappa_{\epsilon}^{(2)} & =\varepsilon \log (\rho / \Lambda)  \tag{127}\\
\kappa_{\epsilon}^{(3)} & =\varepsilon\left(1-\frac{2 \delta}{1-\varepsilon}\right)^{2} \frac{\log (1 / \rho)}{2 \xi \ln 2} . \tag{128}
\end{align*}
$$

In order to shorten the notations, let us put

\alpha=\alpha(\delta, \varepsilon, \rho, \xi)=\left(1-\frac{2 \delta}{1-\varepsilon}\right)^{2} \frac{1}{2 \xi \ln 2} . \tag{129}
\end{equation*}

For fixed $\delta \in] 0, \frac{1}{2}[$, we look for $\varepsilon \in] 0,1-2 \delta[, \rho \in] 0,1[$ and $\xi>1$ that maximize $\kappa_{\epsilon}=\min \left(\kappa_{\epsilon}^{(1)}, \kappa_{\epsilon}^{(2)}, \kappa_{\epsilon}^{(3)}\right)$. Let us remark that

$$
\begin{equation*}
\kappa_{\epsilon}^{(3)}=\varepsilon\left(1-\frac{2 \delta}{1-\varepsilon}\right)^{2} \frac{\log (1 / \rho)}{2 \xi \ln 2}<\frac{\varepsilon \log (1 / \rho)}{2 \ln 2}<2 \varepsilon \log (1 / \rho)=\kappa_{\epsilon}^{(1)}, \tag{130}
\end{equation*}
$$

therefore $\min \left(\kappa_{\epsilon}^{(1)}, \kappa_{\epsilon}^{(2)}, \kappa_{\epsilon}^{(3)}\right)=\min \left(\kappa_{\epsilon}^{(2)}, \kappa_{\epsilon}^{(3)}\right)$. Moreover, we have

\kappa_{\epsilon}^{(2)} \leq \kappa_{\epsilon}^{(3)} \Leftrightarrow \log (\rho / \Lambda) \leq \alpha \log (1 / \rho) \Leftrightarrow \log \rho \leq \frac{\log \Lambda}{1+\alpha} \Leftrightarrow \rho \leq \Lambda^{\frac{1}{1+\alpha}} \tag{131}
\end{equation*}

Firstly, let us suppose that

In this case we have $\min \left(\kappa_{\epsilon}^{(1)}, \kappa_{\epsilon}^{(2)}, \kappa_{\epsilon}^{(3)}\right)=\kappa_{\epsilon}^{(2)}=\varepsilon \log (\rho / \Lambda)$ and this expression is maximum when the independent variables $\rho$ and $\varepsilon$ are maximum, hence for $\rho=\Lambda^{\frac{1}{1+\alpha}}$, which leads to

since $\delta$ is supposed to be fixed. Secondly, if we suppose that

then $\min \left(\kappa_{\epsilon}^{(1)}, \kappa_{\epsilon}^{(2)}, \kappa_{\epsilon}^{(3)}\right)=\kappa_{\epsilon}^{(3)}=\varepsilon \alpha \log (1 / \rho)$ and this quantity is maximum when $\alpha$ is maximum and $\rho$ minimum, i.e., when inequality (134) is an equality, i.e., when (133) is satisfied.

Further, the exponent $\kappa_{\epsilon}^{(2)}=\kappa_{\epsilon}^{(3)}$ in equation (133) is maximum if and only if

\end{equation*}
$$

$g(\varepsilon, \xi)$ is maximum when

$$
\begin{equation*}
\xi=\xi_{\min }>1 \tag{137}
\end{equation*}
$$

and equation (129) implies that

\begin{equation*}
\alpha\left(\varepsilon, \xi_{\min }\right)=\frac{\left(1-\frac{2 \delta}{1-\varepsilon}\right)^{2}}{2 \xi_{\min } \ln 2} \stackrel{\text { def }}{=} \alpha_{\max }(\varepsilon) . \tag{138}
\end{equation*}

Finally, the function to maximize is

\tilde{g}^{\prime}(\varepsilon)=\frac{\alpha_{\max }(\varepsilon)}{1+\alpha_{\max }(\varepsilon)}+\frac{\varepsilon \alpha_{\max }^{\prime}(\varepsilon)}{\left(1+\alpha_{\max }(\varepsilon)\right)^{2}} \tag{140}
\end{equation*}
$$

vanishes if and only if $\alpha_{\max }(\varepsilon)\left(1+\alpha_{\max }(\varepsilon)\right)+\varepsilon \alpha_{\max }^{\prime}(\varepsilon)=0$. We obtain a trivial solution $\varepsilon=1-2 \delta$ (corresponding to a minimum: $\tilde{g}(1-2 \delta)=0$ ) and a third degree algebraic equation in $u$, with $u=1-\varepsilon$ :

\end{array}\right.
$$

The discriminant of $P$ is the resultant $\operatorname{Res}\left(P, P^{\prime}\right)$ between polynomials $P(u)$ and its derivative $P^{\prime}(u)=3 A u^{2}-2 B u-C$ :

\operatorname{Res}\left(P, P^{\prime}\right)= & \left|\begin{array}{ccccc}
A & -B & -C & -D & 0 \\
0 & A & -B & -C & -D \\
0 & 0 & 3 A & -2 B & -C \\
0 & 3 A & -2 B & -C & 0 \\
3 A & -2 B & -C & 0 & 0
\end{array}\right|  \tag{142}\\
= & 256\left(\xi_{\min } \ln 2\right)^{2}\left(2 \xi_{\min } \ln 2+1\right)\left(4 \delta^{2}-4 \delta+2 \xi_{\min } \ln 2+1\right) \delta^{3} \\
& \times\left(8 \xi_{\min } \ln 2-\delta\left(27-2 \xi_{\min } \ln 2\right)\right) . \tag{143}
\end{align*}
$$

The third degree equation $P(u)=0$ admits a multiple root if and only if the resultant $\operatorname{Res}\left(P, P^{\prime}\right)$ vanishes, i.e., if and only if $\delta=0$ or (see Figure 2)

\delta=\delta_{1}\left(\xi_{\min }\right)=\frac{8 \xi_{\min } \ln 2}{27-2 \xi_{\min } \ln 2} \underset{\xi_{\min }=1}{\simeq} 0.21649 \tag{144}

Thus for all $\delta \in] 0, \delta_{1}\left(\xi_{\min }\right)\left[\right.$, the equation $P(u)=0$ admits three real roots, for $\delta>\delta_{1}\left(\xi_{\min }\right)$ the same equation admits only one real root and for $\delta=\delta_{1}\left(\xi_{\min }\right)$, the real root is multiple. Moreover, let us introduce the discriminant of $P^{\prime}(u)$ :

and, for $\delta \in] 0, \frac{1}{2}[$, let

be the real roots of $P^{\prime}(u)$ (see Figure 1). We have $P\left(u_{1}\left(\delta_{1}\left(\xi_{\min }\right)\right)\right)=0$ and $u_{2}\left(\delta_{2}\right)=2 \delta_{2}$ with $\delta_{2}=1 / 5=0.2$.

We show on Figure 2 the graphs of the values of $P(u)$ when $P^{\prime}(u)$ vanishes as functions of $\delta$ for different values of $\xi_{\min }$ and we can see that for all $\left.\delta \in\right] 0, \delta_{1}\left(\xi_{\min }\right)\left[, P\left(u_{1}\right)>0\right.$. Further,

since $P(0)=-D<0(\forall \delta>0)$ and $P(u) \rightarrow-\infty$ when $u \rightarrow-\infty(\forall \delta)$, we deduce that when equation $P(u)=0$ admits three real zeros (i.e., when $0<\delta<\delta_{1}\left(\xi_{\min }\right)$ ), two of the three roots are smaller than zero.

Finally, since polynomial $4 \delta^{2}-4 \delta+2 \xi_{\text {min }} \ln 2+1$ has no real roots, we can remark that

& \left.P(1)=A-B-C-D=(1-2 \delta)\left(4 \delta^{2}-4 \delta+2 \xi_{\min } \ln 2+1\right)>0 \quad \text { for all } \delta \in\right] 0, \frac{1}{2}[(148) \\
& \left.P(2 \delta)=8 A \delta^{3}-4 B \delta^{2}-2 C \delta-D=-16 \xi_{\min }(\ln 2) \delta^{2}(1-2 \delta)<0 \quad \text { for all } \delta \in\right] 0, \frac{1}{2}[(149)
\end{aligned}
$$

Therefore, for all $\delta \in] 0, \frac{1}{2}$, there is always one and only one zero of $P(u)$ with $2 \delta<u<1$. Let us note $\nu_{1}(\delta)$ this root of $P$. All the above mentioned conditions on the real roots $\nu_{i}(\delta)$ $(1 \leq i \leq 3)$ of $P(u)$ can be observed on Figure 3, which has been obtained with numerical simulations.

We show on Figure $4(a)$ the graph of $\tilde{g}\left(1-\nu_{1}(\delta)\right)$ as a function of $\delta$ and $(b)$ the graph of $\tilde{g}(\varepsilon)$ as a function of $\varepsilon$ for various $\delta$. We see that $\tilde{g}$ is maximum for $\lim _{\delta \rightarrow 0^{+}} \tilde{g}\left(1-\nu_{1}(\delta)\right) \underset{\xi_{\min }=1}{\simeq} 0.0046789995$.

Thus, we prove the following Proposition.
Proposition 3.11 For any $\delta \in] 0, \frac{1}{2}[$ and for any $\varepsilon \in] 0,1-2 \delta\left[\right.$, there exists $\kappa_{\delta, \varepsilon}>0$, $A_{\delta, \varepsilon}>0$ and $C_{\delta, \varepsilon}$ such that for any memoryless source $S$ with binary-part to compress and discrete side-information and for any integer $\nu_{0}>C_{\delta, \varepsilon}-$ noting $n=2^{\nu_{0}}-$, we have

$$
\begin{align*}
\mathbb{P}\left(Z\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-n^{\delta}} \ln 2\right) & \geq 1-H(S)-\frac{A_{\delta, \varepsilon}}{n^{\varepsilon \kappa_{\delta, \varepsilon}}}  \tag{150}\\
\mathbb{P}\left(Z^{\prime}\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-n^{\delta}}\right) & \geq H(S)-\frac{A_{\delta, \varepsilon}}{n^{\varepsilon \kappa_{\delta, \varepsilon}}}, \tag{151}
\end{align*}
$$

where $J$ is a random variable uniformly distributed over $\llbracket 0, n-1 \rrbracket$.
Moreover putting $B_{\delta, \varepsilon}=\left[\frac{\left(1-\frac{2 \delta}{1-\varepsilon}\right)^{2}+2 \ln 2}{2 \ln (1 / \Lambda)}\right]$, we can choose $A_{\delta, \varepsilon}$ such that

$$
\begin{equation*}
\sqrt{e}\left(1+\frac{2-\varepsilon}{\varepsilon} B_{\delta, \varepsilon}\right)+\frac{\sqrt{\ln 2}}{2}<A_{\delta, \varepsilon}<\sqrt{e}\left(1+\frac{2-\varepsilon}{\varepsilon} B_{\delta, \varepsilon}\right)+\frac{\sqrt{\ln 2}}{2}+\frac{2}{\ln 2} . \tag{152}
\end{equation*}
$$

Further, for any $\delta \in] 0, \frac{1}{2}[$, for any memoryless source $S$ with binary-part to compress and discret side-information, for any $\nu_{0} \in \mathbb{N}$, let us apply inequality (42) of Proposition 2.5 with

$\mu=\nu_{0}, m=n=2^{\nu_{0}}$ and $\theta=2^{-n^{\delta}}$ (provided that $\theta \leq \frac{1}{2}$ ):

\end{equation*}

We claim that for any $\kappa>0$, for any $\varepsilon>0$, there exists $\theta_{\kappa, \varepsilon}>0$ such that for all $n>\theta_{\kappa, \varepsilon}$

\frac{\sqrt{2} \Lambda^{\nu_{0}}}{2 \sqrt{2^{-n^{\delta}}}} \leq \frac{\theta_{\kappa, \varepsilon}}{n^{\kappa \varepsilon}} \tag{154}
\end{equation*}

Indeed, inequality (154) is equivalent to

\log n(\log \Lambda+\kappa \varepsilon) \leq \log \theta_{\kappa, \varepsilon}+\frac{1}{2}\left(1+n^{\delta}\right) \tag{155}

which is satisfied when $\theta_{\kappa, \varepsilon}$ and $n$ are sufficiently large.
Finally we have

\end{equation*}

\end{equation*}

and with the notations of Proposition 3.11, we have

\mathbb{P}\left(H\left(S_{\nu_{0}}^{(J)}\right)>1-2^{-n^{\delta}}\right) \geq \mathbb{P}\left(Z^{\prime}\left(S_{\nu_{0}}^{(J)}\right) \leq 2^{-n^{\delta}}\right) \geq H(S)-\frac{A_{\delta, \varepsilon}}{n^{\varepsilon \kappa \delta, \varepsilon}} \tag{161}
\end{equation*}
$$

Therefore, applying the left inequality of relation (43) and the right inequality of relation (44) we prove the following proposition.

Proposition 3.12 For any $\delta \in] 0, \frac{1}{2}[$ and for any $\varepsilon \in] 0,1-2 \delta\left[\right.$, there exists $\kappa_{\delta, \varepsilon}>0$, $A_{\delta, \varepsilon}>0$ and $C_{\delta, \varepsilon}$ such that for any memoryless source $S$ with binary-part to compress and discrete side-information and for any integer $\nu_{0}>C_{\delta, \varepsilon}-$ noting $n=2^{\nu_{0}}-$, we have

\begin{align*}
0 & \leq \frac{\left|\mathcal{H}_{X \mid Y}\left(2^{-n^{\delta}}\right) \cap \mathcal{V}_{X \mid Y}^{c}\left(2^{-n^{\delta}}\right)\right|}{n} \leq \frac{A_{\delta, \varepsilon}}{n^{\varepsilon \kappa_{\delta, \varepsilon}}}  \tag{162}\\
H(S)-2^{-n^{\delta}} & \leq \frac{\left|\mathcal{H}_{X \mid Y}\left(2^{-n^{\delta}}\right)\right|}{n} \leq H(S)+\frac{A_{\delta, \varepsilon}}{n^{\varepsilon \kappa_{\delta, \varepsilon}}}  \tag{163}\\
H(S)-\frac{A_{\delta, \varepsilon}}{n^{\varepsilon \kappa_{\delta, \varepsilon}}} & \leq \frac{\left|\mathcal{V}_{X \mid Y}\left(2^{-n^{\delta}}\right)\right|}{n} \leq H(S)+2^{-n^{\delta}} \tag{164}
\end{align*}
$$

where $A_{\delta, \varepsilon}$ satisfies the inequalities (152).

### 3.4 Order of magnitude of constants

In this subsection we study the values of the constants $c_{\beta}$ and $c_{\delta}$ with numerical simulations. Firstly we compute the solution ${ }^{9} \alpha=\alpha(\beta)$ of the equation

$$
\begin{equation*}
\varphi\left(\frac{\log \alpha-\log \beta}{\beta}\right)=1 \quad \Leftrightarrow \quad \frac{\beta}{\alpha}+\frac{\beta}{\log \alpha-\log \beta}=\beta \tag{165}
\end{equation*}
$$

such that

$$
\begin{equation*}
c_{\beta}^{(1)}=\frac{1}{\beta} \log \left(\frac{\alpha(\beta)}{\beta}\right) \tag{166}
\end{equation*}
$$

is the smallest permissible value of $c_{\beta}$ satisfying (68). Moreover we find a simple expression

$$
\begin{equation*}
c_{\beta}^{(2)}=\frac{1}{\beta} \log \left(\frac{1.6 \beta+1.203}{\beta}\right) \tag{167}
\end{equation*}
$$

slightly greater than the smallest value $c_{\beta}^{(1)}$ (see Figures 5-7).

Secondly, we assume that inequality (134) is an equality and replacing $\alpha$ by the expression (129), we obtain

$$
\begin{equation*}
\log (1 / \rho)=\frac{\log (1 / \Lambda)}{1+\alpha}=\frac{2 \xi \ln (1 / \Lambda)}{2 \xi \ln 2+(1-2 \beta)^{2}} \tag{168}
\end{equation*}
$$

and we express $c_{\beta}^{\prime}$ and $c_{\delta}$ introduced in relations $(71,72)$ as functions of $\beta$ and $\xi$.

Let us denote

$$
\begin{equation*}
c_{\delta}^{(1)}=\frac{\left(1+\alpha_{0}\right) \xi}{(\xi-1) \log (1 / \rho)} \tag{169}
\end{equation*}
$$

appearing in the definition (72) of $c_{\delta}$.

$c_{\delta}$ with $\log (1 / \rho)=\frac{\log (1 / \Lambda)}{1+\alpha_{\max }(\beta, \xi)}=\frac{2 \xi \ln (1 / \Lambda)}{2 \xi \ln 2+(1-2 \beta)^{2}}$

In order to have

$$
\begin{equation*}
c \stackrel{\text { def }}{=}\left[\frac{\gamma \xi}{\log (1 / \rho)}\right\rceil=\frac{\gamma \xi}{\log (1 / \rho)} \tag{170}
\end{equation*}
$$

with $\rho$ satisfying equality (168) and $\xi>1$ as small as possible, we set $\xi_{\min }$ as the value of $\xi$ solution of equations (168) and

$$
\begin{equation*}
\frac{(1-\varepsilon) \xi}{\varepsilon \log (1 / \rho)}=\min \left(\mathbb{N}^{*} \cap\left\{\frac{(1-\varepsilon) \xi}{\varepsilon \log (1 / \rho)}: \xi>1\right\}\right) \tag{171}
\end{equation*}
$$
