Local Geometry of Nonconvex Spike Deconvolution from Low-Pass Measurements

Abstract

Spike deconvolution is the problem of recovering the point sources from their convolution with a known point spread function, which plays a fundamental role in many sensing and imaging applications. In this paper, we investigate the local geometry of recovering the parameters of point sources—including both amplitudes and locations—by minimizing a natural nonconvex least-squares loss function measuring the observation residuals. We propose preconditioned variants of gradient descent (GD), where the search direction is scaled via some carefully designed preconditioning matrices. We begin with a simple fixed preconditioner design, which adjusts the learning rates of the locations at a different scale from those of the amplitudes, and show it achieves a linear rate of convergence—in terms of *entrywise* errors—when initialized close to the ground truth, as long as the separation between the true spikes is sufficiently large. However, the convergence rate slows down significantly when the dynamic range of the source amplitudes is large. To bridge this issue, we introduce an adaptive preconditioner design, which compensates for the learning rates of different sources in an iteration-varying manner based on the current estimate. The adaptive design provably leads to an accelerated convergence rate that is independent of the dynamic range, highlighting the benefit of adaptive preconditioning in nonconvex spike deconvolution. Numerical experiments are provided to corroborate the theoretical findings.

1 Introduction

Spike deconvolution, also known as super-resolution [1], is the task of recovering a stream of point sources from their convolution with a point spread function (PSF). This classical problem is at the core of many sensing and imaging modalities, including but not limited to radar, sonar, optical imaging, neuroimaging, and communication systems. The PSF, which models the physical limitations of the imaging device involved in the experimental process, is commonly assumed to act as a band-limited and shift-invariant low-pass filter on the point sources [2, 3]. The sharpness of the original sources, modeled by Dirac impulses, is degraded through the convolution process, introducing undesirable ambiguity on the complex amplitudes and locations of the sources. The spike deconvolution task amounts to inverting the low-passing effects of the PSF, and to recovering the original sources as precisely as possible.

There is a rich literature on algorithmic investigations of the spike deconvolution problem, ranging from classical root-finding methods such as Prony's method, subspace methods such as MUSIC [4, 5], ESPRIT [6] and matrix pencil [7], to more recent optimization methods such as atomic norm minimization (a.k.a. total *variation minimization*) [8, 9, 10, 11, 12] and basis pursuit [13, 14]. While classical approaches harness the algebraic properties of complex exponentials by mapping the observations onto a low-dimensional linear subspace to recover the parameters of interest, optimization methods, on the other hand, attempt to recover the parameters via minimizing some carefully-designed loss function. As such, optimization methods tend to be more versatile in adapting to different imaging modalities, as well as amenable to modern advances in large-scale optimization. Therefore, there has been a surge of interest in developing provably correct convex programs—such as the atomic norm minimization framework mentioned earlier—for spike deconvolution over the continuum in recent years, with strong performance guarantees developed under sufficient separations between the point sources [15, 16, 17, 18]. Nonetheless, the atomic norm framework requires solving a semidefinite program whose complexity scales at least cubically with respect to the signal length; and therefore is computationally expensive and memory inefficient. In addition, although it is in principle possible to examine the so-called dual polynomial to localize the sources [10], it often boils down to an additional post-processing step on the output of the convex program to recover the source parameters, which may hamper the guarantee of the overall procedure.

Motivated by the recent success of nonconvex methods, especially simple first-order methods, in various signal estimation and machine learning tasks [19, 20], we are interested in understanding the efficacy of first-order methods in nonconvex spike deconvolution. In fact, first-order methods have already been popular empirically for spike deconvolution, but little is known about their theoretical underpinnings [21]. As a first step, this paper focuses on the local geometry and performance guarantees of recovering the parameters of

point sources—including both amplitudes and locations—by minimizing a natural nonconvex least-squares loss function measuring the observation residuals.

1.1 Observation model

Formally, we formulate the spike deconvolution problem as follows. Consider a set of 2r parameters $\theta^* = [a_1^*, \ldots, a_r^*, \tau_1^*, \ldots, \tau_r^*],$ where $a_\ell^* \in \mathbb{C}$ and $\tau_\ell^* \in \mathbb{R}$ correspond to the complex amplitude and location of the ℓ -th spike, respectively, $\ell = 1, \ldots, r$. Denoting by M the set of Radon measures over the reals, we assume that the point source signal $\mu^* \in \mathcal{M}$ to resolve is of the form

$$
\mu^* = \mu(\boldsymbol{\theta}^*) = \sum_{\ell=1}^r a_\ell^* \delta_{\tau_\ell^*},\tag{1}
$$

where δ_{τ} stands for the Dirac function located at $\tau \in \mathbb{R}$. Let us further denote the largest and the smallest amplitude of the spikes as

$$
a_{\max}^\star = \max_{1\leq \ell \leq r} |a_\ell^\star| = \|\mathbf{a}^\star\|_\infty\,, \qquad a_{\min}^\star = \min_{1\leq \ell \leq r} |a_\ell^\star|\,.
$$

The dynamic range of the measure μ^* , an important quantity that will be used repetitively later, is thus defined as $a_{\max}^{\star}/a_{\min}^{\star}$. Denoting by $g \in L_1(\mathbb{R})$ the PSF, the temporal signal $x \in L_1(\mathbb{R})$ resulting from the convolution of the point source signal μ^* and the PSF g reads

$$
x(\tau) = (g * \mu^*) (\tau) = \sum_{\ell=1}^r a_\ell^* g(\tau - \tau_\ell^*), \tag{2}
$$

where ∗ denotes the convolution product.

A versatile observation model commonly encountered in practice considers the measurements to be taken from a uniform sampling of the Fourier transform of the temporal signal x. Denote by $\mathcal{F}(\cdot)$ the Fourier transform of a measure μ lying in \mathcal{M} , given by

$$
\mathcal{F}(\mu)(f) = \int_{\mathbb{R}} e^{-i2\pi f \tau} d\mu(\tau), \quad \forall \mu \in \mathcal{M}, \ \forall f \in \mathbb{R}.
$$

Denote by $G = \mathcal{F}(g)$ and $X = \mathcal{F}(x)$ the Fourier transform of g and x, respectively. We assume that the PSF is band-limited within the bandwidth $B = 1$ so that it constraint no frequency greater than $1/2$, *i.e.* $G(f) = 0$ for $|f| > \frac{1}{2}$.¹ For convenience, we assume that an odd number $N = 2n + 1$ of measurements are taken in the Fourier domain, uniformly spaced in the bandwidth $[-\frac{1}{2},\frac{1}{2}]$. The sampled signal $x \in \mathbb{C}^N$ writes

$$
\mathbf{x} = \mathbf{\Phi}(\mu^*)
$$

= diag(**g**) $\left[\mathcal{F}(\mu) \left(-\frac{n}{N} \right), \mathcal{F}(\mu) \left(\frac{-n+1}{N} \right), \dots, \mathcal{F}(\mu) \left(\frac{n}{N} \right) \right]^\top,$ (4)

where $\Phi: \mathcal{M} \to \mathbb{C}^N$ represents the observation operator and $g \in \mathbb{C}^N$ is a vector with generic term $g_k = G\left(\frac{k}{N}\right)$ for $k = -n, \ldots, n$. The goal of spike deconvolution is thus to recover the measure μ^* , or equivalently, the parameter θ^* , from x.

1.2 Our contributions

Assume that the model order r is known, we consider a natural nonconvex loss function, which aims to minimize the quadratic loss of the parameters $\boldsymbol{\theta} = [a_1, \ldots, a_r, \tau_1, \ldots, \tau_r]$ of the Radon measures, given by

$$
\min_{\boldsymbol{\theta}} \mathcal{L}(\boldsymbol{\theta}) = \frac{1}{2} \left\| \boldsymbol{\Phi}(\mu(\boldsymbol{\theta})) - \boldsymbol{x} \right\|_2^2.
$$
 (5)

¹The normalization $B = 1$ is made without loss of generality, up to a rescaling of the source locations τ_{ℓ}^* . Assuming that $\tau_{\ell}^{\star} \in [-\frac{T}{2}, \frac{T}{2}]$, where T is the length of the observation window, the deconvolution problem only depends on the time-bandwidth product $T \cdot B$ [22].

Due to the nonlinear form of the parameters, the loss function $\mathcal{L}(\theta)$ is clearly nonconvex. As a first step towards nonconvex spike deconvolution, we are interested in understanding the local geometry of the loss function (5) and its implications on the computation efficacy of first-order methods. Without loss of generality, we assume that the Fourier transform $G(f)$ of the PSF is a triangular low pass function, *i.e.*

$$
g(\tau) = \frac{\sin^2\left(\frac{\pi\tau}{2}\right)}{\left(\frac{\pi\tau}{2}\right)^2},\tag{6}
$$

so that $g_k = G\left(\frac{k}{N}\right) = \frac{1}{n+1} \left(1 - \frac{|k|}{n+1}\right)$ for all $k = -n, \ldots n$. Note that the triangular low-pass function and the Fejér kernel—its discrete counterpart—play an important role in the deconvolution literature and have been extensively proposed as a convolution kernel to evaluate the norm and distance between Radon measures [10]. Additionally, our main results can be re-derived with any other bandlimited PSF g by following analogous reasoning, as long as q is an *absolutely integrable* function.

Concretely, we propose and analyze preconditioned variants of gradient descent (GD), where the search direction is scaled via some carefully designed preconditioning matrices. Our contributions are summarized as follows.

- We begin with a simple fixed preconditioner design, which adjusts the learning rates of the locations at a different scale from those of the amplitudes, and show it achieves a linear rate of convergence—in terms of entrywise errors—when initialized close to the ground truth, as long as the separation between the true spikes is sufficiently large. However, the convergence rate slows down significantly when the dynamic range of the source amplitudes is large.
- To bridge this issue, we introduce an adaptive preconditioner design, which compensates the learning rates of different sources in an iteration-varying manner based on the current estimate. The adaptive design provably leads to an accelerated convergence rate that is independent of the dynamic range, highlighting the benefit of adaptive preconditioning in nonconvex spike deconvolution.

Our result is based on understanding the geometric properties of scaled Hessian matrices via a set of novel summation bounds on the absolute sums of sampled Fejér kernels and higher-order derivatives, which might be of independent interest in other contexts.

1.3 Related work

The closest work to ours on recovering spike signals from low-pass observations using nonconvex optimization is [23]. The radius of the basin of attraction for gradient descent is characterized whenever the observation operator satisfies the restricted isometry property over the set of well-separated sparse measures. Although the problem setup is versatile, specializing this result in our context of low-pass measurements yields a convergence region whose size scales inversely with the number of sources, which is pessimistic when the number of sources is large. Moreover, the analysis in [23] focuses on the Euclidean error of the parameters, while we focus on the entrywise error, which is more meaningful for gauging the recovery quality of the point sources. Projected gradient methods, which merge pairs of colliding spikes at each iteration, have been proposed in [24, 25] but without theoretical convergence guarantees.

Our work can be viewed as falling into a growing line of research on developing provably efficient nonconvex methods—especially first-order methods—for high-dimensional signal estimation, examples including phase retrieval [26], low-rank matrix estimation [27, 19], blind deconvolution [28], dictionary learning [29], multichannel sparse deconvolution [30, 31], and so on. In particular, the preconditioned gradient methods considered in this paper are motivated by [32, 33], which demonstrated that preconditioning can efficiently accelerate the convergence of gradient descent in ill-conditioned low-rank estimation.

1.4 Notation and paper organization

Vectors and matrices are denoted by boldface and capital boldface letters, respectively. Vectors $\boldsymbol{x} \in \mathbb{C}^N$ with odd dimension $N = 2n + 1$ are indexed between $-n$ and n, so that $\boldsymbol{x} = [x_{-n}, \ldots, x_n]^\top$ for convenience. Transpose and Hermitian transpose of a vector or a matrix A are denoted by A^{\top} and A^{H} , respectively.

Furthermore, the adjoint of the operator Φ is denoted by Φ^* . We write 1_d and 0_d the all-one and null vector (or matrix) in dimension d, respectively. With a slight abuse of notation, we denote by $|a|, |a|^2, a^{-1}$ the vector with entries equal to the modulus, the squared modulus, and the inverse of the entries of a , respectively. The element-wise product between two vectors a and a' is written as $a \odot a'$. We denote by \mathcal{D}_{ℓ} the space of ℓ -times differentiable function of the real variable. For any function $h \in \mathcal{D}_{\ell}$, we write its ℓ th derivative $h^{(\ell)}$. We denote by $\langle \cdot, \cdot \rangle$ and $\langle \cdot, \cdot \rangle_{\mathbb{R}} = \Re(\langle \cdot, \cdot \rangle)$ the usual inner product and real inner product between Radon measure, respectively. Additionally, we let $\delta^{(\ell)} \in \mathcal{M}$ be the functional which satisfies

$$
g^{(\ell)}(\tau) = \left\langle \delta_{\tau}^{(\ell)}, g \right\rangle, \quad \forall g \in \mathcal{D}_{\ell}, \forall \tau \in \mathbb{R}.
$$
 (7)

Fejér kernel We denote by $F_N(\cdot)$ the normalized Fejér kernel of order $N = 2n + 1$ defined by

$$
F_N(t) = \frac{1}{n+1} \sum_{k=-n}^{n} \left(1 - \frac{|k|}{n+1} \right) e^{i2\pi kt} = \begin{cases} \frac{\sin^2(\pi(n+1)t)}{(n+1)^2 \sin^2(\pi t)} & \text{if } t \notin \mathbb{Z} \\ 1 & \text{otherwise.} \end{cases}
$$
(8)

The Fejér kernel is a trigonometric polynomial, hence it is infinitely differentiable. We point out that the second derivative of $F_N(\cdot)$ at the origin satisfies

$$
F_N''(0) = \frac{1}{n+1} \sum_{k=-n}^n -4\pi^2 k^2 \left(1 - \frac{|k|}{n+1}\right) = -\frac{2}{3}\pi^2 n(n+2) < 0. \tag{9}
$$

Some of its properties, key to this paper, are derived and discussed in Appendix A. The Fejér kernel plays an important role in the sequel as the Gramian $\Phi^*\Phi : \mathcal{M} \to \mathcal{M}$ of the observation operator Φ is a convolution product with F_N , *i.e.*

$$
\mathbf{\Phi}^* \mathbf{\Phi}(\mu) = F_N * \mu, \quad \forall \mu \in \mathcal{M}.
$$
\n(10)

Wrap-around distance For any set of r points $\tau = {\tau_1, \ldots, \tau_r} \subset \mathbb{T}$, we denote by $\Delta(\tau)$ is minimal wrap-around distance, defined by

$$
\Delta(\tau) \triangleq \min_{\ell \neq \ell'} \inf_{p \in \mathbb{Z}} |\tau_{\ell} - \tau_{\ell'} + p| \,. \tag{11}
$$

The rest of this paper is organized as follows. Section 2 starts by defining the preconditioned gradient methods and two of its designs with provable local convergence guarantees, using a fixed preconditioner and an adaptive preconditioner in Section 2.2 and Section 2.3, respectively. Section 3 provides the analysis of the main theorems by controlling the conditioning of the scaled Hessian matrix of the loss function in a neighborhood of the ground truth. Numerical experiments are provided in Section 4 to corroborate our findings. Finally, a brief conclusion is drawn in Section 5.

2 How does preconditioning help local convergence?

2.1 Preconditioned gradient descent

Recognizing that the parameters corresponding to the amplitudes and locations may require different treatments, we consider iterates of preconditioned gradient descent (GD) to recover the ground truth parameters, where the preconditioner can possibly be iteration-varying. Given an initialization point $\theta_0 \in \mathbb{C}^{2r}$, the update sequence of preconditioned GD is obtained by successively moving oppositely along the direction of a linear transform of the gradient. More specifically, the update rule reads

$$
\boldsymbol{\theta}_{k+1} = \boldsymbol{\theta}_k - \boldsymbol{P}_k \nabla \mathcal{L}(\boldsymbol{\theta}_k),\tag{12}
$$

where $\boldsymbol{\theta}_k = [\boldsymbol{a}_k^{\top}, \boldsymbol{\tau}_k^{\top}]^{\top}$ is the k-th iterate, $\boldsymbol{P}_k \in \mathbb{C}^{2r \times 2r}$ is a preconditioning matrix (also called preconditioner) that can vary at each iteration; the choice of P_k will be detailed momentarily. Here, it is worth noticing that there are no additional learning rates in (12), which can be thought of as already absorbed and set within the preconditioner P_k . By analogy with the celebrated Newton-Raphson method, which selects

 $P_k = \nabla^2 \mathcal{L}(\theta_k)^{-1}$ (which might however be computationally expensive), the role of the preconditioning matrix P_k is to balance the local optimization landscape towards a quadratic function to improve the convergence rate towards a local minimum over the vanilla gradient method. By basic calculation, the gradient $\nabla \mathcal{L}(\theta)$ at point $\boldsymbol{\theta} = [a_1, \ldots, a_r, \tau_1, \ldots, \tau_r]$ is given by

$$
\frac{d\mathcal{L}(\boldsymbol{\theta})}{da_j} = \langle \boldsymbol{\Phi}(\delta_{\tau_j}), \boldsymbol{\Phi}(\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^*)) \rangle \n= \langle \delta_{\tau_j}, \boldsymbol{\Phi}^* \boldsymbol{\Phi}(\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^*)) \rangle \n= \langle \delta_{\tau_j}, F_N * (\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^*)) \rangle \n= \sum_{\ell=1}^r a_\ell F_N(\tau_j - \tau_\ell) - \sum_{\ell=1}^{r^*} a_\ell^* F_N(\tau_j - \tau_\ell^*), \qquad j = 1, \dots, r,
$$

and similarly,

$$
\frac{d\mathcal{L}(\theta)}{d\tau_j} = \left\langle \Phi(a_j \delta'_{\tau_j}), \Phi(\mu(\theta) - \mu(\theta^*)) \right\rangle_{\mathbb{R}}
$$

= \left\langle a_j \delta'_{\tau_j}, \Phi^* \Phi(\mu(\theta) - \mu(\theta^*)) \right\rangle_{\mathbb{R}}
$$

= \left\langle a_j \delta'_{\tau_j}, F_N * (\mu(\theta) - \mu(\theta^*)) \right\rangle_{\mathbb{R}}

= \Re \left(\overline{a_j} \left(\sum_{\ell=1}^r a_\ell F_N'(\tau_j - \tau_\ell) - \sum_{\ell=1}^r a_\ell^* F_N'(\tau_j - \tau_\ell^*) \right) \right), \qquad j = 1, \dots, r.

In this paper, we are particularly interested in preconditioning matrices P_k that are diagonally structured, so they do not add computation overhead compared with vanilla gradient methods. In the sequel, we study the basin of attraction and the convergence rate of preconditioned GD for two different preconditioning strategies. The first consists of selecting a time-invariant, diagonal preconditioning matrix $P = P_k$ whose role is to judiciously renormalize the learning rates between the amplitudes $a \in \mathbb{C}^r$ and the locations $\tau \in \mathbb{R}^r$ which are of different units. The second strategy seeks to dynamically update the preconditioning matrix P_k based on the current iterate to better approximate the inverse of the Hessian matrix around the point θ_k and accelerate convergence.

2.2 Invariant preconditioning

In this section, we seek to recover the ground truth parameter θ^* from an instance of the preconditioned GD algorithm (12) where the sequence of preconditioning matrices is constant, *i.e.* $P = P_k$ for all $k \in \mathbb{N}$. We fix

$$
\boldsymbol{P} = \text{diag}\left(\begin{bmatrix} \mathbf{1}_r \\ -F_N''(0)^{-1}A^{-2}\mathbf{1}_r \end{bmatrix}\right),\tag{14}
$$

where $A > 0$ is an input parameter that controls the ratio between the learning rate applied to the amplitudes a_k of the sources and that applied to the locations τ_k of the sources throughout the iterative process.

Performance metric To gauge the performance, we define by $S \in \mathbb{C}^{2r \times 2r}$ the weighting matrix

$$
\mathbf{S} = \text{diag}\left(\begin{bmatrix} \mathbf{a}^{\star -1} \\ \sqrt{-F_N''(0)} \mathbf{1}_r \end{bmatrix}\right),\tag{15}
$$

where $F''_N(0)$ is given in (9), and study the convergence properties of preconditioned GD in terms of the infinity norm weighted by the matrix S , *i.e.*

$$
\|\boldsymbol{S}\left(\boldsymbol{\theta}_{k}-\boldsymbol{\theta}^{\star}\right)\|_{\infty}=\max_{j}\left\{\frac{\left|a_{k,j}-a_{j}^{\star}\right|}{\left|a_{j}^{\star}\right|},\sqrt{-F_{N}^{"}(0)}\left|\tau_{k,j}-\tau_{j}^{\star}\right|\right\}.
$$
\n(16)

Intuitively, the role of this scaling is to analyze a unitless metric that decorrelates the error with the dynamic range of the sources and with the problem dimension, as we have $\sqrt{-F_N''(0)} = \mathcal{O}(n)$ and that the error on the source locations is expected to be inversely proportional to the number of observation: $\|\boldsymbol{\tau}_k - \boldsymbol{\tau}^\star\|_{\infty} = \mathcal{O}(n^{-1}).$

The following theorem establishes the linear convergence of preconditioned GD with a fixed preconditioning matrix P whenever the input parameter A is properly set, and the initial point θ_0 is close enough to the ground truth θ^* , as long as the true spikes are sufficiently separated.

Theorem 1 (Linear convergence with invariant preconditioner). Suppose that $n \geq 2$ and that the input parameter A satisfies $\|\boldsymbol{a}^\star\|_{\infty} \leq \frac{3}{2}A$. Moreover, assume that

$$
\eta := 276.21 \frac{A^2 \|\mathbf{a}^*\|_{\infty}}{(a_{\min}^*)^3} \left((n+1) \Delta(\boldsymbol{\tau}^*) \right)^{-2} < 1,\tag{17}
$$

then if the initial point $\boldsymbol{\theta}_0 = [\boldsymbol{a}_0^\top, \boldsymbol{\tau}_0^\top]^\top$ satisfies

$$
\|\boldsymbol{S}\left(\boldsymbol{\theta}_{0}-\boldsymbol{\theta}^{\star}\right)\|_{\infty}\leq\frac{1}{2},\tag{18}
$$

the iterates $\{\theta_k\}$ of preconditioned GD (12) with a fixed preconditioner (14) converge towards θ^* according to

$$
\|\boldsymbol{S}\left(\boldsymbol{\theta}_{k}-\boldsymbol{\theta}^{\star}\right)\|_{\infty} \leq \left(1-\frac{1}{4}\frac{\left(a_{\min}^{\star}\right)^{2}}{A^{2}}\left(1-\eta\right)\right)^{k} \|\boldsymbol{S}\left(\boldsymbol{\theta}_{0}-\boldsymbol{\theta}^{\star}\right)\|_{\infty}, \qquad \forall k \in \mathbb{N}.
$$
 (19)

Theorem 1 indicates that preconditioned GD admits a linear rate of convergence as long as the separation condition $\Delta(\tau^*)$ is sufficiently large with respect to the dynamic range, *i.e.*

$$
(n+1)\,\Delta(\boldsymbol{\tau}^{\star}) \gtrsim \left(\frac{\|\boldsymbol{a}^{\star}\|_{\infty}}{a_{\min}^{\star}}\right)^{3/2}.\tag{20}
$$

Additionally, our finding is independent of the number of sources r of the input measure, both in terms of the size of the basin of attraction (cf. (18)) and the convergence rate. Faster convergence rate are achieved for smaller values of the parameter $0 < \eta < 1$, when the separation $\Delta(\tau^*)$ of the true spikes is larger or the dynamic range $\frac{\|a^*\|_{\infty}}{a_{\min}^*}$ of the amplitudes is smaller. However, even for small values of η , the convergence rate ρ predicted by Theorem 1 is lower bounded by

$$
\rho \ge 1 - \frac{1}{4} \left(\frac{a_{\min}^{\star}}{A} \right)^2 \ge 1 - \frac{9}{16} \left(\frac{a_{\min}^{\star}}{\|\mathbf{a}^{\star}\|_{\infty}} \right)^2.
$$
 (21)

This suggests that a high dynamic range will lead to a slow convergence rate, independently of the separation $\Delta(\tau^*)$. Additionally, the convergence guarantees established in Theorem 1 demand to adjust the input parameter A as a function of $||a^*||_{\infty}$, which can be impractical in scenarios with no postulate on the norm of the source amplitudes.

2.3 Adaptive preconditioning

In order to mitigate the limitations of the fixed preconditioning strategy presented in Section 2.2, we propose to study an instance of preconditioned GD where the preconditioner P_k varies at each iteration and is selected as a function of the current iterate θ_k . In particular, we fix

$$
\boldsymbol{P}_k = \text{diag}\left(\begin{bmatrix} \mathbf{1}_r & \mathbf{1}_{r} \\ -F_N''(0)^{-1} \left| \boldsymbol{a}_k \right|^{-2} \end{bmatrix}\right). \tag{22}
$$

Similar to Theorem 1, the next theorem guarantees a linear convergence rate of the iterates towards the ground truth θ^* , provided a good enough initialization point θ_0 , as long as the true spikes are sufficiently separated.

Theorem 2 (Linear convergence with adaptive preconditioner). Suppose that $n \geq 2$, and assume that

\gamma := 11.60 \frac{\|\boldsymbol{a}\|_{\infty}}{a_{\min}^{\star}} \left((n+1)\Delta(\boldsymbol{\tau}^{\star}) \right)^{-2} < \frac{1}{2},\tag{23}
$$

then if the initial point $\boldsymbol{\theta}_0 = [\boldsymbol{a}_0^\top, \boldsymbol{\tau}_0^\top]^\top$ satisfies

$$
\|\boldsymbol{S}\left(\boldsymbol{\theta}_{0}-\boldsymbol{\theta}^{\star}\right)\|_{\infty} \leq 1 - \sqrt{\frac{2}{3}},\tag{24}
$$

the iterates $\{\theta_k\}$ of preconditioned GD (12) with an adaptive preconditioner (22) converge towards θ^{\star} according to

$$
\|\boldsymbol{S}\left(\boldsymbol{\theta}_{k}-\boldsymbol{\theta}^{\star}\right)\|_{\infty} \leq \left(\frac{1}{2}+\gamma\right)^{k} \|\boldsymbol{S}\left(\boldsymbol{\theta}_{0}-\boldsymbol{\theta}^{\star}\right)\|_{\infty}, \qquad \forall k \in \mathbb{N}.
$$

Theorem 2 guarantees that preconditioned GD with an adaptive preconditioner achieves a constant linear rate of convergence in a similar basin of attraction, provided that the separation condition $\Delta(\tau^*)$ is sufficiently large with respect to the dynamic range, i.e.

$$
(n+1)\,\Delta(\boldsymbol{\tau}^{\star})\gtrsim\left(\frac{\|\boldsymbol{a}^{\star}\|_{\infty}}{a_{\min}^{\star}}\right)^{1/2},\tag{26}
$$

which is much weaker than the requirement for the case using a fixed preconditioner, as indicated in Theorem 1. Consequently, this highlights the benefit of adaptive preconditioning in accelerating the convergence in the presence of high dynamic ranges for nonconvex spike deconvolution.

Remark. We have not attempted to fully optimize the constants in the above theorems. Therefore, their values are set in a quite pessimistic fashion.

3 Analysis

This section is devoted to proving the two main results of this paper comprised in Theorem 1 and Theorem 2. Before entering the core of the proofs, we first provide some warm-up analysis that will be required in the latter proofs.

3.1 Preliminaries

3.1.1 Contraction of entrywise errors

The convergence analysis of the preconditioned gradient method presented in Theorem 1 and Theorem 2 calls for understanding of the contraction properties of the sequence $\{\|\mathbf{S}(\theta_{k} - \theta^*)\|_{\infty}\}$. Starting from the update rule (12), leveraging $\nabla \mathcal{L}(\theta_{\star}) = \mathbf{0}$, and applying the fundamental theorem of calculus, we have

$$
S(\theta_{k+1} - \theta_{\star}) = S(\theta_k - P_k \nabla \mathcal{L}(\theta_k) - \theta_{\star})
$$

\n
$$
= S(\theta_k - \theta_{\star}) - SP_k (\nabla \mathcal{L}(\theta_k) - \nabla \mathcal{L}(\theta_{\star}))
$$

\n
$$
= S(\theta_k - \theta_{\star}) - SP_k \left(\int_0^1 \nabla^2 \mathcal{L} (\theta^{\star} + u (\theta_k - \theta^{\star})) du \right) (\theta_k - \theta_{\star})
$$

\n
$$
= \left[I - SP_k \left(\int_0^1 \nabla^2 \mathcal{L} (\theta^{\star} + u (\theta_k - \theta^{\star})) du \right) S^{-1} \right] S(\theta_k - \theta_{\star}). \tag{27}
$$

Let $\mathcal{S}_k = \{\theta^* + u \, (\theta_k - \theta^*) \, | u \in [0,1] \}$ be the line segment that connects θ^* and θ_k in \mathbb{C}^{2r} , and denote by ρ_k the quantity

$$
\rho_k \triangleq \max_{\boldsymbol{\theta} \in \mathcal{S}_k} \left\| \boldsymbol{I} - \boldsymbol{S} \boldsymbol{P}_k \boldsymbol{H}(\boldsymbol{\theta}) \boldsymbol{S}^{-1} \right\|_{\infty},\tag{28}
$$

where $H(\theta) = \nabla^2 \mathcal{L}(\theta)$ is the Hessian of the loss function \mathcal{L} at point θ . Continuing to bound (27) yields

$$
\|S(\theta_{k+1} - \theta_{\star})\|_{\infty} \leq \left\|I - SP_k\left(\int_0^1 H\left(\theta^{\star} + u\left(\theta_k - \theta^{\star}\right)\right) \mathrm{d}u\right) S^{-1}\right\|_{\infty} \|S(\theta_k - \theta_{\star})\|_{\infty} \n= \left\|\int_0^1 \left(I - SP_k H\left(\theta^{\star} + u\left(\theta_k - \theta^{\star}\right)\right) S^{-1}\right) \mathrm{d}u\right\|_{\infty} \|S(\theta_k - \theta_{\star})\|_{\infty} \n\leq \left(\int_0^1 \left\|I - SP_k H\left(\theta^{\star} + u\left(\theta_k - \theta^{\star}\right)\right) S^{-1}\right\|_{\infty} \mathrm{d}u\right) \|S(\theta_k - \theta_{\star})\|_{\infty} \n\leq \max_{\theta \in S_k} \left\{\left\|I - SP_k H(\theta) S^{-1}\right\|_{\infty}\right\} \|S(\theta_k - \theta_{\star})\|_{\infty} \n= \rho_k \|S(\theta_k - \theta_{\star})\|_{\infty}.
$$
\n(29)

Hence, the crux of the convergence analysis is to show that $\rho_k < 1$ (and control the size of ρ_k) uniformly over the segment S_k whenever the point θ_k lies in an appropriate region centered around the ground truth θ^* . Further analysis towards that goal requires an explicit derivation of the Hessian matrix $H(\theta)$, which is done next.

3.1.2 Hessian decomposition

Recall that $H(\theta) = \nabla^2 \mathcal{L}(\theta) \in \mathbb{C}^{2r \times 2r}$ is the Hessian matrix of the loss function \mathcal{L} in (5) at the point $\theta = [\boldsymbol{a}^\top, \boldsymbol{\tau}^\top]^\top$. We decompose $\boldsymbol{H}(\boldsymbol{\theta})$ as

$$
\boldsymbol{H}(\boldsymbol{\theta}) = \begin{bmatrix} \boldsymbol{H}_{a,a}(\boldsymbol{\theta}) & \boldsymbol{H}_{a,\tau}(\boldsymbol{\theta}) \\ \boldsymbol{H}_{a,\tau}^{\mathsf{H}}(\boldsymbol{\theta}) & \boldsymbol{H}_{\tau,\tau}(\boldsymbol{\theta}) \end{bmatrix},\tag{30}
$$

where each block is of size $r \times r$, with generic terms

$$
\left[\bm{H}_{a,a}(\bm{\theta})\right]_{(i,j)} = \frac{\mathrm{d}^2 f(\bm{\theta})}{\mathrm{d}a_i \mathrm{d}a_j}, \qquad \left[\bm{H}_{a,\tau}(\bm{\theta})\right]_{(i,j)} = \frac{\mathrm{d}^2 f(\bm{\theta})}{\mathrm{d}a_i \mathrm{d}\tau_j}, \qquad \left[\bm{H}_{\tau,\tau}(\bm{\theta})\right]_{(i,j)} = \frac{\mathrm{d}^2 f(\bm{\theta})}{\mathrm{d}\tau_i \mathrm{d}\tau_j},
$$

for $i, j = 1 \ldots, r$. A direct calculation of the Hessian matrix $H(\theta)$ (see, e.g. [23]) yields a decomposition of the form

$$
H(\theta) = G(\theta) + E(\theta),\tag{31}
$$

where the terms $G(\theta) \in \mathbb{C}^{2r \times 2r}$ and $E(\theta) \in \mathbb{C}^{2r \times 2r}$ are described in the sequel.

Structure of $G(\theta)$ The matrix $G(\theta)$ can be written as

$$
G(\theta) = \text{diag}\left(\left[\frac{1_r}{\sqrt{-F_N''(0)}}a\right]\right)^H D(\tau) \text{diag}\left(\left[\frac{1_r}{\sqrt{-F_N''(0)}}a\right]\right),\tag{32}
$$

with $\mathbf{D}(\tau) \in \mathbb{C}^{2r \times 2r}$ given with a block structure

$$
D(\tau) = \begin{bmatrix} D_0(\tau) & D_1(\tau) \\ D_1(\tau)^{\mathsf{H}} & D_2(\tau) \end{bmatrix}.
$$
 (33)

The entries of the blocks $D_0(\tau)$, $D_1(\tau)$, $D_2(\tau) \in \mathbb{C}^{r \times r}$ are composed of

$$
[\boldsymbol{D}_0(\boldsymbol{\tau})]_{(i,j)} = F_N(\tau_i - \tau_j), \tag{34a}
$$

$$
[\mathbf{D}_1(\tau)]_{(i,j)} = -F_N'(\tau_i - \tau_j) / \sqrt{-F_N''(0)},\tag{34b}
$$

$$
[\mathbf{D}_2(\tau)]_{(i,j)} = F_N''(\tau_i - \tau_j) / F_N''(0)
$$
\n(34c)

for all $i, j = 1, \ldots, r$. As shall be seen, the matrix $G(\theta)$ is a relatively well-conditioned matrix whose spectrum can be controlled as a function of the separation parameter between the spikes $(n+1)\Delta(\tau^*)$, the dynamic range of the amplitudes $\frac{\|\boldsymbol{a}\|_{\infty}}{a_{\min}^*}$, and the distance of $\boldsymbol{\theta}$ to the ground truth parameter $\boldsymbol{\theta}^*$.

Structure of $E(\theta)$ The matrix $E(\theta)$ is given by the block structure decomposition

$$
\boldsymbol{E}(\boldsymbol{\theta}) = \begin{bmatrix} \mathbf{0}_{r \times r} & \boldsymbol{E}_1(\boldsymbol{\theta}) \\ \boldsymbol{E}_1(\boldsymbol{\theta})^{\mathsf{H}} & \boldsymbol{E}_2(\boldsymbol{\theta}) \end{bmatrix},
$$
(35)

where the entries of $\mathbf{E}_1(\theta)$, $\mathbf{E}_2(\theta) \in \mathbb{C}^{r \times r}$ are given as

$$
[\boldsymbol{E}_{1}(\boldsymbol{\theta})]_{(i,j)} = \begin{cases} \left\langle \delta'_{\tau_{j}}, F_{N} * (\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^{*})) \right\rangle & i = j; \\ 0 & i \neq j; \end{cases} \tag{36a}
$$

$$
[\boldsymbol{E}_2(\boldsymbol{\theta})]_{(i,j)} = \begin{cases} a_j \left\langle \delta''_{\tau_j}, F_N * (\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^*)) \right\rangle & i = j; \\ 0 & i \neq j. \end{cases} \tag{36b}
$$

It is worth noting that $E(\theta_{\star}) = 0$, hence E can be interpreted as a perturbation term that grows as θ deviates from θ_{\star} .

With the above preliminaries, we are now ready to prove the main results of this paper. The following two sections present our convergence analyses for preconditioned GD using a fixed preconditioner and an adaptive preconditioner, respectively.

3.2 Proof of Theorem 1

We recall that $P_k = P = \text{diag}\left(\begin{bmatrix} \mathbf{1}_r \ -F''_N(0)^{-1}A^{-2}\mathbf{1}_r \end{bmatrix}\right)$ for all $k \in \mathbb{N}$ when the preconditioner is fixed. The contraction analysis (29) presented in Section 3.1.1 suggests that the contraction rate in Theorem 1 is controlled by the quantity $||SPH(\theta)S^{-1} - I||_{\infty}$ in neighborhood around the ground truth θ^* . The next theorem, whose proof is deferred to Appendix B, provides a uniform bound on this quantity on a neighborhood of the ground truth.

Theorem 3 (Uniform bound of the Hessian). Suppose that $n \ge 2$, $(n+1)\Delta(\tau^*) \ge 16.5$ and $\|\tau - \tau^*\|_{\infty} \le \frac{1}{4}\Delta(\tau^*)$. Let $\theta_k = [\mathbf{a}_k^{\top}, \tau_k^{\top}]^{\top}$ and assume that $A \ge \max\{\frac{3}{2} ||\mathbf{a}^*||_{\infty}, ||\mathbf{a}_k||_{\infty}\}$ then constants

$$
K_{\Delta} = 2.13,\tag{37a}
$$

$$
K_{\theta} = 44.42,\tag{37b}
$$

such that for all $\boldsymbol{\theta} = [\boldsymbol{a}^\top, \boldsymbol{\tau}^\top]^\top \in \mathcal{S}_k$ with $\|\boldsymbol{S}(\boldsymbol{\theta}_k - \boldsymbol{\theta}^*)\|_{\infty} < 1$, we have that

$$
\|\boldsymbol{SPH}(\boldsymbol{\theta})\boldsymbol{S}^{-1} - \boldsymbol{I}\|_{\infty} \le 1 - \left(\frac{a_{\min}^{\star}}{A}\right)^{2} (1 - \|\boldsymbol{S}(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{\star})\|_{\infty})^{2} + (4K_{\Delta} + K_{\theta} \|\boldsymbol{S}(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{\star})\|_{\infty}) \frac{\|\boldsymbol{a}^{\star}\|_{\infty}}{a_{\min}^{\star}} ((n+1)\Delta(\boldsymbol{\tau}^{\star}))^{-2} (1 + \|\boldsymbol{S}(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{\star})\|_{\infty})^{2}.
$$
 (38)

Theorem 3 provides a bound on $||SPH(\theta)S^{-1} - I||_{\infty}$ depending on the quantity $\frac{||a^*||_{\infty}}{a^*_{\min}}((n+1)\Delta(\tau^*))^{-2}$, which can be made small enough under the hypothesis of Theorem 1. We proceed with the rest of the proof by induction.

For the base case, it is trivial that (19) holds for $k = 0$. We start the induction by assuming that

$$
\|\boldsymbol{S}\left(\boldsymbol{\theta}_{k}-\boldsymbol{\theta}^{\star}\right)\|_{\infty} \leq \left(1-\frac{1}{4}\left(\frac{a_{\min}^{\star}}{A}\right)^{2}\left(1-\eta\right)\right)^{k} \|\boldsymbol{S}\left(\boldsymbol{\theta}_{0}-\boldsymbol{\theta}^{\star}\right)\|_{\infty} \tag{39}
$$

holds for some $k \in \mathbb{N}$. We begin by verifying the assumptions of Theorem 3.

• First, as the dynamic range $\frac{\|a^*\|_{\infty}}{a_{\min}^*} \geq 1$, it is easy to see that the hypothesis (17) immediately implies that $(n+1)\Delta(\tau^*) \geq 16.6$.

• By the definition (16) and the induction hypothesis (39) , it follows that

\|\tau_{k} - \tau^{\star}\|_{\infty} \leq \frac{1}{\sqrt{-F_{N}^{"}}(0)} \left\| \mathbf{S} \left(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{\star} \right) \right\|_{\infty}
$$

$$
\leq \frac{1}{\sqrt{-F_{N}^{"}}(0)} \left\| \mathbf{S} \left(\boldsymbol{\theta}_{0} - \boldsymbol{\theta}^{\star} \right) \right\|_{\infty}
$$

$$
\leq \frac{\sqrt{3}}{2\pi} \frac{1}{n+1} \leq \frac{1}{n+1} \leq \frac{\Delta(\tau^{\star})}{4}.
$$
(40)

• Furthermore, we have that

$$
\|a_k\|_{\infty} \le \|a^*\|_{\infty} + \|a_k - a^*\|_{\infty}
$$

\n
$$
\le \|a^*\|_{\infty} (1 + \|S(\theta_k - \theta^*)\|_{\infty})
$$

\n
$$
< \|a^*\|_{\infty} (1 + \|S(\theta_0 - \theta^*)\|_{\infty})
$$

\n
$$
\le \frac{3}{2} \|a^*\|_{\infty} \le A.
$$
\n(41)

Hence, the assumptions of Theorem 3 hold, which yields

$$
\rho_{k} = \max_{\theta \in S_{k}} \left\| \mathbf{SPH}(\theta) \mathbf{S}^{-1} - \mathbf{I} \right\|_{\infty} \n\leq 1 - \frac{\left(a_{\min}^{*}\right)^{2}}{4A^{2}} + \frac{9}{4} \left(4K_{\Delta} + \frac{1}{2} K_{\theta} \right) \frac{\|\mathbf{a}^{*}\|_{\infty}}{a_{\min}^{*}} \left((n+1)\Delta(\boldsymbol{\tau}^{*}) \right)^{-2} \n\leq 1 - \frac{\left(a_{\min}^{*}\right)^{2}}{4A^{2}} \left(1 - 9 \left(4K_{\Delta} + \frac{1}{2} K_{\theta} \right) \frac{A^{2} \|\mathbf{a}^{*}\|_{\infty}}{a_{\min}^{*3}} \left((n+1)\Delta(\boldsymbol{\tau}^{*}) \right)^{-2} \right) \n\leq 1 - \frac{\left(a_{\min}^{*}\right)^{2}}{4A^{2}} \left(1 - 276.21 \frac{A^{2} \|\mathbf{a}^{*}\|_{\infty}}{a_{\min}^{*3}} \left((n+1)\Delta(\boldsymbol{\tau}^{*}) \right)^{-2} \right) \n\leq 1 - \frac{\left(a_{\min}^{*}\right)^{2}}{4A^{2}} \left(1 - \eta \right),
$$
\n(42)

where we substituted the definition (17) of η in the last line. It results from the iterative analysis (29) that the next update θ_{k+1} obeys

\|S(\theta_{k+1} - \theta^*)\|_{\infty} \le \rho_k \|S(\theta_k - \theta^*)\|_{\infty}
$$

\n
$$
\le \left(1 - \frac{(\alpha^*_{\min})^2}{4A^2} (1 - \eta)\right) \|S(\theta_k - \theta^*)\|_{\infty}
$$

\n
$$
\le \left(1 - \frac{(\alpha^*_{\min})^2}{4A^2} (1 - \eta)\right)^{k+1} \|S(\theta_0 - \theta^*)\|_{\infty},
$$
\n(43)

which concludes the proof of Theorem 1.

3.3 Proof of Theorem 2

We proceed with the proof of Theorem 2 analogously to the proof of Theorem 1 presented in Section 3.2. First, we establish the following intermediate theorem that controls the conditioning of the scaled Hessian matrix $SP_k(\theta)HS^{-1}$ uniformly over the segment S_k as a function of the weighted infinity-norm distance $||S(\theta_k - \theta^*)||_{\infty}$. The proof of Theorem 4 is deferred to Appendix B.3.

Theorem 4 (Uniform bound of the Hessian). Suppose that $n \geq 2$, $(n+1)\Delta(\tau^*) \geq 4.7$ and $\|\tau - \tau^*\|_{\infty} \leq$ $\frac{1}{4}\Delta(\tau^{\star})$ then the exists two positive constants

$$
K_{\Delta} \le 2.32,\tag{44a}
$$

$$
K_{\theta} \le 75.80,\tag{44b}
$$

such that for all $\boldsymbol{\theta} = [\boldsymbol{a}^\top, \boldsymbol{\tau}^\top]^\top \in \mathcal{S}_k$ satisfying $\|\boldsymbol{S}\left(\boldsymbol{\theta}_k - \boldsymbol{\theta}^\star\right)\|_\infty < 1$ we have that

$$
\|\mathbf{SP}_{k}\mathbf{H}(\boldsymbol{\theta})\mathbf{S}^{-1} - \mathbf{I}\|_{\infty} \leq \frac{1}{\left(1 - \|\mathbf{S}(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{*})\|_{\infty}\right)^{2}} - 1 + (4K_{\Delta} + K_{\theta} \|\mathbf{S}(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{*})\|_{\infty}) \frac{\|\boldsymbol{a}^{*}\|_{\infty}}{a_{\min}^{*}} \frac{\left((n+1)\Delta(\boldsymbol{\tau}^{*})\right)^{-2}}{\left(1 - \|\mathbf{S}(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{*})\|_{\infty}\right)^{2}}.
$$
 (45)

The rest of the proof follows similarly by induction. For the base case, it is trivial that the initial point θ_0 verifies (25). We now assume that θ_k satisfies

$$
\|\boldsymbol{S}\left(\boldsymbol{\theta}_{k}-\boldsymbol{\theta}^{\star}\right)\|_{\infty} \leq \left(\frac{1}{2}+\gamma\right)^{k} \|\boldsymbol{S}\left(\boldsymbol{\theta}_{0}-\boldsymbol{\theta}^{\star}\right)\|_{\infty} \tag{46}
$$

for some $k \in \mathbb{N}$. Let's verify the assumptions of Theorem 4.

- First, as the dynamic range $\frac{\|a^*\|_{\infty}}{a_{\min}^*} \ge 1$, the assumption (23) easily implies that $(n+1)\Delta(\tau^*) \ge 4.7$.
- By the definition (16) and the induction hypothesis (46) , it follows that

Hence, the assumptions of Theorem 4 hold. Noticing that the function $f(u) := \frac{1}{(1-u)^2}$ is increasing over [0, 1], we have that $\frac{1}{(1-\|S(\theta_k-\theta^*)^2\|_{\infty})} \leq \frac{1}{2}$. Together with Theorem 4, this yields the bound

4 Numerical experiments

This section provides a numerical validation of Theorem 1 and Theorem 2. In the following experiments, the signal length is set to $N = 65$ (*i.e.* $n = 32$). The ground truth signal is composed of $r = 6$ sources placed in the interval $[-\frac{1}{2},\frac{1}{2})$ while ensuring that $(n+1)\Delta(\tau^*)\geq 2$, which is a more optimistic separation condition than what the theorems' statements suggest. Additionally, the dynamic range is denoted by $\kappa = \frac{\|\mathbf{a}^{\star}\|_{\infty}}{a_{\min}^{\star}}$. The complex amplitudes $a^* \in \mathbb{C}^r$ are selected independently and uniformly at random in a complex annulus with bounds $1 \leq |a_{\ell}^{\star}| \leq \kappa$. The input parameter of the invariant preconditioning scheme is set at $A = \frac{3}{2} ||a^{\star}||_{\infty}$.

Size of the basin of attraction Of critical importance in the analysis of Theorem 1 and Theorem 2 is the distance between the initial parameter θ_0 and the ground truth θ_{\star} . We start by comparing the success rates of both preconditioning schemes on reconstructing the ground truth as a function of the initialization distance $||S(\theta_0 - \theta_\star)||_{\infty}$. In each experiment, the starting point θ_0 is drawn uniformly over the set of points equidistant to θ_{\star} . An experiment is labeled as a success if $||S(\theta_{200} - \theta_{\star})||_{\infty} \leq 10^{-2}$ after 200 iterations. Figure 1 suggests that, for both schemes, the size of the basin of attraction is independent of the dynamic range κ , and is around the order of magnitude $||S(\theta_0 - \theta_\star)||_{\infty} \simeq 1$. This suggests that the numerical constants proposed in Theorem 1 and Theorem 2 are pessimistic and nonconvex spike deconvolution performs in a much more benign manner than predicted by our theory, indicating room for further refinements.

Figure 1: Success rate of the invariant and adaptive preconditioning schemes on reconstructing the ground truth θ_{\star} as a function of the initialization distance $||S(\theta_{0} - \theta_{\star})||_{\infty}$ for different dynamic ranges κ. The results are averaged over 1000 randomized trials.

Linear convergence using a spectral initialization In practice, several ad hoc initialization methods could be envisaged to produce an initial point θ_0 that falls in the basin of attraction of the preconditioned gradient descent methods. Herein, we proceed by uniformly discretizing the spectral domain over N elements. Given the knowledge of the ground truth model order r, the initial locations τ_0 are selected as the r elements of the discrete grid whose weighted Fourier transform best describes the observation x . Mathematically, consider the following optimization problem

where $F_N \in \mathbb{C}^{N \times N}$ is a discrete Fourier transform matrix, and the ℓ_0 -norm denotes the cardinality of the support. Writing $\mathcal{I}_0 = \text{supp} (\boldsymbol{u}_0) \subset [-n, \ldots, n]$ the support of the solution \boldsymbol{u}_0 of (50), the parameter $\boldsymbol{\theta}_0$ is constructed in a second stage by selecting $\boldsymbol{\tau}_0 = \begin{bmatrix} \frac{k_1}{N}, \ldots, \frac{k_r}{N} \end{bmatrix}^\top$ where $k_\ell \in \mathcal{I}_0$, $\ell = 1, \ldots, r$ and $\boldsymbol{a}_0 = \boldsymbol{u}_{|\mathcal{I}_0}$ as the restriction of u to the elements in \mathcal{I}_0 . The program (50) is itself a non-convex sparse reconstruction problem, which we approximate the solution using the orthogonal matching pursuit algorithm [34]. The proposed

initialization procedure offers several benefits over more classical methods: It is highly scalable, robust to high dynamic range, and does not involve any polynomial root finding subroutine.

Figure 2 pictures the convergence rate of preconditioned GD under the invariant and adaptive preconditioning schemes, respectively. For both schemes, θ_0 is selected according to the previously described initialization procedure. It can be seen that, although both preconditioning schemes ensure a linear converge of the iterate sequence, the convergence rate with a fixed preconditioner degrades as the dynamic range of the sources increases. In contrast, the one with an adaptive preconditioner remains unchanged. Additionally, the adaptive preconditioning scheme benefits from faster convergence rates for a given dynamic range. These experimental results corroborate the theoretical findings presented in Section 2.

Figure 2: Convergence rates of the iterate sequence of preconditioned GD towards the ground truth as the dynamic range κ varies for: (a) the invariant preconditioning scheme; (b) the adaptive preconditioning scheme.

5 Conclusion

This work proposed and analyzed preconditioned gradient methods for nonconvex spike deconvolution using both fixed and adaptive preconditioners, and demonstrated that for ground truth with sufficiently separated spikes, the proposed methods achieve a linear rate of convergence that is independent of the number of spikes, as long as a close enough initialization is provided near the ground truth. In particular, by designing the preconditioner to compensate adaptively for the amplitude profile of the spikes, it is possible to accelerate the convergence rate to be dimension-free and independent of the dynamic range, while the convergence using a fixed preconditioner slows down when the dynamic range is large. Our work thus highlights the importance of preconditioning in accelerating convergence in nonconvex spike deconvolution.

As a first step towards understanding the efficacy of first-order methods for spike deconvolution, this works opens up several interesting directions for further investigation.

- Initialization schemes. One immediate direction is to analyze initialization schemes that produce initial estimates that fall into the basin of attraction, which we suspect the procedure described in Section 4 is a good candidate.
- General observations. Another direction is to extend the analysis to more general observation operators, possibly including random sampling, missing data, as well as corruptions. This may necessarily require a reformulation of the loss function, such as a nonsmooth and nonconvex formulation using the least absolute deviation [35] to improve robustness.
- Separation condition. Last but not least, it is of great importance to study to what extent it is possible to relax the success condition in terms of the separation condition, possibly with additional positive constraints of the source amplitudes.

A Summation bounds of the Fejér kernel

The purpose of this section is to present Lemma 5, which delivers fundamental bounds on the absolute sum of the Fejér kernel and its derivatives at sampled points of interest. Although specific to the Fejér kernel, Lemma 5 could be adapted to any other absolutely integrable point spread function without a significant change in the proof structure.

Lemma 5 (Uniform bounds on the Fejér kernel). Suppose that $n \geq 2$. Let $\tau = {\tau_1, \ldots, \tau_r} \subset \mathbb{T}$, and let $\alpha > 0$ be such that $(n+1)\Delta(\tau) \geq \alpha$. Let $\boldsymbol{u} = \{u_{i,j}\}_{i \neq j} \subset \mathbb{R}$ be a set of $\frac{r(r-1)}{2}$ real numbers that are absolutely bounded by β such that

0 \le h_{\ell} \left(\tau_{i-j} - \tau_{i} + u_{i,j} \right) \le h_{\ell} \left(-j \Delta(\tau) + \frac{\beta}{n+1} \right) = h_{\ell} \left(j \Delta(\tau) - \frac{\beta}{n+1} \right), \quad j = 1, \ldots, r_{-}.

We can subsequently bound the sum (57) as

Identifying and associating the right-hand side of (63) to a Riemann sum with a mid-point rule and recalling that h_{ℓ} is decreasing and convex over $(0, \frac{1}{2}]$ leads to the majorant

SP_k G(\theta) S^{-1} - I = SP_k \operatorname{diag}\left(\begin{bmatrix} 1_r \\ \sqrt{-F_N''(0)}a \end{bmatrix}\right)^H D(\tau) \operatorname{diag}\left(\begin{bmatrix} 1_r \\ \sqrt{-F_N''(0)}a^H \end{bmatrix}\right) S^{-1} - I
$$

= diag $\left(\begin{bmatrix} a^{\star -1} \\ |a_k|^{-2} \odot a \end{bmatrix}\right)^H D(\tau) \operatorname{diag}\left(\begin{bmatrix} a^{\star} \\ a \end{bmatrix}\right) - I$
= diag $\left(\begin{bmatrix} a^{\star -1} \\ |a_k|^{-2} \odot a \end{bmatrix}\right)^H (D(\tau) - I) \operatorname{diag}\left(\begin{bmatrix} a^{\star} \\ a \end{bmatrix}\right) + \operatorname{diag}\left(\begin{bmatrix} 1_r \\ |a_k|^{-2} \odot |a|^2 \end{bmatrix}\right) - I.$ (85)

This immediately yields from the triangle inequality

$$
\|\mathbf{SP}_{k}\mathbf{G}(\boldsymbol{\theta})\mathbf{S}^{-1} - \mathbf{I}\|_{\infty} \n\leq \left\|\operatorname{diag}\left(\begin{bmatrix} \mathbf{a}^{\star-1} \\ |\mathbf{a}_{k}|^{-2} \odot \mathbf{a} \end{bmatrix}\right)^{\mathsf{H}} (\mathbf{D}(\boldsymbol{\tau}) - \mathbf{I}) \operatorname{diag}\left(\begin{bmatrix} \mathbf{a}^{\star} \\ \mathbf{a} \end{bmatrix}\right)\right\|_{\infty} + \left\|\operatorname{diag}\left(\begin{bmatrix} \mathbf{1}_{r} \\ |\mathbf{a}_{k}|^{-2} \odot |\mathbf{a}|^{2} \end{bmatrix}\right) - \mathbf{I}\right\|_{\infty} \n\leq \left\|\operatorname{diag}\left(\begin{bmatrix} \mathbf{a}^{\star-1} \\ |\mathbf{a}_{k}|^{-2} \odot \mathbf{a} \end{bmatrix}\right)^{\mathsf{H}}\right\|_{\infty} \|\mathbf{D}(\boldsymbol{\tau}) - \mathbf{I}\|_{\infty} \left\|\operatorname{diag}\left(\begin{bmatrix} \mathbf{a}^{\star} \\ \mathbf{a} \end{bmatrix}\right)\right\|_{\infty} + \left\|\operatorname{diag}\left(\begin{bmatrix} \mathbf{1}_{r} \\ |\mathbf{a}_{k}|^{-2} \odot |\mathbf{a}|^{2} \end{bmatrix}\right) - \mathbf{I}\right\|_{\infty} \n\leq \max_{j} \left\{\frac{1}{|a_{j}^{\star}|}, \frac{|\mathbf{a}_{j}^{\star}|}{|a_{k,j}|^{2}}\right\} \max_{j} \left\{|a_{j}^{\star}|, |a_{j}|\right\} \|\mathbf{D}(\boldsymbol{\tau}) - \mathbf{I}\|_{\infty} + \max_{j} \left\{\left|\frac{|a_{j}^{\star}|^{2}}{|a_{k,j}|^{2}} - 1\right|\right\}
$$
\n(86)

The three maxima in (86) can be controlled using the basic relation

$$
\frac{|a_j^*|}{|a_{k,j}|} \le \frac{|a_j^*|}{|a_j^*| - |a_{k,j} - a_j^*|} \le \frac{1}{1 - \|S(\theta_k - \theta^*)\|_{\infty}},\tag{87}
$$

as follows

\max_{j} \left\{ \frac{1}{|a_{j}^{*}|}, \frac{|a_{j}^{*}|}{|a_{k,j}|^{2}} \right\} \le \max_{j} \left\{ \frac{1}{|a_{j}^{*}|}, \frac{1}{|a_{j}^{*}|} \frac{1}{(1 - \|S(\theta_{k} - \theta^{*})\|_{\infty})^{2}} \right\} \le \frac{1}{a_{\min}^{*}} \frac{1}{(1 - \|S(\theta_{k} - \theta^{*})\|_{\infty})^{2}} \quad (88a)
$$

$$
\max_{j} \left\{ |a_{j}^{*}|, |a_{j}| \right\} \le \max_{j} \left\{ |a_{j}^{*}|, |a_{j}^{*}| (1 + \|S(\theta_{k} - \theta^{*})\|_{\infty}) \right\} \le \|a^{*}\|_{\infty} (1 + \|S(\theta_{k} - \theta^{*})\|_{\infty}) \quad (88b)
$$

$$
\max_{j} \left\{ \left| \frac{|a_{j}^{*}|^{2}}{|a_{k,j}|^{2}} - 1 \right| \right\} \le \max_{j} \left\{ 1 - \frac{|a_{j}^{*}|^{2}}{|a_{k,j}|^{2}}, \frac{|a_{j}^{*}|^{2}}{|a_{k,j}|^{2}} - 1 \right\} \n\le \max_{j} \left\{ 1, \frac{|a_{j}^{*}|^{2}}{|a_{k,j}|^{2}} - 1 \right\} \le \frac{1}{\left(1 - \| \mathbf{S}(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{*}) \|_{\infty} \right)^{2}} - 1.
$$
\n(88c)

The bounds (88) and Lemma 6 conclude with (86) on

$$
\|SP_k G(\theta)S^{-1} - I\|_{\infty} \n\leq \frac{\|a^*\|_{\infty}}{a_{\min}^*} \frac{1 + \|S(\theta_k - \theta^*)\|_{\infty}}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} \|D(\tau) - I\|_{\infty} + \frac{1}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} - 1 \n\leq \frac{\|a^*\|_{\infty}}{a_{\min}^*} \frac{1 + \|S(\theta_k - \theta^*)\|_{\infty}}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} K_{\Delta} ((n+1)\Delta(\tau))^{-2} + \frac{1}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} - 1,
$$
\n(89)

where the constant K_{Δ} defined in Lemma 6 is numerically evaluated to $K_{\Delta} \leq 2.32$ by setting the parameter $\alpha = 4.7$.

 $\text{Step 2: bound } ||SP_kE(\theta)S^{-1}||_{\infty}$ Again, using the block diagonal structure of the matrix $\boldsymbol{E}(\boldsymbol{\theta})$ defined in (35), we similarly have that

\boldsymbol{SP}_{k}\boldsymbol{E}(\boldsymbol{\theta})\boldsymbol{S}^{-1} = \begin{bmatrix} \boldsymbol{0} & \frac{1}{\sqrt{-F_{N}^{\prime\prime}(0)}}\operatorname{diag}\left(\boldsymbol{a}^{\star-1}\right)\boldsymbol{E}_{1}(\boldsymbol{\theta}) \\ \frac{1}{\sqrt{-F_{N}^{\prime\prime}(0)}}\operatorname{diag}\left(\left|\boldsymbol{a}_{k}\right|^{-2}\odot\boldsymbol{a}^{\star}\right)^{\mathsf{H}}\boldsymbol{E}_{1}(\boldsymbol{\theta}) & -\frac{1}{F_{N}^{\prime\prime}(0)}}\left|\boldsymbol{a}_{k}\right|^{-2}\boldsymbol{E}_{2}(\boldsymbol{\theta}) \end{bmatrix} . \tag{90}
$$

Therefore, the quantity of interest can be bounded as follows

$$
\|\mathbf{SP}_{k}\mathbf{E}(\boldsymbol{\theta})\mathbf{S}^{-1}\|_{\infty} \leq \frac{1}{\sqrt{-F_{N}^{"}}(0)} \max_{j} \left\{\max\left\{\frac{1}{|a_{j}^{*}|}, \frac{|a_{j}^{*}|}{|a_{j,k}|^{2}}\right\} \left|\left\langle\delta_{\tau_{j}}^{\prime}, F_{N} * (\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^{*}))\right\rangle\right|\right\} -\frac{1}{F_{N}^{"}}(0) \max_{j} \left\{\frac{|a_{j}|}{|a_{j,k}|^{2}} \left|\left\langle\delta_{\tau_{j}}^{\prime}, F_{N} * (\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^{*}))\right\rangle\right|\right\} \leq \frac{(a_{\min}^{*})^{-1}}{(1 - \|\mathbf{S}(\boldsymbol{\theta}_{k} - \boldsymbol{\theta}^{*})\|_{\infty})^{2}} \left(\frac{1}{\sqrt{-F_{N}^{"}}(0)} \max_{j} \left\{\left|\left\langle\delta_{\tau_{j}}^{\prime}, F_{N} * (\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^{*}))\right\rangle\right|\right\} -\frac{1}{F_{N}^{"}}(0) \max_{j} \left\{\left|\left\langle\delta_{\tau_{j}}^{\prime}, F_{N} * (\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}^{*}))\right\rangle\right|\right\}, \tag{91}
$$

where we used the inequalities (88) on the second line. Substituting the expression provided by Lemma 7 into (91) leads to

\|SP_k E(\theta) S^{-1} \|_{\infty} \leq \left(\left(C_1 \frac{n+1}{\sqrt{-F_N''(0)}} + C_2 \frac{(n+1)^2}{-F_N''(0)} \right) \frac{\| \mathbf{a} - \mathbf{a}^* \|_{\infty}}{\| \mathbf{a}^* \|_{\infty}} + \left(C_2 \frac{(n+1)^2}{-F_N''(0)} + C_3 \frac{(n+1)^3}{(-F_N''(0))^{3/2}} \right) \sqrt{-F_N''(0)} \|\mathbf{r}_k - \mathbf{r}^* \|_{\infty} \right) + \frac{\| \mathbf{a}^* \|_{\infty}}{a_{\min}^*} \frac{\left((n+1)\Delta(\mathbf{r}) \right)^{-2}}{(1 - \| S(\theta_k - \theta^*) \|_{\infty})^2} . \tag{92}
$$

Evaluating the constants $C_1 \leq 3.24, C_2 \leq 22.90$ and $C_3 \leq 105.55$ defined in (53) with parameters $\alpha = 4.7$ and $\beta = \frac{\alpha}{4} = 1.2$, altogether with the inequality $\frac{(n+1)^2}{-F_N''(0)} \le \frac{27}{16\pi^2}$ under the assumption $n \ge 2$ yields

$$
\left\|\mathbf{SP}_{k}\mathbf{E}(\boldsymbol{\theta})\mathbf{S}^{-1}\right\|_{\infty} \leq \left(K_{a} \frac{\left\|\boldsymbol{a}-\boldsymbol{a}^{\star}\right\|_{\infty}}{\left\|\boldsymbol{a}^{\star}\right\|_{\infty}} + K_{\tau}\sqrt{-F_{N}^{\prime\prime}(0)}\left\|\boldsymbol{\tau}_{k}-\boldsymbol{\tau}^{\star}\right\|_{\infty}\right) \frac{\left\|\boldsymbol{a}^{\star}\right\|_{\infty}}{a_{\min}^{\star}} \frac{\left((n+1)\Delta(\boldsymbol{\tau})\right)^{-2}}{\left(1-\left\|\mathbf{S}(\boldsymbol{\theta}_{k}-\boldsymbol{\theta}^{\star})\right\|_{\infty}\right)^{2}},\tag{93}
$$

where the constants K_a and K_τ are given by

$$
K_a = C_1 \sqrt{\frac{27}{16\pi^2}} + C_2 \frac{27}{16\pi^2} \le 5.26,
$$
\n(94a)

$$
K_{\tau} = C_2 \frac{27}{16\pi^2} + C_3 \left(\frac{27}{16\pi^2}\right)^{3/2} \le 11.38. \tag{94b}
$$

Step 3: combine the bounds The scaled Hessian matrix $SP_kH(\theta)S^{-1}$ can be controlled over \mathcal{S}_k by the triangle inequality as follows

$$
\|SP_k H(\theta)S^{-1} - I\|_{\infty} \le \|SP_k (G(\theta) + E(\theta))S^{-1} - I\|_{\infty}
$$

\$\le \|SP_k G(\theta)S^{-1} - I\|_{\infty} + \|SP_k E(\theta)S^{-1}\|_{\infty} . \tag{95}

Finally, the inequality $|\Delta(\tau) - \Delta(\tau^*)| \leq 2 \|\tau - \tau^*\|_{\infty}$ holds for every $\tau, \tau^* \subset \mathbb{R}$. This implies, with the assumption $\|\tau-\tau^*\|_{\infty} \leq \frac{1}{4}\Delta(\tau^*)$, that $\Delta(\tau) \geq \frac{1}{2}\Delta(\tau^*)$. Substituting the bounds given in (89) and (93) yields

\|SP_k H(\theta)S^{-1} - I\|_{\infty} \n\leq \frac{1}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} - 1 \n+ \left(K_{\Delta} (1 + \|S(\theta_k - \theta^*)\|_{\infty}) + K_a \frac{\|a - a^*\|_{\infty}}{\|a^*\|_{\infty}} + K_{\tau} \sqrt{-F_N''(0)} \|\tau_k - \tau^*\|_{\infty}\right) \frac{\|a^*\|_{\infty}}{a_{\min}^*} \frac{((n+1)\Delta(\tau))^{-2}}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} \n\leq \frac{1}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} - 1 \n+ (K_{\Delta} (1 + \|S(\theta_k - \theta^*)\|_{\infty}) + (K_a + K_{\tau}) \|S(\theta_k - \theta^*)\|_{\infty}) \frac{\|a^*\|_{\infty}}{a_{\min}^*} \frac{((n+1)\Delta(\tau))^{-2}}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} \n\leq \frac{1}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} - 1 \n+ (K_{\Delta} + (K_{\Delta} + K_a + K_{\tau}) \|S(\theta_k - \theta^*)\|_{\infty}) \frac{\|a^*\|_{\infty}}{a_{\min}^*} \frac{((n+1)\Delta(\tau))^{-2}}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} \n\leq \frac{1}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} - 1 \n+ (K_{\Delta} + (K_{\Delta} + K_a + K_{\tau}) \|S(\theta_k - \theta^*)\|_{\infty}) \frac{\|a^*\|_{\infty}}{a_{\min}^*} \frac{4((n+1)\Delta(\tau^*))^{-2}}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} \n\leq \frac{1}{(1 - \|S(\theta_k - \theta^*)\|_{\infty})^2} - 1 + (4K_{\Delta} + K_{\theta} \|S(\theta_k - \theta^*)\|_{\infty}) \frac{\|a^*\|_{\infty}}{a_{\min}^*} \frac{((n+1)\Delta(\tau^*))^{-2
$$

where defined the constant K_{θ} as

$$
K_{\theta} = 4(K_{\Delta} + K_a + K_{\tau}) \le 75.80.
$$
\n(97)

 \Box

This concludes the proof of the theorem.

B.4 Proof of Lemma 6

Leveraging the block structure (33) of the matrix $\mathbf{D}(\tau)$, it boils down to controlling

\|D(\tau)-I\|_{\infty} \leq \max\left\{\|D_0(\tau)-I\|_{\infty}+\|D_1(\tau)\|_{\infty},\|D_2(\tau)-I\|_{\infty}+\|D_1(\tau)\|_{\infty}\right\},
$$
\n(98)

which can be accomplished with the aid of Lemma 5. Specifically, recalling the expressions in (34) , applying Lemma 5 with parameters α and $\beta = 0$, and noticing that the inequality $\frac{(n+1)^2}{-F_N''(0)} \le \frac{27}{16\pi^2}$ holds whenever $n \geq 2$, the quantities of interest in (98) can be controlled as follows

\|D_0(\tau) - I\|_{\infty} = \max_{i} \sum_{j \neq i} |F_N(\tau_j - \tau_i)| \leq C_0 \left((n+1)\Delta(\tau) \right)^{-2},
$$

\|D_1(\tau)\|_{\infty} = \frac{1}{\sqrt{-F_N''(0)}} \max_{i} \sum_{j} |F_N'(\tau_j - \tau_i)| \leq C_1 \frac{n+1}{\sqrt{-F_N''(0)}} \left((n+1)\Delta(\tau) \right)^{-2}
$$
\n
$$
\leq \frac{3\sqrt{3}}{4\pi} C_1 \left((n+1)\Delta(\tau) \right)^{-2},
$$
\n
$$
\|D_2(\tau) - I\|_{\infty} = \frac{1}{-F_N''(0)} \max_{i} \sum_{j \neq i} |F_N''(\tau_j - \tau_i)| \leq C_2 \frac{(n+1)^2}{-F_N''(0)} \left((n+1)\Delta(\tau) \right)^{-2}
$$
\n
$$
\leq \frac{27}{16\pi^2} C_2 \left((n+1)\Delta(\tau) \right)^{-2}.
$$
\n(99c)

Further substituting (99) into (98) leads to

$$
\|\mathbf{D}(\boldsymbol{\tau}) - \mathbf{I}\|_{\infty} \le \max \left\{ C_0 + \frac{3\sqrt{3}}{4\pi} C_1, \frac{3\sqrt{3}}{4\pi} C_1 + \frac{27}{16\pi^2} C_2 \right\} \left((n+1)\Delta(\boldsymbol{\tau}) \right)^{-2}
$$
(100)

 \Box

 \Box

which leads to the desired statement.

B.5 Proof of Lemma 7

For the first inequality, following the definition, we have that

$$
\left| \left\langle \Phi(\delta'_{\tau_j}), \Phi(\mu(\theta) - \mu(\theta_\star)) \right\rangle \right| = \left| \left\langle \delta'_{\tau_j}, \Phi^* (\Phi(\mu(\theta) - \mu(\theta_\star))) \right\rangle \right|
$$

\n
$$
= \left| \sum_{\ell=1}^r a_\ell F'_N(\tau_j - \tau_\ell) - \sum_{\ell=1}^{r^*} a_\ell^* F'_N(\tau_j - \tau_\ell^*) \right|
$$

\n
$$
= \left| \sum_{\ell=1}^r (a_\ell - a_\ell^*) F'_N(\tau_j - \tau_\ell) + \sum_{\ell=1}^r a_\ell^* (F'_N(\tau_j - \tau_\ell) - F'_N(\tau_j - \tau_\ell^*)) \right|
$$

\n
$$
\leq \left| \sum_{\ell=1}^r (a_\ell - a_\ell^*) F'_N(\tau_j - \tau_\ell) \right| + \left| \sum_{\ell=1}^r a_\ell^* (F'_N(\tau_j - \tau_\ell) - F'_N(\tau_j - \tau_\ell^*)) \right|, \quad (101)
$$

where the last line used the triangle inequality. To proceed, we control the two terms separately. Using Hölder's inequality and Lemma 5, we obtain

\left| \sum_{\ell=1}^{r} (a_{\ell} - a_{\ell}^{\star}) F_{N}^{\prime}(\tau_{j} - \tau_{\ell}) \right| \leq ||\boldsymbol{a} - \boldsymbol{a}^{\star}||_{\infty} \sum_{\ell=1}^{r} |F_{N}^{\prime}(\tau_{j} - \tau_{\ell})|
$$

$$
\leq C_{1}(n+1) ||\boldsymbol{a} - \boldsymbol{a}^{\star}||_{\infty} ((n+1)\Delta(\tau))^{-2}.
$$
 (102)

Next, the second term can be bounded by applying Hölder's inequality, the mean-value theorem and Lemma 5 with parameter $\beta \ge (n+1) ||\tau - \tau^*||_{\infty}$ as follows

$$
\left| \sum_{\ell=1}^{r} a_{\ell}^{\star} \left(F_{N}'(\tau_{j} - \tau_{\ell}) - F_{N}'(\tau_{j} - \tau_{\ell}^{\star}) \right) \right| \leq \left\| a^{\star} \right\|_{\infty} \sum_{\ell=1}^{r} \left| F_{N}'(\tau_{j} - \tau_{\ell}) - F_{N}'(\tau_{j} - \tau_{\ell}^{\star}) \right|
$$

$$
\leq \left\| a^{\star} \right\|_{\infty} \left\| \tau - \tau^{\star} \right\|_{\infty} \sum_{\ell=1}^{r} \sup_{\left\| u_{\ell} \right| \leq \left\| \tau - \tau^{\star} \right\|_{\infty}} \left| F_{N}''(\tau_{j} - \tau_{\ell} + u_{\ell}) \right|
$$

$$
\leq \left\| a^{\star} \right\|_{\infty} \left\| \tau - \tau^{\star} \right\|_{\infty} C_{2}(n+1)^{2} \left((n+1)\Delta(\tau) \right)^{-2} . \tag{103}
$$

Plugging the previous two bounds into the inequality (101) reduces to

$$
\left| \left\langle \Phi(\delta'_{\tau_j}), \Phi(\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}_\star)) \right\rangle \right|
$$

$$
\leq (C_1 \|\boldsymbol{a} - \boldsymbol{a}^\star\|_{\infty} + C_2 \|\boldsymbol{a}^\star\|_{\infty} (n+1) \|\boldsymbol{\tau} - \boldsymbol{\tau}^\star\|_{\infty} (n+1) ((n+1) \Delta(\boldsymbol{\tau}))^{-2}.
$$
 (104)

Moreover, we may show that through analogous reasoning that

$$
\left| \left\langle \Phi(\delta_{\tau_j}''), \Phi(\mu(\boldsymbol{\theta}) - \mu(\boldsymbol{\theta}_*)) \right\rangle \right|
$$

\$\leq (C_2 ||\boldsymbol{a} - \boldsymbol{a}^*||_{\infty} + C_3 ||\boldsymbol{a}^*||_{\infty} (n+1) ||\boldsymbol{\tau} - \boldsymbol{\tau}^*||_{\infty} (n+1)^2 ((n+1)\Delta(\boldsymbol{\tau}))^{-2}, (105)\$

which concludes the proof.
