Effect of an electric field on ferroelectric and piezoelectric properties of the brownmillerite $Ca_2Al_2O_5$

Brownmillerites $A_2B_2O_5$ are oxides possessing a crystallographic structure that is parent from the perovskite structure ABO₃ with an ordered sublattice of oxygen vacancies, forming a network of 1D chiral chains of oxygen tetrahedra carrying electric dipoles. The distribution of left-and right-handed chains enables the formation of different, polar or non-polar crystallographic phases with close internal energies. We have performed first-principles calculations on the non-magnetic Ca₂Al₂O₅ oxide, chosen as a case study, in order to study the effect of an external electric field, applied in the direction parallel to the chains, on the stability of four different crystallographic phases. We found that reversing the direction of the electric polarization in the *Ima2* phase necessitates going through different intermediate phases. However, we also showed that, even if the application of the electric field allows to change the relative stability of each phase, it cannot be sufficient to change one chain handedness at low temperature, owing to the high barrier energies, of the order of ~ 1 eV per chain of two tetrahedra, which has to be overpassed. Switching between different phases would thus require applying an electric field at high temperature or with the application of additional stress. Finally, we demonstrated that polar phases, such as *Ima2* or *Pmc2*₁, display negative longitudinal piezoelectric coefficients due to the lattice response to the applied electric field.

I. INTRODUCTION

Brownmillerite oxides of chemical formula A₂B₂O₅ 10 (or, equivalently, $ABO_{2.5}$) possess a structure similar 11 to the structure of perovskite oxides (of chemical for-12 mula ABO_3) in which oxygen vacancies are ordered and 13 form 1D channels, all aligned along a specific crystallo-14 graphic direction. These oxides have already shown a 15 wide range of properties because of the numerous com-16 binations of A and B cations which can be used to new 17 compounds [1, 2] with different lattice distortions, oxi-18 dation states and magnetic ordering, providing a large 19 range of functional properties. Hence, this family of ox-20 21 ides could help to enrich the list of multifunctional materials. Multiferroicity has, for example, been evidenced 22 in materials such as $SrFeO_{2.5}$ [3] and studied theoreti-23 cally in $Ca_2(Fe,Al)O_5$ [4]. Brownmillerites are nowadays 24 increasingly studied and could be as promising as their 25 perovskite parents for future applications. 26

The particular tunabilities of brownmillerite properties 27 is generally explained by the configurations of the chains 28 of oxygen tetrahedra (T chains) formed because of the 29 oxygen-vacancy channels. Similarly to the octahedra tilts 30 observed in perovskite oxides, the oxygen tetrahedra can 31 32 display tilts which make the associated chains to be chi-33 ral. Different control parameters and stimuli (chemical composition, temperature, strain, applied electric field) 34 can be used to tune the atomic structure by changing 35 the tetrahedra-tilts pattern [4, 5], the T-chain crystallo-36 ³⁷ graphic orientations [6–8] or the oxygen content through

³⁸ topotactic phase transitions (ABO_{2.5} brownmillerites be-³⁹ ing an intermediate structure between ABO₃ perovskites ⁴⁰ and ABO₂ structures with infinite square lattices) [7, 9– ⁴¹ 13], all of this resulting in modifications of electronic, ⁴² optical and magnetic properties. Topotactic transitions ⁴³ through brownmillerite structures is in particular promis-⁴⁴ ing for memristive devices and neuromorphism comput-⁴⁵ ing [7, 8, 13–15], as the anisotropic mobility of oxygen ⁴⁶ atoms is facilitated along the oxygen-vacancy channel, ⁴⁷ which moreover reduces the variability of the switching ⁴⁸ mechanisms [15].

If several research efforts have been dedicated to the 10 ⁵⁰ study of topotactic transitions, the ordering of oxygen-51 tetrahedra tilts between different T chains remains an 52 important characteristics of brownmillerites, as it is inti-⁵³ mately linked to the possible emergence of a ferroelectric ⁵⁴ polarization in these oxides [3–5, 16]. Brownmillerites ⁵⁵ indeed display a non-conventional ferroelectricity, which ⁵⁶ comes from cation-oxygen displacements resulting from 57 these oxygen-tetrahedra tilts. The collective tilts in each 58 T chain result in left- or right-handed chiralities (noted $_{59}$ "-" and "+" in the following) and are responsible of the 60 emergence of electric dipoles along the [010] direction, ⁶¹ the signs of which are defined by the chiral orientation of 62 the T chains. The distribution of the orientations of the 63 different chains will determine the value of the macro-⁶⁴ scopic electric polarization [16]. Finally, confirming the ⁶⁵ complexity of this system, Tian et al. [17] demonstrated ⁶⁶ that the ferroelectric state in the $Pmc2_1$ ground state of $_{67}$ Sr₂Co₂O₅ originates from a novel coupling between dif-68 ferent phonon modes, which differs from those character-⁶⁹ istic of the proper, improper [18], hybrid improper [19-70 22] or triggered [23, 24] type of ferroelectricity.

From a serie of mea-73 surements on $La_{1-x}A_xMnO_{2.5}$ (with A = Ba, Sr, Ca), 74 Parsons et al. [16] showed that the chain handedness or-75 dering can be tuned by changing the chemical composi-76 tion of A cation *via* two effects. Firstly, by changing the 77 interlayer distances between two (001) T atomic layers. 78 Secondly, by modifying the distortions on the T chains. 79 which is a result of the change of Mn oxidation degrees in 80 ctahedral sites. Different structures can thus be gener-81 ated as a function of the tilts patterns. The Ima2 struc-82 ture, which corresponds to the case with all T chains 83 having the same handedness, can be stable when the net 84 electric dipole is small. When electric dipole is too large, 85 a centrosymmetric structure will form to compensate it: 86 87 the structure will then possess an intralayer antiferroelectric ordering (Pbcm) if the separation distance between 88 two adjacent T layers is large, while it will favor an in-89 terlayer antiferroelectric ordering otherwise, as such or-90 dering does not involve a strong distortion of the oxygen 91 octahedra [16, 25, 26]. In this latter case a Pnma struc-92 ture will form, with all tetrahedra T chains in T and 93 T' layers having chains with opposite chiralities. More 94 generally, explanations of the structural ground states 95 have been given through the use of several structural de-96 scriptors characterizing the distortions in terms of chem-97 ical bond-angles and lengths changes [5, 16]. For certain 98 brownmillerites, or when the temperature is increased, 99 the chain orientations can be disordered, leading to an 100 Imma structure and (3+1)D Imma $(00\gamma)s00$ superspace 101 groups have even been often characterized to describe the 102 formation of incommensurate orderings [27–29]. In addi-103 104 tion to the choice of chemical composition, it has been 105 found that the physical control of phases in brownmillerites is strongly dependent on the strain [5]. 106

Applying an external electric field would be another 107 way to modify the brownmillerite structure and proper-108 ties. Experimentally, it has been shown that it could help 109 to modify the T-chain crystallographic orientation [7] or 110 to activate the oxygen conduction [7, 8, 15]. To our 111 knowledge, no study has been reported on the effect of 112 an electric field on the oxygen-tetrahedra tilts and of 113 the T-chain handedness pattern, despite the fact that, as 114 demonstrated in the case of perovskites [30], this would 115 be important to understand the modification of ferroelec-116 tric properties, in view of integrating such materials in 117 electronic devices. 118

II. DETAILS ON THE CALCULATION METHODS AND ON THE BROWNMILLERITE STRUCTURE

We performed first-principles calculations based on ¹³⁵ the density functional theory (DFT) [31, 32], using the ¹³⁶ VASP software [33, 34]. We employed the projector aug-¹³⁷ mented wave method (PAW) [35] with a cutoff energy ¹³⁸ of 550 eV. The exchange-correlation functional was ex-¹³⁹ pressed within the generalized-gradient approximation ¹⁴⁰ parametrized by Perdew, Burke and Ernzerhof and re-¹⁴¹ vised for solids (GGA-PBESol) [36]. The first Brillouin ¹⁴² zone was sampled using a Monkhorst-Pack grid [37] with dimensions $4 \times 6 \times 2$. 143

The external electric field is applied using the method ¹⁴⁵ proposed in Ref. [30]. The stability of the atomic struc-¹⁴⁶ ture is then governed by the energy F, which is, at a tem-¹⁴⁷ perature of 0 K, equal to the Kohn-Sham internal energy ¹⁴⁸ U plus an additional electric-field (\mathcal{E}) dependent contri-¹⁴⁹ bution, such that $F = U - \mathbf{P} \cdot \boldsymbol{\mathcal{E}}$. The electric polarization $_{150}$ P has been calculated using the Born effective charges ¹⁵¹ Z^* (calculated for the centrosymmetric Imma phase and ¹⁵² given in Appendix A); this method is also convenient as ¹⁵³ it allows to perform a projection in a given volume [illus- $_{154}$ trated by the black dotted lines in Fig. 1(a)] to separate 155 each T-chain contribution. For some polar bulk struc-¹⁵⁶ tures, we also calculated the total electric polarization ¹⁵⁷ using the Berry-phase method and found a fairly good ¹⁵⁸ agreement between the results obtained with both methods. To optimize the atomic structures, we calculated the 159 ¹⁶⁰ total forces applied on each atom, which are now the sum ¹⁶¹ of the standard Hellmann-Feynman forces plus a prod-¹⁶² uct between its Born effective charge Z^* and the electric ¹⁶³ field \mathcal{E} . To calculate the barrier energy to switch between ¹⁶⁴ two structural states, we used the climbing-image nudged ¹⁶⁵ elastic band method (CI-NEB) implemented within the ¹⁶⁶ VTST package [38].

III. RESULTS

Properties of bulk Ca₂Al₂O₅ brownmillerite 198

We chose to focus our study on the Ca₂Al₂O₅ brown-199 200 millerite [29, 39, 40]. This oxide has not been extensively studied but it possesses the advantages to contain only one type of cation A and one type of cation B with both being non-magnetic. It is derived from the native 203 $Ca_2(Fe_{1-x}Al_x)_2O_5$ brownmillerite, which has been found 205 to naturally exist and which can be grown at ambient 206 pressures for compositions x ranging from x = 0 to x = $_{207}$ 0.7 [41, 42]. Al-rich phases of Ca₂(Fe_{1-x}Al_x)₂O₅ gener-²⁰⁸ ally adopt a Ima2 (or I2mb) space group [29, 40], while 209 iron-rich phases (below x = 0.235) have been reported ²¹⁰ with a *Pnma* structure [28, 43]. Both for Al-rich or Fe-²¹¹ rich phases, a transition to an incommensurate struc-²¹² ture, with a superspace group $(3+1)D Imma(00\gamma)s00$, ²¹³ has been evidenced at high temperature [28, 29]. The 214 experimental synthesis of Ca₂Al₂O₅ (that is for x = 1) 215 requires high pressure and high temperature, and it is ²¹⁶ then possible to quench the material at room tempera-²¹⁷ ture (see Ref. [29] and references therein) in order that ²¹⁸ the system stays in the brownmillerite structure.

a. Stability of the different crystallographic phases: 219 ²²⁰ Ca₂Al₂O₅ can exist under different crystallographic ²²¹ phases, which differ one from another by their pattern of ²²² chain handedness. With our considered supercells, these $_{223}$ pattern of chain handedness will be noted (12|34), where 224 1-4 are the chain numbers given in Fig. 1. The right- or ²²⁵ left-handed enantiomorphic chains will be noted + and ₂₂₆ -, respectively, and 0 will correspond to an average state, ²²⁷ when the tetrahedra display no rotation.

228 The aristotype *Imma* space group (No 74) corresponds ²²⁹ to the brownmillerite structure (12|34) = (00|00) with ²³⁰ no tetrahedra tilts. Using the supercell described in the ²³¹ previous section, it is then possible to generate four het-²³² totype structures, as shown in Fig. 1(c). Table I summarizes the main properties of each of these structures.

The Ima2 structure (No 46) is non-centrosymmetric 234 235 and possesses only T chains with one specific handedness $_{236}$ ("-" or "+") defined from the tetrahedra-tilts direction. 237 This structure thus displays a spontaneous electric po- $_{238}$ larization that we calculated to be $P_{\rm tot}^0=3.8~\mu{\rm C~cm^{-2}}$ 239 by using Born effective charges; a slightly lower value of shifted one to each other along the $[1\overline{10}]_p$ (or [100]) di- $_{240}$ 3.6 µC cm⁻² was obtained using the Berry-phase method. with a, b and c being respectively along the $[1\overline{1}0]_p$, $[110]_p^2$ ²⁴⁷ from the Ima2 polar structure, it is also possible to $_{252}$ tion of 1.9 µC cm⁻² (1.2 µC cm⁻² with the Berry-phase

From Table I, we can see that the calculated lattice 262 parameters are in fairly good agreement with reported 263 experimental parameters, with a calculated pseudocu-264 bic lattice parameter for the Ima2 phase only 0.23%265 lower than the experimental value [40]. From our cal-266 culations, we can also see that the variation of lattice 267 parameters between the different crystallographic phases 268 is quite small for the four more stable phases (-0.01%) in 269 average between the Pbcm and Ima2 phases), while it is 270 more important if we consider the Imma phase (-0.19%)271 with the *Pbcm* phase). The larger lattice distortion sep-272 arating the *Imma* phase from the four other structures 273 ²⁷⁴ is in agreement with the calculated high internal energy. The in-plane distance separating two T chains only de-275 creases by 0.26 pm when changing from the *Ima2* to the 276 *Pbcm* phase, while the out-of-plane distance increases 277 by 0.52 pm when switching from the Ima2 to the Pnma 278 phase. For the four structures, Ima2, $Pmc2_1$, Pnma and 279 *Pbcm*, the averaged absolute value of the tetrahedra-tilt 280 281 angles $\langle |\theta y_{\rm T}| \rangle$ does not strongly vary and remains in the ²⁸² range of 25.61-25.73°. Depending on the handedness of the T chain, the Al cations and anions are all displaced 283 $_{284}$ in the same direction along the y axis. For example, in the case of the Ima2 structure, we found that the Al 285 atoms are, in average, displaced from their centrosym-286 ₂₈₇ metric positions by $\delta y(\text{Al}) = -18.4 \text{ pm}$, and the oxygen atoms by $\delta y(O) = -64.5$ pm, so that the cation-oxygen ²⁸⁹ buckling is of $\Delta y_{\rm T}(Ima2) = \delta y({\rm Al}) - \delta y({\rm O}) = 46.1 \text{ pm}.$ ²⁹⁰ The spontaneous electric polarization is really depen-³⁰³ ²⁹¹ dent on the distortions located in the T and T' layers; ³⁰⁴ phases: The NEB method was used to calculate the en-

 $_{306}$ electric polarization in the case where the Ima2 phase is $\Delta E_{\rm b}(\alpha \rightarrow \beta)$ is defined as the energy difference between the maximum of the energy calculated 308 along a reaction path between two states α and β and 309 the energy of the initial state α . 310

A homogeneous switching, corresponding to a direct 311 $46 \rightarrow 46$ transition, would require to rotate simultane-312 ously all T chains and the maximum of the energy bar-313 rier would be reached when all tetrahedra tilts $\theta_{\rm T} = 0^{\circ}$, 314 *i.e.*, when the structure takes the *Imma* space group. In 315 that case, as displayed in Fig. 2, the total energy bar-316 317 rier for the whole heterostructure is thus expected to be $\Delta E_{\rm b}(46 \rightarrow 46) = 3.78 \text{ eV}$, or 0.95 eV per chain of two ³¹⁹ tetrahedra. Such energy barrier is high if we compare it 320 to common ferroelectric materials for which the energy ³²¹ required to switch the electric polarization is in the order of tens of meV [44]. On the other hand, our calculated 322 value is closer to the energy barriers reported for geo-323 metric ferroelectrics [21], in which the ferroelectricity is 324 driven by rotations and it is approximately three times 325 higher than the value calculated for the Brownmillerite 326 $Sr_2Fe_2O_5$ [3]. The high energy necessary to change the 327 T-chain handedness may be easily understood from ge-328 ometry considerations, taking into account that a T chain 329 is formed by a succession of oxygen tetrahedra turning alternatively in clockwise and anticlockwise directions and 331 ³³² changing the chain handedness would require to reverse 333 simultaneously the angles of all tetrahedra. It is important to note that these calculated energy barriers are of 334 the same order of magnitude than those calculated for 335 the migration of oxygen atoms between different atomic 336 sites [15, 45]. 337

Up-to-now, we considered that the polarization rever-338 sal was performed by homogeneously switching all chains 339 at the same time. It is however reasonable to assume that 340 the polarization switching would rather occur by chang-341 ing the handedness of the T-chains one after another, 342 eventually through the motions of domain walls [44, 46]. 343 Locally, such process could allow to generate different in-344 termediate states corresponding to phases like those dis-345 cussed before. ³⁶⁴ structural distortions are however relatively low and, in ³⁶⁵ a first approximation, we can consider that each chain ³⁶⁶ behaves almost independently: as discussed before and ³⁶⁷ displayed in Fig. 3(b), each chain-state reversal increases 368 approximately the total electric polarization by, in av- $_{369}$ erage, $P_{\alpha} \simeq 0.94 \ \mu C \ cm^{-2}$. In the ⁴¹² presence of a parallel external electric field with a mag-⁴¹³ nitude greater than $\mathcal{E} = +4.6 \times 10^6 \text{ V m}^{-1}$, this polar 414 phase becomes more stable, and the intermediate (and $_{415}$ also polar) $Pmc2_1$ phase the second most stable from $_{416} \mathcal{E} = +7.2 \times 10^7 \text{ V m}^{-1}$. On the contrary, it can be seen 417 that, if the electric field is applied antiparallel, the two ⁴¹⁸ non-polar phases not only remain the more stable states, ⁴¹⁹ but their energy difference with respect to the energies of the polar phases increases with the magnitude of \mathcal{E} . 420

Comparing the two non-polar phases, we can see in 421 ⁴²² Fig. 4(a) that the two curves representing the variation of ⁴²³ their free energy are almost superimposed, which shows that their energy difference remains low - in comparison 424 with the energy difference with other phases, even at high 425 electric-field values. In Fig. 4(b), we can indeed see that the Pbcm and Pnma phases. Because higher 444 electric fields can be experimentally applied in thin films, we calculated the barrier energies for higher magnitudes 445 of \mathcal{E} : The energy barriers to switch the electric dipoles on 446 one T chain become more homogeneous as we increase \mathcal{E} , 447 but they remain very high, of around 1.092 eV when the 448 $_{449}$ electric field is of $+5 \times 10^8$ V m⁻¹ and that the global electric polarization is still antiparallel to it, and 1.114 eV, 450 when the electric field and the electric polarization are 451 452 parallel.

According to our calculations, it appears that, even 453 by applying a large electric field, it should be difficult 454 to switch between different crystallographic phases, at 455 least at a temperature of 0 K. It is indeed interesting 456 that Kang, et al. [3], demonstrated the possibility to re-457 verse the electric polarization at room temperature in 458 a thin film of $Sr_2Fe_2O_5$ in its *Ima2* ferroelectric phase; they estimated that the electric coercive field was about 460 1.5×10^8 V m⁻¹. The ability to reverse the electric po-461 larization with such an electric field might highlight the 462 importance of domain-wall motion in the polarization-463 switching mechanism of brownmillerites. 464

Finally, we can also address the idea that, if the sys-465 tem is initially in a non-polar state, it could be possible 466 to stabilize the polar phase Ima2 by heating the sample 467 and by applying the electric field at a sufficiently high 468 temperature; if we then slowly cool down the system in 469 order to keep it in equilibrium in the polar *Ima2* phase, 470 we can expect to preserve this state down to room tem-471 perature. This state should then be locked, even after 472 removing the electric field. 473

b. Evolution of the electric polarization: From the 474 NEB calculations described previously, we saw that the 475 energy cost to reverse the T-chain handednesses, which are linked to the spontaneous electric polarization $P_{\rm tot}^0$ at 477 zero electric field, is very high. The electric field applied 478 in our calculations will nonetheless modify the atomic 480 structure and induce an additional contribution to the ⁴⁸¹ electric polarization. As displayed in Figs. 6(a,b), the 482 total electric polarization is increasing quasi-linearly, as ⁴⁸³ a function of the electric field, between $\mathcal{E} = -10^9$ and ⁴⁸⁴ $+10^9$ V m⁻¹, with a slope of 11.24×10^{-11} F m⁻¹ and $_{485}$ 11.04 \times 10⁻¹¹ F m⁻¹, for the polar *Ima2* and non-polar 486 Pbcm phase, respectively. According to the discussion above, we succeeded to 533 understand why the polar or non-polar phases could be 534 more stable according to the direction of the applied elec-535 tric field. From the Eq. 1, if we consider that χ_i does not 536 strongly vary for the different crystallographic phases, 537 we should conclude that the difference of free energy be-538 tween the different phases should vary linearly or remain 539 constant if the two phases have initially the same electric 540 polarization, which is not the case according to Fig. 4. 541 Of course, we already saw that, at high electric field, the 542 variation of the total electric polarization is not fully lin-543 ear anymore. In order to have a better insight in the 544 mechanisms that govern the change of electric polariza-545 tion, we can decompose the total electric polarization in 546 chain contributions P_{α} , as already done in Fig. 3(b). It 547 548 is then possible to see in Figs. 6(a,b) that each P_{α} follows the same trend than P_{tot} . To improve the analy- $_{550}$ sis, we also chose to show in Figs. 6(c,d) the atomic displacements and the corresponding cation-anion bucklings 551 $\Delta y_{\rm T}$, and in Figs. 6(e,f) the variation of the tetrahedra-552 tilt angles $|\theta_{\rm T}|$ as a function of \mathcal{E} . 553

Let us first consider the Ima2 structure for simplicity. We can see that the cation-anion buckling along the 555 [001] direction, $\langle \Delta y_{\rm T} \rangle$, decreases by approximately 12 pm 556 for each chain, when the electric field is antiparallel to the initial electric polarization and decreases from 0 to 558 -4×10^9 V m⁻¹. We observe on the contrary a smaller increase by 7 pm, when the electric field is increased to $+4 \times 10^9$ V m⁻¹. This variation of buckling is mostly 561 governed by the displacement of oxygen atoms. > Contrary to the Ima2 phase, for which all the T chains ⁵⁸⁹ are equivalent, the *Pbcm* phase displays two sets of chains $_{590}$ [Fig. 6(a)], one with the local spontaneous polarization ⁵⁹¹ P^0_{α} parallel and the other one antiparallel to the electric ⁵⁹² field, whatever its direction is. As it was noticed before, the behavior of each chain can be considered, at first, 593 ⁵⁹⁴ as independent. Their local polarizations present simi- $_{595}$ lar slopes than the chains in the Ima2 phase. We also ⁵⁹⁶ observe the same trends for cation-anion bucklings and 597 tetrahedra tilts, with mirror variations for the two sets 598 of chains, due to the direction of their chain spontaneous ⁵⁹⁹ polarization with respect to the electric field. If we an-600 alyze in more details the variations of P_{α} in the *Pbcm* ⁶⁰¹ phase, we can see that the slopes displayed by the two ⁶⁰² sets of chain is not exactly equal. We calculated that ⁶⁰³ the polarization difference between two chains with op-⁶⁰⁴ posite handedness, $P_1 - P_2$ for example, increases from ⁶⁰⁵ 1.7 µC cm⁻² to 3.4 µC cm⁻², when the electric field is ⁶⁰⁶ increased between 0 and 4×10^9 V m⁻¹, It is certainly 607 partly due to the asymmetric variation of the tilt angles 608 $\langle |\theta_{\rm T}| \rangle$.

⁶²⁸ is the direction of the electric field. The calculated large $_{629}$ increase of the *b* lattice parameter is consistent with the $_{630}$ increase of the electric polarization $P_{\rm tot}$ induced by the ⁶³¹ applied electric field. The elongation of in-plane lattice 632 parameters is accompanied by a contraction of the out- $_{633}$ of-plane lattice parameter c. The calculated coefficients thus reflect the anisotropic electrostrictive behavior (see 634 Table II). In the previous subsection, we saw that the in-635 duced change of electric polarization could help to understand the (de)stabilization of polar phases over non-polar 637 638 phases. Concerning the relative stability of the two non- $_{639}$ polar phases *Pbcm* and *Pnma*, we also saw that their free energies remain very close, but that, from an electric field 640 value of $\mathcal{E} = \pm 1.9 \times 10^9 \text{ V m}^{-1}$, the *Pnma* phase becomes 641 $_{642}$ more stable than the *Pbcm* one. The calculated changes ⁶⁴³ of lattice parameters could also explain this change of ⁶⁴⁴ relative stability. Indeed, the *Pnma* phase could become ₆₄₅ more stable than the *Pbcm* structure because, when $|\mathcal{E}|$ $_{646}$ increases, the decrease of c induces a consecutive increase ⁶⁴⁷ of the interlaver chain interaction (which imposes an an-648 tiferroelectric ordering [16, 25, 26]), while the increase $_{649}$ of the in-plane lattice parameter a, on the contrary, de-⁶⁵⁰ creases the intralayer chain interaction.

When polar phases are stabilized [see Fig. 7b for the 651 ⁶⁵² Ima2 structure], on the contrary to the Pbcm structure, the electric field will have a different effect depending if it is applied parallel (positive values) or antiparallel 654 (negative) to the electric polarization at zero field P_{tot}^0 . 655 656 tice parameters follows the same trend than for the *Pbcm* ⁷¹⁵ $d_{23} = 4.58 \text{ pm V}^{-1}$, which are close from the ionic terms ⁶⁵⁸ phase, while, when it is parallel, we observe an increase $_{659}$ of the out-of-plane lattice parameter c and a decrease of ₆₆₀ b, as the magnitude of \mathcal{E} increases up to $1-2 \times 10^9$ V m⁻¹. ⁶⁶¹ From Fig. 7b, it is also possible to see that the variation ⁷¹⁷ 662 of the c parameter as a function of \mathcal{E} , when \mathcal{E} is low, $_{663}$ is more linear than for the *Pbcm* phase. Piezoelectric materials with negative longitudinal co-671 672 efficients are relatively rare but have been reported in ⁶⁷³ wurtzite BN [51], orthorhombic hafnia HfO₂ [52], ABC 674 hexagonal ferroelectrics [53] or also in layered ferro- $_{675}$ electrics like CuInP₂S₆ [54]. The piezoelectric coeffi-676 cient can be decomposed into the sum of two terms, the 677 clamped-ion term, which is the component calculated for 678 the equilibrium structure, i.e. at zero strain, and the internal-strain term [53, 55]. Negative piezoelectric co-680 efficients have been found when the clamped-ion term is negative and dominate over the second term [53, 54], 681 generally because this last one is small due to low Born effective charges or to small responses associated 683 to the atomic positions, which can be the case in lowdimensional crystals [54]. On the contrary, in HfO_2 , the lattice-mediated response has been found to dominate 686 and to be at the origin of the negative coefficient. For $Ca_2Al_2O_5$, we calculated that the longitudinal coefficient 688 $_{689}$ coming from the ionic response d_y is negative. This ionic ⁶⁹⁰ term depends on the calculated Born effective charges, ⁶⁹¹ given in Appendix A, which are not particularly small, with diagonal terms close to $\sim \pm 2e$, and on the varia-692 ⁶⁹³ tion of structural distorsions, which on the contrary, can ⁶⁹⁴ be small if the electric field is parallel to the sponta-⁶⁹⁵ neous polarization (Fig. 6d,f). We then decided to per-696 form a direct calculation of the piezoelectric stress coef-⁶⁹⁷ ficient, firstly in order to confirm this coefficient, which ⁶⁹⁸ has been calculated by fitting the variation of strain over 699 a wide range of electric field \mathcal{E} , and secondly to verify ⁷⁰⁰ if the total piezoelectric coefficient, including the purely 701 electronic contribution, is also negative or not. Such method could provide an additional 762 way to ensure the stabilization of polar phases in brown-763 millerite structures, in addition to the control of other 764 parameters such as epitaxial strain. 765

We finally discussed the variation of strain as a func-766 tion of the external electric field applied along the T chain 767 directions. We found that, due to the electrostrictive behavior, which will change the interlayer distances, or 769 in other words the lattice coupling between the differ-770 ent chains, the electric field could help to stabilize dif-771 ferent non-polar phases. When a polar phase is stabi-772 lized, we predict that, because of its low lattice response, 773 774 Ca₂Al₂O₅ possesses a negative longitudinal piezoelectric 775 coefficient in the direction parallel to the field.

We chose to focus our study on the non-magnetic 776 Ca₂Al₂O₅ brownmillerite.
